A RESOLUTION

- Designating June 15, 2021, as "Court Appointed Special Advocates Day" in Pennsylvania.
- 3 WHEREAS, The Pennsylvania Court Appointed Special Advocates
- 4 (CASA) is a network of 22 local programs covering 28 counties in
- 5 this Commonwealth, which are developed to provide volunteer
- 6 advocacy for abused and neglected children in dependency court
- 7 proceedings; and
- 8 WHEREAS, Pennsylvania CASA has 1,185 active volunteers who
- 9 advocated for 2,121 abused and neglected children throughout
- 10 this Commonwealth in 2020 and donated thousands of hours of
- 11 their time; and
- 12 WHEREAS, Pennsylvania CASA volunteers help to protect the
- 13 safety and welfare of this Commonwealth's most vulnerable
- 14 children and help to ensure that children's needs are being met
- 15 while in the dependency system and that the children obtain safe
- 16 and permanent housing as quickly as possible; and
- 17 WHEREAS, Pennsylvania CASA volunteers are deeply committed,

- 1 specially trained advocates who work within the child welfare
- 2 system and are appointed by dependency court judges to provide
- 3 individualized attention and bring urgency to a child's needs
- 4 throughout his or her time in between case managers, foster
- 5 parents, service providers, attorneys and other stakeholders;
- 6 and
- 7 WHEREAS, Pennsylvania CASA maximizes community resources and
- 8 support for children and families within the child welfare
- 9 system through increased community involvement and awareness,
- 10 local and State advocacy efforts and a more coordinated and
- 11 compassionate response to child victims and families in crisis;
- 12 and
- 13 WHEREAS, The Commonwealth recognizes Pennsylvania CASA
- 14 volunteers for selflessly giving their time and talents to
- 15 advocate for the best interests of children in court and
- 16 recognizes the volunteer board members and staff of the
- 17 Pennsylvania CASA programs for their contributions on behalf of
- 18 children of this Commonwealth; therefore be it
- 19 RESOLVED, That the Senate designate June 15, 2021, as "Court
- 20 Appointed Special Advocates Day" in Pennsylvania.
