A RESOLUTION

- Designating the month of April 2022 as "Sexual Assault Awareness Month" in Pennsylvania.
- 3 WHEREAS, April is nationally recognized as Sexual Assault
- 4 Awareness Month to call attention to the fact that sexual
- 5 violence is widespread and impacts every community; and
- 6 WHEREAS, April 2022 marks the 21st anniversary of the
- 7 designation of "Sexual Assault Awareness Month"; and
- 8 WHEREAS, Rape, sexual assault and sexual harassment have a
- 9 deep physical and emotional trauma on those who have experienced
- 10 it; and
- 11 WHEREAS, The frequency of rape in the United States occurs
- 12 with more prevalence than the public realizes, as one in five
- 13 women and one in sixty-seven men have been raped in the United
- 14 States; and
- 15 WHEREAS, On postsecondary campuses, one in five women and one
- 16 in sixteen men are sexually assaulted at some point in their
- 17 educational career; and

- 1 WHEREAS, Young people experience heightened rates of child
- 2 sexual abuse as one in six boys and one in four girls experience
- 3 sexual assault before the age of eighteen; and
- 4 WHEREAS, Lesbian and bisexual women may be up to three times
- 5 as likely as heterosexual women to report having been sexually
- 6 assaulted during their lifetime; and
- 7 WHEREAS, Gay men may be up to 15 times as likely as
- 8 heterosexual men to report having been sexually assaulted during
- 9 their lifetime; and
- 10 WHEREAS, More than 90% of individuals with a developmental
- 11 delay or disability will be sexually assaulted at least once in
- 12 their lifetime; and
- 13 WHEREAS, Twenty-seven percent of all sexual assault
- 14 victimizations for adults and children end in arrest; and
- 15 WHEREAS, Communities can support survivors by believing their
- 16 story, showing respect and championing their individual support
- 17 networks; and
- 18 WHEREAS, Individuals speaking out against inappropriate
- 19 jokes, offensive gestures, harmful attitudes and unwanted
- 20 actions make a positive impact toward ending sexual harassment,
- 21 abuse and assault; and
- 22 WHEREAS, Consent and boundaries can be violated online in a
- 23 number of ways; and
- 24 WHEREAS, Communities can work together to make their
- 25 communities safer by providing prevention education and
- 26 increasing public awareness to avoid future harm from sexual
- 27 violence; therefore be it
- 28 RESOLVED, That the Senate designate the month of April 2022
- 29 as "Sexual Assault Awareness Month" in Pennsylvania; and be it
- 30 further

- 2 "Sexual Assault Awareness Month" to empower more survivors and
- 3 their loved ones on their journey to help, hope and heal; and be
- 4 it further
- 5 RESOLVED, That the Senate encourage communities to understand
- 6 their role in ending sexual violence in Pennsylvania and the
- 7 United States; and be it further
- 8 RESOLVED, That the Senate encourage communities to commit to
- 9 make a difference to ensure that online platforms are safe and
- 10 respectful for everyone by practicing consent, keeping kids safe
- 11 and supporting survivors.
