## AN ACT

Amending the act of April 28, 1937 (P.L.417, No.105), entitled "An act relating to milk and the products thereof; creating a Milk Marketing Board; establishing its jurisdiction, powers 3 and duties; regulating the production, transportation, manufacturing, processing, storage, distribution, delivery 5 and sale of milk and certain products thereof; providing for 6 the licensing of milk dealers and the payment of fees therefor; requiring milk dealers to file bonds to secure 8 payment for milk to producers and certain milk dealers; 9 authorizing the holding of hearings and the issuance of 10 subpoenas by the board; conferring jurisdiction upon courts to punish contempts and to prohibit violations of this act 11 12 and of rules, regulations and orders of the board; 13 authorizing the board to adopt rules, regulations and orders, 14 15 and to enter into interstate and Federal compacts; requiring persons who weigh, measure, sample or test milk to procure 16 permits or certificates, to take examinations, to pay fees 17 therefor, to furnish certain notices, records and statements, 18 and to use certain methods of weighing, measuring, sampling 19 20 and testing; authorizing the board to examine the business, papers and premises of milk dealers and producers, requiring 21 the keeping of records and the filing of reports by milk 22 23 dealers, and permitting, with limitations, the use of information obtained thereby; authorizing the board to fix 24 prices for milk and certain milk products subject to the 25 approval of the Governor, and conferring certain powers upon the Governor with respect thereto; providing for appeals to 26 27 the courts from decisions of the board, and for the burden of 28 29 proof upon such appeals; prescribing penalties, fines and 30 imprisonment for violations of this act and rules, 31 regulations and orders of the board; defining perjury; defining remedies; repealing legislation supplied and 32 superseded by this act, and saving rights, duties and 33 proceedings thereunder; and making appropriations," IN 34

- 1 LICENSES OF MILK DEALERS, FURTHER PROVIDING FOR PENALTIES IN
- 2 LIEU OF SUSPENSION; AND, in weighing and testing, further
- providing for certified testers and for certified weighers
- 4 and samplers.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Sections 404.1, 602 and 603 of the act of April <--
- 8 28, 1937 (P.L.417, No.105), known as the Milk Marketing Law, are
- 9 amended to read:
- 10 SECTION 404.1. PENALTIES IN LIEU OF SUSPENSION.--IN ANY CASE <--
- 11 WHERE THE BOARD SHALL SUSPEND A LICENSE, THE BOARD MAY ACCEPT
- 12 FROM THE LICENSEE AN OFFER IN COMPROMISE AT THE RATE OF [ONE
- 13 HUNDRED FIFTY DOLLARS (\$150)] ONE THOUSAND DOLLARS (\$1,000) FOR
- 14 EACH DAY OF SUSPENSION AS A PENALTY IN LIEU OF SUCH SUSPENSION,
- 15 AND THEREUPON RESCIND THE SUSPENSION.
- 16 Section 602. Certified Testers. -- It shall be unlawful for
- 17 any milk dealer to buy or receive milk from producers, or to
- 18 sell or deliver milk to stores or consumers, on the basis of, or
- 19 with reference to, the amount of butterfat or appropriate milk
- 20 components contained in such milk, unless the butterfat or
- 21 component tests thereof is conducted by a tester certified by
- 22 the board.
- 23 The certified tester shall keep an accurate record of all
- 24 tests made, and copies of such record shall be kept for a period
- 25 of two (2) years by him and by the milk dealer.
- 26 Any person who, upon the effective date of this act, is the
- 27 holder of a certificate of proficiency for milk testing issued
- 28 after examination conducted by the Pennsylvania Department of
- 29 Agriculture, shall, upon application to the board, on a form
- 30 prescribed by the board, furnishing information including that
- 31 pertaining to good character and to the apparatus and methods
- 32 used in testing, be issued a certificate and be designated

- 1 therein as a certified tester.
- 2 Any person who is not the holder of such certificate of
- 3 proficiency upon the effective date of this act, shall, prior to
- 4 applying for a tester's certificate, apply to the board for a
- 5 certificate of proficiency. Such application shall be
- 6 accompanied by a fee [of five dollars (\$5.00).] established
- 7 under section 7 of the act of July 1, 1978 (P.L.730, No.132),
- 8 known as the "Milk Marketing Fee Act." The applicant shall be
- 9 required to pass an examination in milk testing, reasonably
- 10 prescribed and conducted by the board, and upon approval of the
- 11 application shall be issued a certificate of proficiency.
- 12 Thereupon, and [annually] thereafter without such examination,
- 13 the person so certified may apply for a tester's certificate as
- 14 herein prescribed.
- 15 The application for a tester's certificate, accompanied by a
- 16 fee [of five dollars (\$5.00),] established under section 7 of
- 17 the "Milk Marketing Fee Act," shall be filed, upon a form
- 18 prescribed by the board, before commencing to test milk[, and
- annually thereafter on or before December first].
- The tester's certificate issued hereunder shall be for [the
- 21 term of one calendar year] a term of no more than two (2) years
- 22 from the date of issuance, and shall be posted and kept in plain
- 23 view in the plant in which the certified tester is employed.
- 24 Section 603. Certified Weighers and Samplers.--It shall be
- 25 unlawful for any milk dealer to buy or receive milk from
- 26 producers, or to sell or deliver milk to stores or consumers on
- 27 the basis of, or with reference to, the amount of butterfat or
- 28 appropriate milk components contained in such milk, unless the
- 29 samples taken for testing purposes shall be made by a certified
- 30 tester or certified weigher and sampler, and according to the

- 1 method prescribed in this act or in regulations established by
- 2 the board under this act.
- 3 It shall be unlawful for any person to pick up milk from
- 4 farms unless the person making the pickup has a valid tester's
- 5 certificate or weigher's or sampler's certificate issued by the
- 6 board.
- 7 Any person who, upon the effective date of this act, is the
- 8 holder of a certificate of proficiency for milk weighing and
- 9 sampling issued after examination conducted by the Pennsylvania
- 10 Department of Agriculture, shall, upon application to the board
- 11 on a form prescribed by the board furnishing information
- 12 including that pertaining to good character and to apparatus and
- 13 methods used in weighing and sampling, be issued a certificate
- 14 and be designated therein as a certified weigher and sampler.
- Any person who is not the holder of such certificate of
- 16 proficiency upon the effective date of this act, shall, prior to
- 17 applying for a weighing and sampling certificate, apply to the
- 18 board for a certificate of proficiency. Such application shall
- 19 be accompanied by a fee [of five dollars (\$5.00).] established
- 20 under section 8 of the act of July 1, 1978 (P.L.730, No.132),
- 21 <u>known as the "Milk Marketing Fee Act."</u> The applicant shall be
- 22 required to pass an examination in weighing and sampling milk,
- 23 reasonably prescribed and conducted by the board, and upon
- 24 approval of the application shall be issued a certificate of
- 25 proficiency. Thereupon, and [annually] thereafter without such
- 26 examination, the person so certified may apply for a certificate
- 27 as a certified weigher and sampler. The application for such
- 28 weighing and sampling certificate, accompanied by a fee [of five
- 29 dollars (\$5.00), established under section 8 of the "Milk
- 30 Marketing Fee Act," shall be filed, upon a form prescribed by

- 1 the board, before commencing to sample milk[, and annually
- 2 thereafter on or before December first].
- 3 The weighing and sampling certificate issued hereunder shall
- 4 be for [the term of one calendar year] a term of no more than
- 5 two (2) years from the date of issuance, and shall be posted and
- 6 kept in plain view in the room in which the certified weigher
- 7 and sampler is employed.
- 8 Section 2. This act shall take effect in 60 days.
