## AN ACT

1 Making appropriations to the Trustees of the University of  
2 Pennsylvania.

3 The General Assembly of the Commonwealth of Pennsylvania  
4 hereby enacts as follows:

5 Section 1. (a) The sum of ~~\$32,293,000~~ \$31,660,000, or as <--  
6 much thereof as may be necessary, is hereby appropriated to the  
7 Trustees of the University of Pennsylvania for the fiscal year  
8 July 1, 2023, to June 30, 2024, for veterinary activities.

9 (b) The sum of ~~\$1,931,000~~ \$1,893,000, or as much thereof as <--  
10 may be necessary, is hereby appropriated to the Trustees of the  
11 University of Pennsylvania for the fiscal year July 1, 2023, to  
12 June 30, 2024, for the Center for Infectious Diseases.

13 Section 2. (a) Payments to the University of Pennsylvania  
14 on account of the appropriations provided in section 1 shall be  
15 made quarterly by the Secretary of Agriculture on the basis of  
16 costs during the fiscal year and shall be conditioned on  
17 continuing authority for inclusion on the Board of Trustees of

1 the University of Pennsylvania of a minimum of four persons who  
2 are not elected officials and who are appointed by the President  
3 pro tempore of the Senate, the Minority Leader of the Senate,  
4 the Speaker of the House of Representatives and the Minority  
5 Leader of the House of Representatives for terms of office  
6 coterminous with that of the respective appointing authority;  
7 and shall be further conditioned on these appointees receiving  
8 full voting rights as members of the board of trustees.

9 (b) The University of Pennsylvania shall provide full,  
10 complete and accurate information as may be required by the  
11 Department of Agriculture or the chairman or the minority  
12 chairman of the Appropriations Committee of the Senate or the  
13 chairman or the minority chairman of the Appropriations  
14 Committee of the House of Representatives.

15 (c) The University of Pennsylvania shall report its revenues  
16 and expenditures and present its financial statements in  
17 accordance with generally accepted accounting principles and  
18 procedures for educational institutions as stated in the "Higher  
19 Education Finance Manual (1975)" and the "Commonwealth of  
20 Pennsylvania Budget Instructions for the State System of Higher  
21 Education, State-Related Universities and Non-State-Related  
22 Colleges and Universities."

23 (d) The Trustees of the University of Pennsylvania shall  
24 report on forms provided by the Department of Agriculture to  
25 both the chairman and minority chairman of the Appropriations  
26 Committee of the Senate and the chairman and minority chairman  
27 of the Appropriations Committee of the House of Representatives  
28 by September 30, 2024, on how State-appropriated funds were  
29 expended for fiscal year 2023-2024 to reduce the costs to  
30 Pennsylvania resident students or to provide services to

1 Pennsylvania residents.

2 Section 3. This act shall take effect July 1, 2023, or  
3 immediately, whichever is later.
