AN ACT

1 Amending Title 71 (State Government) of the Pennsylvania
2 Consolidated Statutes, in benefits, providing for
3 supplemental annuities for certain State Police officers
4 commencing 2023.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. Title 71 of the Pennsylvania Consolidated
8 Statutes is amended by adding a section to read:

9 § 5708.9. Supplemental annuities for certain State Police
10 officers commencing 2023.

11 (a) Benefits.--Commencing with the first monthly annuity
12 payment after June 30, 2023, an eligible benefit recipient shall
13 be entitled to receive a supplemental monthly annuity from the
14 system. This shall be in addition to the supplemental annuities
15 provided for in sections 5708 (relating to supplemental
16 annuities), 5708.1 (relating to additional supplemental
17 annuities), 5708.2 (relating to further additional supplemental
18 annuities), 5708.3 (relating to supplemental annuities

1 commencing 1994), 5708.5 (relating to supplemental annuities
2 commencing 1998), 5708.6 (relating to supplemental annuities
3 commencing 2002) and 5708.7 (relating to supplemental annuities
4 commencing 2003) and the special supplemental postretirement
5 adjustments provided for in sections 5708.4 (relating to special
6 supplemental postretirement adjustment) and 5708.8 (relating to
7 special supplemental postretirement adjustment of 2002).

8 (b) Amount of supplemental annuity.--The amount of the
9 supplemental annuity payable pursuant to this section shall be
10 an amount in addition to the monthly annuity payment rate on
11 July 1, 2023, determined on the basis of the most recent
12 effective date of retirement, as follows:

13 Most recent effective date of Increase in yearly annuity:
14 retirement:

15 <u>On or prior to June 30, 1990</u>	<u>\$3,000</u>
16 <u>July 1, 1990, to June 30, 2000</u>	<u>\$2,000</u>
17 <u>July 1, 2000, to June 30, 2010</u>	<u>\$1,000</u>

18 (c) Payment.--The supplemental annuity provided under this
19 section shall be paid automatically unless the annuitant files a
20 written notice with the board requesting that the additional
21 monthly supplemental annuity not be paid.

22 (d) Conditions.--The supplemental annuity provided under
23 this section shall be payable under the same terms and
24 conditions as provided under the option plan in effect as of
25 July 1, 2023.

26 (e) Benefits paid to beneficiaries or survivors.--No
27 supplemental annuity provided under this section shall be
28 payable to the beneficiary or survivor annuitant of a member who
29 dies before July 1, 2023.

30 (f) Eligible benefit recipient.--As used in this section,

1 the term "eligible benefit recipient" means a State Police
2 officer who is a superannuation, withdrawal or disability
3 annuitant on July 1, 2023, and whose most recent effective date
4 of retirement is prior to July 1, 2010.

5 Section 2. This act shall take effect immediately.
