## AN ACT

1 Amending Title 35 (Health and Safety) of the Pennsylvania  
2 Consolidated Statutes, in Nonprofit Security Grant Fund,  
3 further providing for Nonprofit Security Grant Fund; AND ◀  
4 MAKING AN APPROPRIATION.

5 The General Assembly of the Commonwealth of Pennsylvania  
6 hereby enacts as follows:

7 ~~Section 1. Section 5602(d) of Title 35 of the Pennsylvania~~ ◀

9 ~~§ 5602. Nonprofit Security Grant Fund.~~

11 ~~(d) Transfer by Secretary of the Budget. No later than 30~~ ◀

12 ~~days after the effective date of this [section] subsection, the~~ ◀

13 ~~Secretary of the Budget shall transfer to the fund [\$5,000,000]~~ ◀

14 ~~\$10,000,000 of the unexpended, unencumbered prior year funds~~ ◀

1 ~~that were originally appropriated from the General Fund to any~~  
2 ~~executive branch agency which is subject to the policy,~~  
3 ~~supervision and control of the Governor. The Secretary of the~~  
4 ~~Budget may only make the transfer of funds if the transfer will~~

14 CONSOLIDATED STATUTES IS AMENDED BY ADDING A SUBSECTION TO READ:  
15 § 5602. NONPROFIT SECURITY GRANT FUND.

17 (E.1) ADDITIONAL APPROPRIATION FOR 2023-2024 FISCAL YEAR.--  
18 IN ADDITION TO ANY TRANSFERS OR APPROPRIATIONS TO THE FUND UNDER  
19 THIS SECTION FOR THE 2023-2024 FISCAL YEAR, \$5,000,000 IS  
20 APPROPRIATED TO THE FUND FOR THE 2023-2024 FISCAL YEAR.
