AN ACT

1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An  
2 act relating to the public school system, including certain  
3 provisions applicable as well to private and parochial  
4 schools; amending, revising, consolidating and changing the  
5 laws relating thereto," in charter schools, further providing  
6 for applicability of other provisions of this act and of  
7 other acts and regulations.

8 The General Assembly of the Commonwealth of Pennsylvania  
9 hereby enacts as follows:

10 Section 1. Section 1749-A(a)(1) of the act of March 10, 1949  
11 (P.L.30, No.14), known as the Public School Code of 1949,  
12 amended July 11, 2024 (P.L.618, No.55), is reenacted and amended  
13 to read:

14 Section 1749-A. Applicability of other provisions of this act

16 (a) General requirements.--Cyber charter schools shall be
