A RESOLUTION

1 Designating the week of June 19 through 25, 2023, as "Pollinator
2 Week" in Pennsylvania.

3 WHEREAS, Pollinator species such as birds and insects,
4 including bees, are essential partners of farmers and ranchers
5 in producing much of our food supply; and

6 WHEREAS, Pollination plays a vital role in the health of our
7 national forests and grasslands, which provide forage, fish and
8 wildlife, timber, water, mineral resources and recreational
9 opportunities as well as enhanced economic development
10 opportunities for communities; and

11 WHEREAS, Pollinator species, including bees, provide
12 significant environmental benefits that are necessary for
13 maintaining healthy, biodiverse ecosystems; and

14 WHEREAS, The Commonwealth has managed wildlife habitats and
15 public lands, including forests and grasslands, for decades; and

16 WHEREAS, The Bee Law, which appears in Chapter 21 of Title 3

1 of the Pennsylvania Consolidated Statutes, and other laws and
2 regulations provide producers with conservation assistance to
3 promote wise conservation stewardship, including the protection
4 and maintenance of pollinators and their habitats on working
5 lands and wildlands, and, through the Department of Agriculture,
6 register and regulate each apiary; and

7 WHEREAS, The Pennsylvania State Beekeepers Association works
8 with the Department of Agriculture to promote pollination,
9 beekeeping and the production of honey; and

10 WHEREAS, Among its activities, the association:

11 (1) produces a newsletter 10 times per year;

12 (2) meets twice yearly to conduct business;

13 (3) operates a booth at the Pennsylvania Farm Show and
14 Ag Progress Days to promote honey and beekeeping;

15 (4) maintains an education program to inspire new
16 beekeepers and continues to investigate avenues to provide
17 information to more accomplished beekeepers;

18 (5) supports Delaware Valley University and The
19 Pennsylvania State University in projects, staff and grant
20 requests that further research and continually promote
21 beekeeping; and

22 (6) operates the Honey Queen Program to promote honey
23 and provide beekeepers across this Commonwealth with a
24 resource person to assist in promoting honey in local areas;

25 and

26 WHEREAS, The Pollinator Partnership is a nonprofit
27 organization that protects the health of managed and native
28 pollinating animals vital to North American ecosystems and
29 agriculture; and

30 WHEREAS, The Pollinator Partnership collaborates with

1 stakeholders who manage or influence landscapes to do a better
2 job of sharing the landscape with pollinators; and

3 WHEREAS, The Pollinator Partnership's mission is to protect
4 pollinators critical to food and ecosystems through
5 conservation, education and research which includes "National
6 Pollinator Week," the North American Pollinator Protection
7 Campaign and ecoregional planting guides; therefore be it

8 RESOLVED, That the House of Representatives designate the
9 week of June 19 through 25, 2023, as "Pollinator Week" in
10 Pennsylvania; and be it further

11 RESOLVED, That the House of Representatives congratulate the
12 Pennsylvania State Beekeepers Association, Penn State
13 Cooperative Extension, Delaware Valley University and the
14 Department of Agriculture for their cooperative efforts to
15 promote pollination, beekeeping and the production of honey; and
16 be it further

17 RESOLVED, That the House of Representatives support the
18 efforts of the Pollinator Partnership to annually observe
19 "National Pollinator Week"; and be it further

20 RESOLVED, That the House of Representatives urge the Governor
21 to issue a proclamation urging all residents to recognize this
22 observance; and be it further

23 RESOLVED, That copies of this resolution be transmitted to
24 the Governor, the Department of Agriculture, the Pennsylvania
25 State Beekeepers Association and the Pollinator Partnership.
