## AN ACT

16 (b) Definitions.--As used in this section, the following 17 words and phrases shall have the meanings given to them in this 18 subsection:

"Bulk milk." The term shall mean milk, as defined in section 1 of the act of July 2, 1935 (P.L.589, No.210), referred to as the Milk Sanitation Law, which is not transported in packages. "Condensed milk" and "evaporated milk." The term shall mean manufactured dairy products as defined in section 1 of the act of July 2, 1935 (P.L.589, No.210), referred to as the Milk Sanitation Law, which is not transported in packages.

Power of Governor during emergency. 19 (a) General rule.--[In] Except as provided under subsection\_ 20 (a.1) and section 4968(a.2)(4) (relating to permit for movement\_ during course of manufacture), in the event of a declared 21 National, State or local emergency when the Governor of this 22 Commonwealth, under 35 Pa.C.S. § 7301 (relating to general 23 24 <u>authority of Governor)</u>, has made a specific determination that 25 modification of any of the provisions of this title will aid in the alleviation of the stated emergency conditions, the Governor 26 27 shall have the power to so modify the provisions on any or all highways in this Commonwealth to be effective at any or all 28 29 hours of the day or night with respect to any or all types or classes of vehicles. 3	period. No person, unless specifically exempted by the terms of
4	the declaration of emergency or by other provisions of the

9	milk to or from a milk plant or to or from a dairy farm, or is
