AN ACT

1 Designating the portion of Pennsylvania Route 41 (Gap Newport  
2 Pike) from the intersection with Bernard Avenue to the  
3 intersection with Highland Road in West Fallowfield Township,  
4 Chester County, as the Corporal Brandon Hardy Memorial  
5 Highway; designating a bridge, identified as Bridge Key  
6 13775, carrying Pennsylvania Route 641 over Big Spring Creek  
7 on the border of Newville Borough and West Pennsboro  
8 Township, Cumberland County, as the SFC Randall Shughart  
9 Memorial Bridge; designating a portion of Johnson Mill Road  
10 (State Route 1001) from the bridge over Buffalo Creek (Bridge  
11 Key 33467) to the intersection of Colonel John Kelly Road  
12 (State Route 1002) in Buffalo Township, Union County, as the  
13 Sgt. Edward L. Shannon Memorial Highway; designating a  
14 bridge, identified as Bridge Key 13617, carrying Pennsylvania  
15 Route 34, over Mountain Creek in Mount Holly Springs Borough,  
16 Cumberland County, as the Firefighter Jerome Guise Memorial  
17 Bridge; designating a bridge, identified as Bridge Key 8553,  
18 carrying State Route 1006 on Syberton Road over Clearfield  
19 Creek in Gallitzin Township, Cambria County, as the Private  
20 Martin J. Hanlon Memorial Bridge; designating a bridge,  
21 identified as Bridge Key 36247, carrying Pennsylvania Route  
22 711 over Loyalhanna Creek in Ligonier Township, Westmoreland  
23 County, as the Sergeant Alvin P. Carey and Private John C.  
24 Ewing Medal of Honor Memorial Bridge; designating the bridge,  
25 identified as Bridge Keys 34474 and 34477, carrying  
26 Interstate 70 over Pennsylvania Route 18, on the border of  
27 Washington City and Canton Township, Washington County, as  
28 the Corporal Frank J. Sworden Memorial Bridge; designating a  
29 portion of Pennsylvania Route 310 between Knox Dale Road,  
30 also known as State Route 2023, and Ash Street in McCalmont  
31 Township, Jefferson County, as the Lance Cpl. Bernard Himes  
32 Memorial Highway; designating a bridge, identified as Bridge

1 Key 33758, carrying Pennsylvania Route 427 over Sugar Creek  
2 in Sugarcreek Borough, Venango County, as the Staff Sergeant  
3 Richard James Mulholland Memorial Bridge; designating a  
4 bridge, identified as Bridge Key 8537, carrying Pennsylvania  
5 Route 869 over a tributary of the Little Conemaugh River in  
6 Jackson Township, Cambria County, as the Sergeant Vance  
7 Stephan Keslar Memorial Bridge; designating a bridge,  
8 identified as Bridge Key 8392, carrying Pennsylvania Route 53  
9 over Bruebaker Run in Dean Township, Cambria County, as the  
10 U.S. Army Technical Sergeant Joseph F. Johnston Memorial  
11 Bridge; designating a bridge, identified as Bridge Key 43267,  
12 on that portion of State Route 3041, also known as Dishong  
13 Mountain Road, over U.S. Route 22 in Jackson Township,  
14 Cambria County, as the Technical Sergeant Mike Capelli  
15 Memorial Bridge; designating a bridge, identified as Bridge  
16 Key 45701, carrying Pennsylvania Route 403 over the Conemaugh  
17 River between Johnstown City and West Taylor Township,  
18 Cambria County, as the Captain Raymond W. Callahan, Jr.,  
19 Memorial Bridge; designating a bridge, identified as Bridge  
20 Key 8569, carrying State Route 1021 over Glendale Lake in

38 Hinckston Run in Jackson Township, Cambria County, as the

41 over California Run in Cambria Township, Cambria County, as  
42 the Senior Chief Stanley "Stush" Kubat, Jr., Memorial Bridge;  
43 designating a bridge, identified as Bridge Key 46706,  
44 carrying State Route 4001, also known as Iverson Road, over  
45 Stevens Run in Blacklick Township, Cambria County, as the PVT  
46 Donald D. Marsh Memorial Bridge; designating a bridge,  
47 identified as Bridge Key 19716, carrying State Route 2019  
48 over Mahoning Creek in Bell Township, Jefferson County, as  
49 the SP4 Michael Raymond Ishman Memorial Bridge; designating a  
50 bridge, identified as Bridge Key 5550, carrying Woodbury Pike  
51 (Pennsylvania Route 36) over Halter Creek, spanning Blair and  
52 Freedom Townships, Blair County, as the Pvt. William E. Green  
53 Memorial Bridge; designating a bridge, identified as Bridge

10 Chest Creek on the border of Allegheny Township and East

14 the intersection of Pennsylvania Route 309 to the border of

29 the Sgt. Earl D. Barkley Memorial Bridge; designating the  
30 section of State Route 403, also known as Cramer Pike, from

32 Township, Cambria County, to the intersection with State  
33 Route 8010, Segment 250 (Ramp E) in East Wheatfield Township,  
34 Indiana County, as the Captain Harry G. Cramer Memorial  
35 Highway; designating a portion of Pennsylvania Route 173  
36 between the southern border of Slippery Rock Township to the  
37 southern border of Slippery Rock Borough in Slippery Rock  
38 Township, Butler County, as the 173rd Airborne Brigade  
39 Highway; designating a bridge, identified as Bridge Key  
40 53848, carrying Pennsylvania Route 36 over Canoe Creek in  
41 Bell Township, Jefferson County, as the PFC Larry E. Frantz  
42 Memorial Bridge; designating the interchange of U.S. Route  
43 22/322 with Arch Rock Road in Fermanagh Township, Juniata  
44 County, as the Trooper Jacques F. Rougeau, Jr., Memorial  
45 Interchange; designating the bridge, identified as Bridge Key  
46 47695, carrying U.S. Route 202 over Almshouse Road in

8 with Pennsylvania Route 192 in Millheim Borough and Penn  
9 Township, Centre County, as the Lieutenant General Robert D.  
10 Springer Memorial Highway; DESIGNATING A BRIDGE, IDENTIFIED <--  
11 AS BRIDGE KEY 55815, CARRYING STATE ROUTE 1005 OVER CROOKED  
12 CREEK IN RAYNE TOWNSHIP, INDIANA COUNTY, AS THE SERGEANT  
13 CHARLES R. LEARN MEMORIAL BRIDGE; DESIGNATING A BRIDGE,  
14 IDENTIFIED AS PENNSYLVANIA ROUTE 443 BRIDGE, OVER THE LITTLE  
15 SCHUYLKILL RIVER, LOCATED IN WALKER TOWNSHIP, SCHUYLKILL  
16 COUNTY, AS THE WILLIAM HOFFMAN MEMORIAL BRIDGE; DESIGNATING A  
17 BRIDGE, IDENTIFIED AS PARK ROAD BRIDGE, LOCATED IN  
18 WYOMISSING, BERKS COUNTY, AS THE JOSEPH WALKER MEMORIAL  
19 BRIDGE; DESIGNATING A BRIDGE ON U.S. ROUTE 209 OVER MIDDLE  
20 CREEK, LOCATED IN POLK TOWNSHIP, MONROE COUNTY, AS THE  
21 CHARLES GARDNER MEMORIAL BRIDGE; DESIGNATING A BRIDGE, ALSO  
22 KNOWN AS THE BRIDGE STREET BRIDGE, LOCATED IN WEISSPORT  
23 BOROUGH, CARBON COUNTY, AS THE RALPH STRUBINGER MEMORIAL  
24 BRIDGE; DESIGNATING A BRIDGE, IDENTIFIED AS U.S. ROUTE 422  
25 BRIDGE, OVER THE LITTLE CACOOSING CREEK, LOCATED IN LOWER  
26 HEIDELBERG TOWNSHIP, BERKS COUNTY, AND SOUTH HEIDELBERG  
27 TOWNSHIP, BERKS COUNTY, AS THE WILBUR BOHN MEMORIAL BRIDGE;  
28 DESIGNATING A BRIDGE, ON LITTLE MOUNTAIN ROAD OVER THE LITTLE  
29 CATAWISSA CREEK, LOCATED IN UNION TOWNSHIP, SCHUYLKILL  
30 COUNTY, AS THE JOSEPH ZIENKIEWICZ MEMORIAL BRIDGE;  
31 DESIGNATING A BRIDGE, ON PENNSYLVANIA ROUTE 191 OVER BRODHEAD  
32 CREEK, LOCATED IN STROUD TOWNSHIP, MONROE COUNTY, AS THE  
33 GORDON BRINK MEMORIAL BRIDGE; DESIGNATING A BRIDGE, ON  
34 PENNSYLVANIA ROUTE 924 OVER THE RAILROAD, LOCATED IN  
35 GILBERTON BOROUGH, MONROE COUNTY, AS THE WALTER SKUBEL  
36 MEMORIAL BRIDGE; DESIGNATING A BRIDGE, ON PENNSYLVANIA ROUTE  
37 512 OVER THE MONOCACY CREEK, LOCATED IN BETHLEHEM CITY,  
38 NORTHAMPTON COUNTY, AS THE RAPHAEL RIVERA MEMORIAL BRIDGE;  
39 DESIGNATING A BRIDGE ON PENNSYLVANIA ROUTE 443 OVER THE  
40 SCHUYLKILL RIVER, LOCATED IN SCHUYLKILL HAVEN BOROUGH,  
41 SCHUYLKILL COUNTY, AS THE CAITLIN MCGARRY MEMORIAL BRIDGE;  
42 DESIGNATING THE PORTION OF STATE ROUTE 1013 (ACADEMY ROAD)  
43 FROM THE INTERSECTION WITH CROMWELL ROAD TO THE INTERSECTION  
44 WITH COMLY ROAD IN PHILADELPHIA, PHILADELPHIA COUNTY, AS THE  
45 U.S. ARMY RANGER SPC DEVIN J. KUHN MEMORIAL HIGHWAY;  
46 DESIGNATING A BRIDGE, IDENTIFIED AS BRIDGE KEY 8660, CARRYING  
47 STATE ROUTE 3039 OVER THE CONEMAUGH RIVER IN THE CITY OF  
48 JOHNSTOWN, CAMBRIA COUNTY, AS THE CORPORAL ROBERT J. RUSNAK  
49 MEMORIAL BRIDGE; DESIGNATING A BRIDGE, IDENTIFIED AS BRIDGE  
50 KEY 11476, ON STATE ROUTE 322, ALSO KNOWN AS NICHOLS STREET  
51 OVER THE WEST BRANCH OF THE SUSQUEHANNA RIVER IN THE BOROUGH  
52 OF CLEARFIELD, CLEARFIELD COUNTY, AS THE WALTER LANE MEMORIAL  
53 BRIDGE; DESIGNATING A BRIDGE, IDENTIFIED AS BRIDGE KEY 5221,  
54 CARRYING U.S. ROUTE 422 BUSINESS, ALSO KNOWN AS PENN STREET,  
55 OVER THE SCHUYLKILL RIVER IN THE CITY OF READING, BERKS  
56 COUNTY, AS THE POLICE OFFICER SCOTT A. WERTZ MEMORIAL BRIDGE;  
57 DESIGNATING A PORTION OF STATE ROUTE 2005, KNOWN AS LEHIGH  
58 STREET, IN ALLENTOWN, LEHIGH COUNTY, FROM SEGMENT 0060/OFFSET  
59 1800 TO THE INTERSECTION WITH VULTEE STREET, AS THE CHIEF  
60 CHRISTOPHER KISKERAVAGE MEMORIAL HIGHWAY; and making repeals.

1 The General Assembly of the Commonwealth of Pennsylvania  
2 hereby enacts as follows:

3 Section 1. Corporal Brandon Hardy Memorial Highway.

4 (a) Findings.--The General Assembly finds that:

5 (1) Brandon Michael Hardy, born March 8, 1981, was a  
6 resident of Cochranville, Chester County, and was the oldest  
7 of four children.

8 (2) Corporal Hardy graduated from Octorara High School  
9 in 1999 and enrolled at CAT-Brandywine Vocational Technical  
10 School in the culinary arts program and was awarded the  
11 Outstanding Culinary Arts Co-Op Student Award.

12 (3) After seeing news coverage of Operation Desert Storm  
13 in 1991, Corporal Hardy was inspired to join the military and  
14 later decided to join the United States Air Force in 1999.

15 (4) Corporal Hardy was stationed in Germany for two  
16 years and served three years at Fairchild Air Force Base in  
17 Spokane, Washington.

18 (5) While serving at these duty stations, Corporal Hardy  
19 was deployed three times to the Middle East, serving in Saudi  
20 Arabia, Oman and the United Arab Emirates.

21 (6) In an extraordinary move, Corporal Hardy decided to  
22 forgo his rank and pay to basically start over and enlist as  
23 a member of the United States Marine Corps.

24 (7) After advanced infantry training, Corporal Hardy  
25 moved on to Camp Pendleton where he graduated at the top of  
26 the class at the Assault Amphibian Training School, serving  
27 as crew chief of an assault amphibian vehicle assigned to the  
28 3rd Assault Amphibian Battalion, 1st Marine Division, I  
29 Marine Expeditionary Force.

30 (8) Corporal Hardy was deployed to Iraq on March 27,

1 2006.

2 (9) On April 28, 2006, in the early morning hours, at  
3 the Haditha Dam area in Anbar Province, Iraq, Corporal Hardy  
4 was returning to base camp after an aid and assist mission  
5 when the vehicle in which he was a passenger struck an IED.

6 (10) Three of the five passengers of the Humvee were  
7 mortally wounded, including Corporal Hardy, who was killed in  
8 action.

9 (11) As a member of the United States Marine Corps,  
10 Corporal Hardy received the following awards:

11 (i) Purple Heart.

12 (ii) Combat Action Ribbon.

13 (iii) Good Conduct Medal.

14 (iv) National Defense Service Medal.

15 (v) Iraq Campaign Medal.

16 (vi) Global War on Terrorism Service Medal.

17 (vii) Sea Service Deployment Ribbon.

18 (viii) Hawaiian Medal of Honor by the State of  
19 Hawaii.

20 (b) Designation.--The portion of Pennsylvania Route 41 (Gap  
21 Newport Pike) from the intersection with Bernard Avenue to the  
22 intersection with Highland Road in West Fallowfield Township,  
23 Chester County, is designated as the Corporal Brandon Hardy  
24 Memorial Highway.

25 (c) Signs.--The Department of Transportation shall erect and  
26 maintain appropriate signs displaying the name of the highway to  
27 traffic in both directions on the highway.

28 Section 2. SFC Randall Shughart Memorial Bridge.

29 (a) Findings.--The General Assembly finds and declares as  
30 follows:

1           (1) Sergeant First Class Randall David "Randy" Shughart  
2 was born August 13, 1958, in Lincoln, Nebraska, into an Air  
3 Force family.

4           (2) The Shugharts moved to Newville, Pennsylvania, after  
5 SFC Shughart's father left the United States Air Force,  
6 living on and tending to a dairy farm.

7           (3) SFC Shughart joined the United States Army while  
8 attending Big Spring High School in Newville and entered upon  
9 graduation.

10          (4) SFC Shughart completed a pre-ranger course and was  
11 granted a slot to attend Army Ranger School, from which he  
12 graduated and earned the coveted Ranger Tab.

13          (5) SFC Shughart left the service for a time and then  
14 reenlisted into the Army Rangers. He was later assigned to  
15 "Delta Force" and transferred to Fort Bragg, North Carolina.

16          (6) SFC Shughart was deployed to Mogadishu, Somalia,  
17 with other Delta Force members in the summer of 1993 as part  
18 of Task Force Ranger.

19          (7) On October 3, 1993, SFC Shughart was a member of the  
20 sniper team during Operation Gothic Serpent, a joint-force  
21 assault mission to apprehend key advisers to Somali warlord  
22 Mohamed Farrah Aidid.

23          (8) During the assault, Super Six One and Four, two of  
24 the Army's Black Hawk helicopters providing insertion and air  
25 support to the assault team, were shot down and crashed in  
26 the city.

27          (9) SFC Shughart and his Delta Sniper Team Leader,  
28 Master Sergeant Gary Gordon, were inserted approximately 100  
29 meters from the second crash site, armed with only their  
30 sniper rifles and sidearms, and made their way to the

1 location of the downed Blackhawk.

2 (10) When Master Sergeant Gordon and SFC Shughart  
3 reached Super Six Four, they extracted the pilot, Chief  
4 Warrant Officer Mike Durant, and other crew members from the  
5 aircraft and established defensive positions around the  
6 crash.

7 (11) It is believed that Master Sergeant Gordon was  
8 first to be shot by a mob, which had surrounded the crash  
9 site.

10 (12) SFC Shughart retrieved Master Sergeant Gordon's  
11 CAR-15 assault rifle and gave it to Chief Warrant Officer  
12 Durant to use. Shortly after, SFC Shughart was killed, the  
13 site was overrun and Chief Warrant Officer Durant was beaten  
14 by the mob before being taken hostage.

15 (13) SFC Shughart posthumously received the Medal of  
16 Honor for his heroic actions and sacrifice.

17 (b) Designation.--The bridge, identified as Bridge Key  
18 13775, carrying Pennsylvania Route 641 over Big Spring Creek on  
19 the border of Newville Borough and West Pennsboro Township,  
20 Cumberland County, is designated as the SFC Randall Shughart  
21 Memorial Bridge.

22 (c) Signs.--The Department of Transportation shall erect and  
23 maintain appropriate signs displaying the name of the bridge to  
24 traffic in both directions on the bridge.

25 Section 3. Sgt. Edward L. Shannon Memorial Highway.

26 (a) Findings.--The General Assembly finds and declares as  
27 follows:

28 (1) Edward L. Shannon was born March 6, 1895, in  
29 Mazeppa, Union County.

30 (2) He served in World War I with the 103rd Trench

1 Mortar Battery in the United States Army.

2 (3) On September 26, 1918, Sgt. Shannon bravely gave his  
3 life for his country after encountering hostile action in the  
4 Argonne Forest of France.

5 (4) Before serving in World War I, Sgt. Shannon fought  
6 in the Mexican Border War in 1917. For his actions there, he  
7 was awarded the Mexican Service Medal.

8 (5) He is considered a hometown hero to many in the  
9 community of Mazeppa.

10 (b) Designation.--The portion of Johnson Mill Road (State  
11 Route 1001) from the bridge over Buffalo Creek (Bridge Key  
12 33467) to the intersection of Colonel John Kelly Road (State  
13 Route 1002) in Buffalo Township, Union County, is designated as  
14 the Sgt. Edward L. Shannon Memorial Highway.

15 (c) Signs.--The Department of Transportation shall erect and  
16 maintain appropriate signs displaying the name of the highway to  
17 traffic in both directions on the highway.

18 Section 4. Firefighter Jerome Guise Memorial Bridge.

19 (a) Findings.--The General Assembly finds and declares as  
20 follows:

21 (1) Jerome S. Guise was born February 15, 1986, in  
22 Carlisle, Cumberland County.

23 (2) Mr. Guise was the father of three children: Kayla,  
24 Wyatt and Zayden.

25 (3) Mr. Guise was a firefighter with the Citizen's Fire  
26 Company No. 1 in Mount Holly Springs, Cumberland County. He  
27 served as a live-in, full-time firefighter with the Citizen's  
28 Fire Company No. 1 for 17 years.

29 (4) Over the course of his tenure with the department,  
30 Mr. Guise ranked as one of the most responsive firefighters,

1 responding to nearly 150-200 fire calls per year.

2 (5) On March 9, 2020, Mr. Guise was dispatched to a  
3 house fire. He entered the home to search for survivors, but  
4 was killed when the home collapsed around him.

5 (6) For his outstanding service to the fire department  
6 and for his bravery in responding to the March 9 house fire,  
7 Mr. Guise was awarded the Firefighter of the Year award in  
8 2020.

9 (b) Designation.--The bridge, identified as Bridge Key  
10 13617, carrying Pennsylvania Route 34, over Mountain Creek in  
11 Mount Holly Springs Borough, Cumberland County, is designated as  
12 the Firefighter Jerome Guise Memorial Bridge.

13 (c) Signs.--The Department of Transportation shall erect and  
14 maintain appropriate signs displaying the name of the bridge to  
15 traffic in both directions on the bridge.

16 Section 5. Private Martin J. Hanlon Memorial Bridge.

17 (a) Findings.--The General Assembly finds and declares as  
18 follows:

19 (1) Martin Joseph Hanlon was born May 28, 1950, in  
20 Allegheny Township.

21 (2) Private Hanlon attended Cresson High School and  
22 graduated in 1968. He was a member of the Future Farmers of  
23 America and worked at a logging company.

24 (3) Private Hanlon joined the United States Marine Corps  
25 and served as a Private in the 1st Marine Division, 11th  
26 Mountain Battalion, A Company, 3rd Marine Amphibious Force.

27 (4) On December 27, 1970, in the Quang Nam Province of  
28 South Vietnam, Private Hanlon was positioned as a gunner on a  
29 truck. He was killed in action when the vehicle struck a land  
30 mine on the roadway.

1 (5) Private Hanlon received the National Defense Service  
2 Medal, the Purple Heart, the Vietnam Campaign Medal, the  
3 Vietnam Service Medal and the Combat Action Ribbon for his  
4 bravery and sacrifice.

5 (b) Designation.--The bridge, identified as Bridge Key 8553,  
6 carrying State Route 1006 on Syberton Road over Clearfield Creek  
7 in Gallitzin Township, Cambria County, is designated as the  
8 Private Martin J. Hanlon Memorial Bridge.

9 (c) Signs.--The Department of Transportation shall erect and  
10 maintain appropriate signs displaying the name of the bridge to  
11 traffic in both directions on the bridge.

12 Section 6. Sergeant Alvin P. Carey and Private John C. Ewing  
13 Medal of Honor Memorial Bridge.

14 (a) Findings.--The General Assembly finds and declares as  
15 follows:

16 (1) Alvin P. Carey was born August 16, 1916, in  
17 Lycippus, Westmoreland County.

18 (2) Mr. Carey graduated from Ligonier High School in  
19 1935.

20 (3) Mr. Carey enlisted in the United States Army in  
21 January 1941, shortly after the attack on Pearl Harbor.

22 (4) Sergeant Carey landed at Utah Beach in Normandy on  
23 June 7, 1944, with the 2nd Infantry Division. Initially  
24 wounded in action and awarded the Purple Heart, he returned  
25 to the front lines to fight the Germans in Brest, France.  
26 While at Brest, Sergeant Carey was mortally wounded after  
27 crawling up a fire-riddled hill alone to take on a German  
28 pillbox. Due to his brave actions, the Allied soldiers were  
29 able to quickly take over the pillbox, leading to the end of  
30 Axis control in France.

1 (5) John C. Ewing was born March 4, 1843, in Donegal  
2 Township, Westmoreland County.

3 (6) Mr. Ewing received no formal education and was self-  
4 taught.

5 (7) Mr. Ewing volunteered for service with the  
6 Pennsylvania Volunteer Infantry 211th on September 12, 1864.

7 (8) Private Ewing and his regiment took part in the  
8 final assaults on Confederate positions in Petersburg,  
9 Virginia. On April 2, 1865, he engaged in hostile hand-to-  
10 hand combat, during which he captured the flags at the Battle  
11 of Five Forks near Petersburg. The battle was a key turning  
12 point, as it caused the fall of Richmond and led to the  
13 surrender of the Northern Virginia Army.

14 (9) For their bravery, both men were awarded the  
15 Congressional Medal of Honor. Both men are considered  
16 hometown heroes to many in the Westmoreland County community.

17 (b) Designation.--The bridge, identified as Bridge Key  
18 36247, carrying Pennsylvania Route 711 over Loyalhanna Creek in  
19 Ligonier Township, Westmoreland County, is designated as the  
20 Sergeant Alvin P. Carey and Private John C. Ewing Medal of Honor  
21 Memorial Bridge.

22 (c) Signs.--The Department of Transportation shall erect and  
23 maintain appropriate signs displaying the name of the bridge to  
24 traffic in both directions on the bridge.

25 Section 7. Corporal Frank J. Sworden Memorial Bridge.

26 (a) Designation.--The bridge, identified as Bridge Keys  
27 34474 and 34477, carrying Interstate 70 over Pennsylvania Route  
28 18, on the border of Washington City and Canton Township,  
29 Washington County, is designated as the Corporal Frank J.  
30 Sworden Memorial Bridge.

1 (b) Signs.--The Department of Transportation shall erect and  
2 maintain appropriate signs displaying the name of the bridge to  
3 traffic in both directions on the bridge.

4 Section 8. Lance Cpl. Bernard Himes Memorial Highway.

5 (a) Findings.--The General Assembly finds and declares as  
6 follows:

7 (1) Bernard Malcolm Himes was born November 25, 1949, in  
8 Anita, Jefferson County.

9 (2) Mr. Himes was a student at Punxsutawney Area High  
10 School. At the time of his graduation, he was 17 years of  
11 age, which was too young to join the military without  
12 parental consent. He presented his parents with the  
13 documentation needed to enlist in the United States Marine  
14 Corps and they signed.

15 (3) Mr. Himes was a member of I Company, 3rd Battalion,  
16 27th Marines, 1st Marine Division, III Marine Expeditionary  
17 Force.

18 (4) Upon Mr. Himes' promotion to Lance Corporal, he was  
19 deployed to Vietnam.

20 (5) On May 17, 1968, almost one year after his high  
21 school graduation, Lance Corporal Himes was killed in action  
22 on Go Noi Island in South Vietnam.

23 (6) For his valiant service, Lance Corporal Himes'  
24 parents, Reed and Phyllis Himes, were presented with his  
25 Vietnam Service Medal, Vietnam Campaign Medal, National  
26 Defense Service Medal, Gallantry Cross with Palm, Military  
27 Merit Medal and Purple Heart.

28 (b) Designation.--The section of Pennsylvania Route 310  
29 between Knox Dale Road, also known as State Route 2023, and Ash  
30 Street in McCalmont Township, Jefferson County, is designated as

1 the Lance Cpl. Bernard Himes Memorial Highway.

2 (c) Signs.--The Department of Transportation shall erect and  
3 maintain appropriate signs displaying the name of the highway to  
4 traffic in both directions on the highway.

5 Section 9. Staff Sergeant Richard James Mulholland Memorial  
6 Bridge.

7 (a) Findings.--The General Assembly finds and declares as  
8 follows:

9 (1) Richard James Mulholland was born January 23, 1992,  
10 in Franklin, Venango County, and was a 2010 graduate of  
11 Venango Catholic High School.

12 (2) He served two deployments to Afghanistan with the  
13 82nd Airborne, 2/504th Infantry Battalion in the United  
14 States Army.

15 (3) Upon being honorably discharged from active-duty  
16 service, Staff Sergeant Mulholland enlisted in the  
17 Pennsylvania Army National Guard, serving in the HHC, 2nd  
18 Brigade HQ in Washington, Pennsylvania, and later with the  
19 HHC, 1st Battalion, 112th Infantry Battalion in Cambridge  
20 Springs, Crawford County.

21 (4) For his service to the United States, Staff Sergeant  
22 Mulholland was awarded the National Defense Service Medal,  
23 the Combat Infantryman Badge, the Parachutist Badge, the Army  
24 Good Conduct Medal, the Afghanistan Campaign Medal with two  
25 campaign stars, the NATO Medal, the Global War on Terrorism  
26 Medal, the Army Achievement Medal, the Army Service Medal and  
27 the Army Commendation Medal (3rd Award).

28 (5) Staff Sergeant Mulholland died on July 1, 2018. At  
29 the time of his death, he resided in Oil City, Venango  
30 County.

1 (b) Designation.--The bridge, identified as Bridge Key  
2 33758, carrying Pennsylvania Route 427 over Sugar Creek in  
3 Sugarcreek Borough, Venango County, is designated as the Staff  
4 Sergeant Richard James Mulholland Memorial Bridge.

5 (c) Signs.--The Department of Transportation shall erect and  
6 maintain appropriate signs displaying the name of the bridge to  
7 traffic in both directions on the bridge.

8 Section 10. Sergeant Vance Stephan Keslar Memorial Bridge.

9 (a) Findings.--The General Assembly finds and declares as  
10 follows:

11 (1) Sergeant Vance Stephan Keslar was born in  
12 Beaverdale, Cambria County.

13 (2) Sergeant Keslar dropped out of school and joined the  
14 Civilian Conservation Corps.

15 (3) Later, Sergeant Keslar joined the United States Army  
16 as a private.

17 (4) Sergeant Keslar was at Schofield Barracks on  
18 December 7, 1941.

19 (5) As the Japanese reached Pearl Harbor, Sergeant  
20 Keslar led a charge to the ammunition depot where the group  
21 was told by the supply sergeant that he had no orders to  
22 release weapons.

23 (6) Sergeant Keslar and others pushed aside the supply  
24 sergeant and ran into the depot, grabbing old water-cooled  
25 machine guns.

26 (7) Sergeant Keslar climbed to the top of the building  
27 and started firing at the Japanese forces.

28 (8) Sergeant Keslar was awarded a Bronze Star for his  
29 heroic actions during the Japanese attack on Pearl Harbor.

30 (9) Sergeant Keslar returned home and enrolled in the

1 Indiana University of Pennsylvania.

2 (10) Before receiving his bachelor's degree, Sergeant  
3 Keslar earned his GED.

4 (11) Sergeant Keslar passed away on July 22, 2003.

5 (b) Designation.--The bridge, identified as Bridge Key 8537,  
6 carrying Pennsylvania Route 869, over a tributary of the Little  
7 Conemaugh River in Jackson Township, Cambria County, is  
8 designated as the Sergeant Vance Stephan Keslar Memorial Bridge.

9 (c) Signs.--The Department of Transportation shall erect and  
10 maintain appropriate signs displaying the name of the bridge to  
11 traffic in both directions on the bridge.

12 Section 11. U.S. Army Technical Sergeant Joseph F. Johnston  
13 Memorial Bridge.

14 (a) Findings.--The General Assembly finds and declares as  
15 follows:

16 (1) Technical Sergeant Joseph F. Johnston was born  
17 November 27, 1917, and grew up in Dean, Cambria County.

18 (2) He was a 1938 graduate of Cresson High School.

19 (3) In June 1941, Technical Sergeant Johnston enlisted  
20 in the United States Army and was assigned to the 9th  
21 Division, 39th Infantry Regiment where he became a technical  
22 sergeant and platoon leader.

23 (4) Technical Sergeant Johnston's service took him to  
24 every Atlantic theater of action including the United  
25 Kingdom, North Africa and most of Western Europe.

26 (5) Technical Sergeant Johnston fought in Algeria,  
27 Morocco, Tunisia, Sicily, Normandy, England, Belgium and  
28 Germany and was at the invasion of Normandy on June 12, 1944.

29 (6) During the battles of Tunisia, Technical Sergeant  
30 Johnston, then a corporal, took command of his platoon in the

1 absence of his platoon leader and sergeant. In blackout  
2 conditions, Technical Sergeant Johnston led his platoon under  
3 heavy enemy shelling and machine gun fire and through  
4 difficult mountainous terrain to deliver supplies to those  
5 fighting on the front lines.

6 (7) For his actions during the battles of Tunisia,  
7 Technical Sergeant Johnston was awarded the Legion of Merit.

8 (8) Technical Sergeant Johnston also received a Bronze  
9 Star and Sliver Star for his service to our country.

10 (9) Technical Sergeant Johnston passed away on November  
11 7, 2010.

12 (b) Designation.--The bridge, identified as Bridge Key 8392,  
13 carrying Pennsylvania Route 53, over Bruebaker Run in Dean  
14 Township, Cambria County, is designated as the U.S. Army  
15 Technical Sergeant Joseph F. Johnston Memorial Bridge.

16 (c) Signs.--The Department of Transportation shall erect and  
17 maintain appropriate signs displaying the name of the bridge to  
18 traffic in both directions on the bridge.

19 Section 12. Technical Sergeant Mike Capelli Memorial Bridge.

20 (a) Findings.--The General Assembly finds and declares as  
21 follows:

22 (1) Technical Sergeant Mike Capelli was born in Nanty  
23 Glo, Cambria County, on May 15, 1918.

24 (2) He served in the United States Army during World War  
25 II as part of Company I, 180th Infantry Regiment, 45th  
26 Infantry Division.

27 (3) He was wounded many times and performed many acts of  
28 heroism for which he was decorated during his tours of Italy,  
29 Germany and France.

30 (4) On May 28, 1944, in Aprilia, Italy, Technical

1 Sergeant Capelli's squad was impeded by the enemy's machine  
2 guns. Technical Sergeant Capelli deployed his men and led  
3 them in an assault on the enemy's position. Although  
4 outnumbered and faced with intense fire, he succeeded after  
5 fierce hand-to-hand fighting in destroying the enemy  
6 position. For these actions, he was awarded an Oak Leaf  
7 Cluster to his Silver Star Medal.

8 (5) On January 8, 1945, in Wildenguth, France, Technical  
9 Sergeant Capelli was shot and killed while organizing his men  
10 during an attack by a reinforced band of German SS Troopers.

11 (6) His awards include the Silver Star with Oak Leaf  
12 Cluster, Bronze Star and Purple Heart with two Oak Leaf  
13 Clusters.

14 (b) Designation.--The bridge, identified as Bridge Key  
15 43267, on that portion of State Route 3041, also known as  
16 Dishong Mountain Road, over U.S. Route 22 in Jackson Township,  
17 Cambria County, is designated as the Technical Sergeant Mike  
18 Capelli Memorial Bridge.

19 (c) Signs.--The Department of Transportation shall erect and  
20 maintain appropriate signs displaying the name of the bridge to  
21 traffic in both directions on the bridge and both directions on  
22 the crossing route.

23 Section 13. Captain Raymond W. Callahan, Jr., Memorial Bridge.

24 (a) Findings.--The General Assembly finds and declares as  
25 follows:

26 (1) Captain Raymond W. Callahan, Jr., was born September  
27 11, 1946.

28 (2) Captain Callahan graduated from Greater Johnstown  
29 High School in 1964.

30 (3) Following graduation, Captain Callahan enrolled at

1 Indiana University of Pennsylvania.

2 (4) Captain Callahan enlisted in the United States Army  
3 in 1966.

4 (5) Captain Callahan was commissioned in 1967, following  
5 his graduation from Officer Candidate School at Fort Knox,  
6 Kentucky.

7 (6) Captain Callahan completed helicopter training at  
8 Fort Wolters, Texas, and completed a course in special  
9 welfare at the John F. Kennedy Center at Fort Bragg, North  
10 Carolina.

11 (7) Captain Callahan was promoted to First Lieutenant in  
12 1968 and was further promoted to Captain shortly before his  
13 death.

14 (8) Captain Callahan was killed in the line of duty in  
15 Phuoc Long Province in the central highlands of South  
16 Vietnam, near the Cambodian border on February 23, 1969.

17 (9) Captain Callahan was awarded the Bronze Star, the  
18 Purple Heart, the National Defense Service Medal, the Vietnam  
19 Service Medal and the Vietnam Campaign Ribbon.

20 (b) Designation.--The bridge, identified as Bridge Key  
21 45701, carrying Pennsylvania Route 403 over the Conemaugh River  
22 between Johnstown City and West Taylor Township, Cambria County,  
23 is designated as the Captain Raymond W. Callahan, Jr., Memorial  
24 Bridge.

25 (c) Signs.--The Department of Transportation shall erect and  
26 maintain appropriate signs displaying the name of the bridge to  
27 traffic in both directions on the bridge.

28 Section 14. CPL Reid Rex Ross 3 BT 26 Marine Reg. Memorial  
29 Bridge.

30 (a) Findings.--The General Assembly finds and declares as

1 follows:

2 (1) CPL Reid Rex Ross was born April 27, 1949.

3 (2) CPL Ross served in the United States Marine Corps  
4 with Company I, Third Battalion, Twenty-Sixth Marines, First  
5 Marine Division.

6 (3) On December 4, 1968, Company I was participating in  
7 Operation Meade River south of DaNang when the Marines were  
8 pinned down by enemy fire. CPL Ross moved from one position  
9 to another to determine ammunition requirements and provide  
10 encouragement to his men.

11 (4) CPL Ross heroically moved through intense fire and  
12 hurled hand grenades and fired several light antitank assault  
13 weapons at the enemy.

14 (5) CPL Ross directed his men to a more secure area  
15 while personally providing covering fire for them.

16 (6) CPL Ross observed two casualties lying in an area  
17 exposed to the enemy and manned an M-60 machine gun and  
18 returned fire, allowing for an evacuation team to retrieve  
19 the two individuals.

20 (7) CPL Ross was killed while providing return fire to  
21 protect his team.

22 (8) CPL Ross was awarded the Silver Star for his service  
23 and sacrifice for our country.

24 (b) Designation.--The bridge, identified as Bridge Key 8569,  
25 carrying State Route 1021 over Glendale Lake in White Township,  
26 Cambria County, is designated as the CPL Reid Rex Ross 3 BT 26  
27 Marine Reg. Memorial Bridge.

28 (c) Signs.--The Department of Transportation shall erect and  
29 maintain appropriate signs displaying the name of the bridge to  
30 traffic in both directions on the bridge.

1 Section 15. Sgt. John C. Alaimo Memorial Bridge.

2 (a) Findings.--The General Assembly finds and declares as  
3 follows:

4 (1) Sgt. John C. Alaimo was born May 31, 1948.

5 (2) Sgt. Alaimo served in the United States Army with  
6 Company A, 2nd Battalion, 16th Infantry Regiment, 2nd  
7 Brigade, 1st Infantry Division during the Vietnam War.

8 (3) Sgt. Alaimo was killed in action in Bien Hoa on  
9 April 8, 1969.

10 (b) Designation.--The bridge, identified as Bridge Key  
11 56008, carrying Pennsylvania Route 403 over Stonycreek River in  
12 Johnstown City, Cambria County, is designated as the Sgt. John  
13 C. Alaimo Memorial Bridge.

14 (c) Signs.--The Department of Transportation shall erect and  
15 maintain appropriate signs displaying the name of the bridge to  
16 traffic in both directions on the bridge.

17 Section 16. PFC Stanley Albert Stys Memorial Bridge.

18 (a) Findings.--The General Assembly finds and declares as  
19 follows:

20 (1) PFC Stanley Albert Stys was born October 1, 1949.

21 (2) PFC Stys graduated from Johnstown High School in  
22 1967.

23 (3) PFC Stys served with Company D, 1st Battalion, 502nd  
24 Infantry Regiment, 101st Airborne Division in the United  
25 States Army.

26 (4) On March 6, 1968, PFC Stys was killed in action in  
27 the Thua Thien province.

28 (b) Designation.--The bridge, identified as Bridge Key 8444,  
29 carrying US Route 219 over Pennsylvania Route 56, also known as  
30 Scalp Avenue, in Richland Township, Cambria County, is

1 designated as the PFC Stanley Albert Stys Memorial Bridge.

2 (c) Signs.--The Department of Transportation shall erect and  
3 maintain appropriate signs displaying the name of the bridge to  
4 traffic in both directions on the crossing route.

5 Section 17. PFC Cyril T. Yeckley Memorial Bridge.

6 (a) Findings.--The General Assembly finds and declares as  
7 follows:

8 (1) PFC Cyril T. Yeckley was born October 20, 1945, in  
9 Carrolltown Borough, Cambria County.

10 (2) PFC Yeckley enlisted in the United States Marine  
11 Corps and began a tour of duty in Quang Nam Province, South  
12 Vietnam, on February 23, 1969, as a rifleman with L Company,  
13 3rd Battalion, 5th Marine Regiment, 1st Marine Division.

14 (3) Less than one month later on March 13, 1969, PFC  
15 Yeckley was killed in action after receiving multiple  
16 fragmentation wounds.

17 (b) Designation.--The bridge, identified as Bridge Key 8547,  
18 located on State Route 1002, also known as Friend Lea Road, over  
19 U.S. Route 219 in Cambria Township, Cambria County, is  
20 designated as the PFC Cyril T. Yeckley Memorial Bridge.

21 (c) Signs.--The Department of Transportation shall erect and  
22 maintain appropriate signs displaying the name of the bridge to  
23 traffic in both directions on the bridge and both directions on  
24 the crossing route.

25 Section 18. East Taylor Township Veterans Memorial Bridge.

26 (a) Findings.--The General Assembly finds and declares that  
27 this Commonwealth and the nation are indebted to the veterans of  
28 East Taylor Township, Cambria County, for their bravery, heroism  
29 and sacrifice in protecting freedom and liberty both at home and  
30 abroad.

1 (b) Designation.--The bridge, identified as Bridge Key 8654,  
2 carrying State Route 3035 over the Little Conemaugh River in  
3 East Taylor Township, Cambria County, is designated as the East  
4 Taylor Township Veterans Memorial Bridge.

5 (c) Signs.--The Department of Transportation shall erect and  
6 maintain appropriate signs displaying the name of the bridge to  
7 traffic in both directions on the bridge.

8 Section 19. Officer Matthew Krupa Memorial Bridge.

9 (a) Findings.--The General Assembly finds and declares as  
10 follows:

11 (1) Officer Matthew Krupa was born July 25, 1993, in  
12 Johnstown.

13 (2) Officer Krupa was raised in Nanty Glo.

14 (3) Officer Krupa graduated from Central Cambria High  
15 School.

16 (4) Officer Krupa sought out to live his childhood dream  
17 by becoming a police officer.

18 (5) Officer Krupa graduated from the police academy and  
19 started to serve the area as a police officer.

20 (6) Officer Krupa served as a police officer for Portage  
21 Borough, Ferndale Borough, Saint Francis University, Indiana  
22 University of Pennsylvania and Conemaugh Hospital.

23 (7) In 2018, Officer Krupa moved to San Antonio, Texas,  
24 where he was employed with the Gonzales County Sheriff's  
25 Office and with the San Antonio Independent School District  
26 Police Department.

27 (8) On February 4, 2021, Officer Krupa was dressed in  
28 full uniform and on his way to work when he was involved in a  
29 line of duty car crash that took his life.

30 (9) Officer Krupa's lifelong dream was to become a K-9

1 officer, and he was in training when he was killed.

2 (b) Designation.--The bridge, identified as Bridge Key  
3 43558, carrying U.S. Route 22 over a tributary of Hinckston Run  
4 in Jackson Township, Cambria County, is designated as the  
5 Officer Matthew Krupa Memorial Bridge.

6 (c) Signs.--The Department of Transportation shall erect and  
7 maintain appropriate signs displaying the name of the bridge to  
8 traffic in both directions on the bridge.

9 Section 20. Senior Chief Stanley "Stush" Kubat, Jr., Memorial  
10 Bridge.

11 (a) Findings.--The General Assembly finds and declares as  
12 follows:

13 (1) Stanley Kubat, Jr., was born June 29, 1973, in  
14 Johnstown.

15 (2) Senior Chief Kubat served our country for 23 years  
16 in the United States Navy.

17 (3) Senior Chief Kubat was awarded a Bronze Star for his  
18 service to our nation.

19 (4) Senior Chief Kubat enjoyed golfing, hunting and  
20 fishing.

21 (5) Senior Chief Kubat passed away on November 9, 2022.

22 (b) Designation.--The bridge, identified as Bridge Key  
23 55994, carrying State Route 4002 over California Run in Cambria  
24 Township, Cambria County, is designated as the Senior Chief  
25 Stanley "Stush" Kubat, Jr., Memorial Bridge.

26 (c) Signs.--The Department of Transportation shall erect and  
27 maintain appropriate signs displaying the name of the bridge to  
28 traffic in both directions on the bridge.

29 Section 21. PVT Donald D. Marsh Memorial Bridge.

30 (a) Findings.--The General Assembly finds and declares as

1 follows:

2 (1) PVT Donald D. Marsh was born April 5, 1924.

3 (2) PVT Marsh was from Nicktown, Pennsylvania.

4 (3) PVT Marsh attended Blacklick Township High School.

5 (4) PVT Marsh joined the United States Army on November  
6 8, 1943.

7 (5) PVT Marsh was killed in action on October 31, 1944,  
8 during the World War II conflict with Axis forces in France.

9 (6) PVT Marsh was awarded the Purple Heart following his  
10 passing for his dedicated and honorable service to the United  
11 States.

12 (b) Designation.--The bridge, identified as Bridge Key  
13 46706, carrying State Route 4001, also known as Iverson Road,  
14 over Stevens Run in Blacklick Township, Cambria County, is  
15 designated as the PVT Donald D. Marsh Memorial Bridge.

16 (c) Signs.--The Department of Transportation shall erect and  
17 maintain appropriate signs displaying the name of the bridge to  
18 traffic in both directions on the bridge.

19 Section 22. SP4 Michael Raymond Ishman Memorial Bridge.

20 (a) Findings.--The General Assembly finds and declares as  
21 follows:

22 (1) Michael Raymond Ishman was born June 2, 1946, in  
23 Punxsutawney, Jefferson County.

24 (2) He served in the Vietnam War with C Company, Second  
25 Battalion, Mechanized 22nd Infantry, 4th Platoon, 3rd Brigade  
26 of the 4th Division in the United States Army.

27 (3) On January 12, 1967, SP4 Ishman was working with his  
28 platoon to find an abandoned Viet Cong campsite during  
29 Operation Cedar Falls when he was struck and killed by an  
30 enemy sniper.

1           (4) For his service to the United States, SP4 Ishman was  
2 awarded the National Defense Service Medal, the Vietnam  
3 Service Medal, the Vietnam Campaign medal, a Bronze Star and  
4 the Purple Heart.

5           (b) Designation.--The bridge, identified as Bridge Key  
6 19716, carrying State Route 2019 over Mahoning Creek in Bell  
7 Township, Jefferson County, is designated as the SP4 Michael  
8 Raymond Ishman Memorial Bridge.

9           (c) Signs.--The Department of Transportation shall erect and  
10 maintain appropriate signs displaying the name of the bridge to  
11 traffic in both directions.

12 Section 23. Pvt. William E. Green Memorial Bridge.

13           (a) Findings.--The General Assembly finds and declares as  
14 follows:

15           (1) William E. Green was born February 9, 1930, in  
16 McKee, Blair County.

17           (2) He served in the Korean War with Company A, 27th  
18 Infantry Regiment, 25th Division in the United States Army.

19           (3) On September 9, 1952, Pvt. Green was stationed in  
20 the Sandbag Castle, a strong forward outpost near the Satae-  
21 Ri/Heartbreak Ridge area in Korea, when his machine gun nest  
22 was destroyed by an artillery shell. He died from his  
23 injuries.

24           (4) For his service to the United States, Pvt. Green was  
25 awarded the National Defense Service Medal, the Korean War  
26 Service Medal, the Combat Infantryman's Badge, the Korean  
27 Service Medal, the United Nations Service Medal and the  
28 Purple Heart.

29           (b) Designation.--The bridge, identified as Bridge Key 5550,  
30 carrying Woodbury Pike (Pennsylvania Route 36) over Halter

1 Creek, spanning Blair and Freedom Townships, Blair County, is  
2 designated as the Pvt. William E. Green Memorial Bridge.

3 (c) Signs.--The Department of Transportation shall erect and  
4 maintain appropriate signs displaying the name of the bridge to  
5 traffic in both directions.

6 Section 24. Petty Officer John W. Coble Memorial Bridge.

7 (a) Findings.--The General Assembly finds and declares as  
8 follows:

9 (1) John W. Coble was born May 6, 1912.

10 (2) Mr. Coble was married to Sarah Josephine Coble, and  
11 they had six children: William Lucas Coble, Robert Harold  
12 Coble, Barbara Louise Coble Partner, Kay Frances Meleshenko,  
13 John Allan Coble and Rebecca Ann Holter.

14 (3) Mr. Coble entered Naval Service on May 12, 1944, and  
15 was honorably discharged from the United States Navy on  
16 November 18, 1945.

17 (4) Mr. Coble was a PennDOT employee who died while on  
18 the job on June 19, 1972.

19 (b) Designation.--The bridge, identified as Bridge Key  
20 41606, carrying State Route 3011, also known as Branch Road,  
21 over Spring Creek in College Township, Centre County, is  
22 designated as the Petty Officer John W. Coble Memorial Bridge.

23 (c) Signs.--The Department of Transportation shall erect and  
24 maintain appropriate signs displaying the name of the bridge to  
25 traffic in both directions on the bridge.

26 Section 25. Marine Lance Corporal Ralph Hammel Memorial Bridge.

27 (a) Findings.--The General Assembly finds and declares as  
28 follows:

29 (1) Marine Lance Corporal Ralph Hammel was born May 8,  
30 1947, in Roaring Spring, Pennsylvania.

1 (2) Prior to enlisting in the United States Marine  
2 Corps, Marine Lance Corporal Hammel attended Hollidaysburg  
3 Area High School.

4 (3) Marine Lance Corporal Hammel served as part of the  
5 1st Battalion, 3rd Marine Division.

6 (4) On March 7, 1968, Marine Lance Corporal Hammel died  
7 as a result of wounds sustained in combat from enemy mortar  
8 fire in the Quan Tri Province of South Vietnam.

9 (b) Designation.--The bridge, identified as Bridge Key  
10 46159, carrying Pennsylvania Route 36 on Charger Highway, Blair  
11 Township, Blair County, is designated as the Marine Lance  
12 Corporal Ralph Hammel Memorial Bridge.

13 (c) Signs.--The Department of Transportation shall erect and  
14 maintain appropriate signs displaying the name of the bridge to  
15 traffic in both directions on the bridge.

16 Section 26. Corpsman Charles Doerr, United States Navy,  
17 Memorial Bridge.

18 (a) Findings.--The General Assembly finds and declares as  
19 follows:

20 (1) Corpsman Charles (Chuck) William Doerr was born in  
21 Ebensburg on June 24, 1930.

22 (2) Corpsman Doerr attended Ebensburg-Cambria High  
23 School where he played football and basketball and ran track.

24 (3) Prior to departing for Korea, Corpsman Doerr was  
25 notified by the Captain of his ship that he had received a  
26 football scholarship from UCLA set to begin at the conclusion  
27 of his tour of duty.

28 (4) Corpsman Doerr was Vice President of his class in  
29 his junior year and also President and Secretary of his  
30 homeroom.

1 (5) After graduating high school in 1949, Corpsman Doerr  
2 was employed for one year before enlisting in the United  
3 States Navy.

4 (6) In 1950, Corpsman Doerr married Sally Ball and they  
5 had one son, Charles Robert Doerr.

6 (7) Corpsman Doerr enlisted in the military in September  
7 1950 and completed boot camp at Great Lakes, Illinois, later  
8 serving at Pensacola, Florida, and Bainbridge, Maryland.

9 (8) Corpsman Doerr received his 3rd class rating on  
10 October 3 and was scheduled for a rest leave when the  
11 communist push canceled all leaves.

12 (9) Corpsman Doerr served as a Hospital Corpsman with  
13 the Fleet Marines, assigned to the First Marine Division in  
14 Korea.

15 (10) Corpsman Doerr was killed in action on Bunker Hill  
16 while volunteering to accompany a rifle squad on a mission to  
17 reinforce a mortar and artillery barrage.

18 (11) Corpsman Doerr administered first aid to the  
19 numerous casualties struck down by the initial burst of fire.

20 (12) At the time of his death, Corpsman Doerr's brother,  
21 Christian, was serving in the United States Navy 70 miles  
22 from where Corpsman Doerr was killed.

23 (13) Corpsman Doerr's twin brother, Robert, was  
24 stationed with the United States Army in Yokohama, Japan, and  
25 shipped out of the state of Washington the day Corpsman Doerr  
26 was killed.

27 (14) Corpsman Doerr was posthumously awarded the Silver  
28 Star and Purple Heart medals, the Combat Action Ribbon, the  
29 Korean Service Medal, the United Nations Service Medal, The  
30 National Defense Service Medal, The Korean Presidential Unit

1 Citation and the Republic of Korea War Service Medal.

2 (b) Designation.--The bridge, identified as Bridge Key  
3 52767, carrying West High Street (State Route 4031), crossing  
4 the Ghost Town Trail, located in Ebensburg Borough, Cambria  
5 County, is designated as the Corpsman Charles Doerr, United  
6 States Navy, Memorial Bridge.

7 (c) Signs.--The Department of Transportation shall erect and  
8 maintain appropriate signs displaying the name of the bridge to  
9 traffic in both directions on the bridge.

10 Section 27. United States Army Sergeant Harold Koller Memorial  
11 Bridge.

12 (a) Findings.--The General Assembly finds and declares as  
13 follows:

14 (1) Sergeant Koller started his service in the United  
15 States Army in 1962.

16 (2) Sergeant Koller's primary unit was C Company, 1st  
17 Battalion, 327th Infantry.

18 (3) Sergeant Koller was also known by many as "Butch."

19 (4) Sergeant Koller was killed in action in the Phu Yen  
20 Province, South Vietnam, on September 2, 1966.

21 (5) Sergeant Koller's name is located on the Vietnam  
22 Memorial Wall Panel 10E Line 62.

23 (6) Sergeant Koller received the Bronze Star, the Purple  
24 Heart, the Army Presidential Unit Citation, the Army Good  
25 Conduct Medal, the Vietnam Service Medal, the Vietnam  
26 Gallantry Cross Unit Citation, the Republic of Vietnam  
27 Campaign Medal and the National Defense Service Medal.

28 (7) This designation is supported by the Clymer American  
29 Legion Post 222.

30 (b) Designation.--The bridge, identified as Bridge Key

1 11781, located on State Route 3004 over the West Branch of the  
2 Susquehanna River, Burnside Township, Clearfield County, is  
3 designated as the United States Army Sergeant Harold Koller  
4 Memorial Bridge.

5 (c) Signs.--The Department of Transportation shall erect and  
6 maintain appropriate signs displaying the name of the bridge to  
7 traffic in both directions on the bridge.

8 Section 28. Sergeant Regis H. Driskel Memorial Bridge.

9 (a) Findings.--The General Assembly finds and declares as  
10 follows:

11 (1) Sergeant Regis H. Driskel was born October 23, 1923,  
12 in Loretto.

13 (2) Prior to his military service, Sergeant Driskel  
14 worked at Sanctis Construction, Inc., in Pittsburgh and Paul  
15 Construction Company, Inc., in Cresson.

16 (3) Sergeant Driskel enlisted in the United States Army  
17 on June 28, 1944, in New Cumberland.

18 (4) Sergeant Driskel was serving with the 309th  
19 Infantry, 78th Division, when he was killed in action.

20 (5) Sergeant Driskel and his unit were driving toward  
21 Germany in the final months of World War II, with the  
22 objective of capturing bridges and dams prior to the German  
23 forces destroying them.

24 (6) Sergeant Driskel and his unit were attempting to  
25 capture Schwammenauel Dam when the unit saw heavy combat,  
26 which resulted in Sergeant Driskel's death on February 6,  
27 1945.

28 (7) Sergeant Driskel was posthumously awarded the Purple  
29 Heart for his service and sacrifice for our nation.

30 (8) Sergeant Driskel is buried at the Netherlands

1 American Cemetery in Margraten, Netherlands, which Mia  
2 Wetzler took care of for 52 years as a display of her  
3 gratitude for the sacrifice given for the liberation of her  
4 country, the Netherlands.

5 (b) Designation.--The bridge, identified as Bridge Key 8555,  
6 carrying State Route 1007 over Chest Creek on the border of  
7 Allegheny Township and East Carroll Township, Cambria County, is  
8 designated as the Sergeant Regis H. Driskel Memorial Bridge.

9 (c) Signs.--The Department of Transportation shall erect and  
10 maintain appropriate signs displaying the name of the bridge to  
11 traffic in both directions on the bridge.

12 Section 29. Heroes Highway.

13 (a) Findings.--The General Assembly finds and declares as  
14 follows:

15 (1) Firefighter Marvin Gruber and Assistant Fire Chief  
16 Zachary Paris belonged to the Community Fire Company of New  
17 Tripoli, in Lynn Township, Lehigh County, and served as  
18 volunteer firefighters.

19 (2) Firefighter Gruber and Assistant Fire Chief Paris  
20 were among scores of firefighters called to a house fire on  
21 December 7, 2022.

22 (3) Firefighter Gruber and Assistant Fire Chief Paris  
23 were trapped in the blaze and tragically lost their lives in  
24 the line of duty.

25 (4) Firefighter Gruber and Assistant Fire Chief Paris  
26 were 59 years of age and 36 years of age, respectively, at  
27 the time of their deaths.

28 (b) Designation.--The portion of Pennsylvania Route 143 in  
29 Lynn Township, Lehigh County, from the intersection of  
30 Pennsylvania Route 309 to the border of Berks County, is

1 designated as Heroes Highway, in honor of fallen firefighter  
2 Marvin Gruber and Assistant Fire Chief Zachary Paris.

3 (c) Signs.--The Department of Transportation shall erect and  
4 maintain appropriate signs, to be located at segments 0010 and  
5 0150 along Pennsylvania Route 143, displaying the name of the  
6 highway to traffic in both directions on the highway.  
7 Section 30. Captain Robert M. Young Memorial Bridge.

8 (a) Findings.--The General Assembly finds and declares as  
9 follows:

10 (1) Robert Milton Young was born January 17, 1945, in  
11 New Alexandria and spent most of his adult life in Saltsburg,  
12 where he lived with his aunt, Clayre Rochella.

13 (2) Captain Young graduated from Saltsburg High School  
14 and attended Indiana University of Pennsylvania, where he was  
15 commissioned through the Army ROTC on May 28, 1967.

16 (3) Captain Young went on to attend Infantry School,  
17 Ranger School and Armor School before serving with Company A,  
18 2nd Battalion, 36th Infantry Regiment of the 3rd Armored  
19 Division in Europe from January 1968 to August 1969.

20 (4) Captain Young was transferred to the 184th Ordnance  
21 Battalion in the Republic of Vietnam and served as the  
22 Commander of the 630th Ordnance Company from August 1969  
23 until January 1970, when he was transferred to the Infantry  
24 Branch and served with Headquarters 2nd Battalion, 34th  
25 Armored Regiment of the 25th Infantry Division.

26 (5) On May 2, 1970, Captain Young was a passenger aboard  
27 a UH-1H Iroquois helicopter on a logistical support mission  
28 to Katum fire support base in Vietnam.

29 (6) During its flight, the helicopter sustained damage  
30 from ground fire and was forced to make an emergency landing

1 along the border of Cambodia and South Vietnam where, upon  
2 landing, Captain Young and the others aboard the helicopter  
3 were captured and taken as prisoners of war in Cambodia.

4 (7) While serving as a prisoner of war, Captain Young  
5 helped to carry out a hunger strike to back the senior  
6 ranking officer who had been denied food and water for  
7 refusing to make fungi sticks.

8 (8) Following several days of the hunger strike, Captain  
9 Young became sick with Malaria and was unable to consume any  
10 food upon completion of the strike.

11 (9) On September 17, 1972, Captain Young succumbed to  
12 his illness while in captivity.

13 (10) Because of his valor and courage while serving as a  
14 prisoner of war in Cambodia, Captain Young was awarded the  
15 Silver Star.

16 (11) Captain Young's remains returned to the United  
17 States on December 7, 1997, and he is buried in Edgewood  
18 Cemetery in Saltsburg.

19 (b) Designation.--The bridge, identified as Bridge Key  
20 47515, carrying Pennsylvania Route 286 over Blacklegs Creek in  
21 Conemaugh Township, Indiana County, is designated as the Captain  
22 Robert M. Young Memorial Bridge.

23 (c) Signs.--The Department of Transportation shall erect and  
24 maintain appropriate signs displaying the name of the bridge to  
25 traffic in both directions on the bridge.

26 Section 31. Charles Owen Jenkins, Jr., Memorial Bridge.

27 (a) Findings.--The General Assembly finds and declares as  
28 follows:

29 (1) Charles Owen Jenkins, Jr., was born January 14,  
30 1941.

1 (2) Sergeant Jenkins was a resident of Clearfield County  
2 and attended Reade Township High School.

3 (3) Sergeant Jenkins enlisted in the United States Army,  
4 obtaining the rank of sergeant and serving during the Vietnam  
5 War where he began his tour of duty on February 23, 1965.

6 (4) Sergeant Jenkins' military occupation or specialty  
7 was Light Weapons Infantry, and he was attached to the  
8 Special Forces, 5th Special Forces Group, A5 414.

9 (5) During his service in the Vietnam War, Sergeant  
10 Jenkins was reported missing near Dong Xoai, Phuoc Long  
11 Province, South Vietnam, and declared dead on June 10, 1965.

12 (6) For his bravery and sacrifice, Sergeant Jenkins was  
13 awarded the Purple Heart, Bronze Star and South Vietnam  
14 Gallantry Cross.

15 (b) Designation.--The bridge, identified as Bridge Key 8574,  
16 carrying State Route 1021 over Clearfield Creek in White  
17 Township, Cambria County, is designated as the Charles Owen  
18 Jenkins, Jr., Memorial Bridge.

19 (c) Signs.--The Department of Transportation shall erect and  
20 maintain appropriate signs displaying the name of the bridge to  
21 traffic in both directions on the bridge.

22 Section 32. PFC John Balog Memorial Bridge.

23 (a) Findings.--The General Assembly finds and declares as  
24 follows:

25 (1) PFC John Balog was born October 24, 1931, in  
26 Brownsville, Fayette County.

27 (2) PFC Balog served in the Korean War with H Company,  
28 Second Battalion, 38th Infantry Regiment, 2nd Infantry  
29 Division in the United States Army.

30 (3) On September 6, 1950, PFC Balog was defending his

1 position against enemy fire near Am-Sim, South Korea. When it  
2 became necessary for his rifle team to withdraw, he  
3 volunteered to remain and cover the withdrawal. After his  
4 team withdrew, his position was overrun and he died in  
5 action. He bravely gave his life for his brothers in arms and  
6 for his country.

7 (4) For his service to the United States, PFC Balog was  
8 awarded the National Defense Service Medal, the Korean  
9 Service Medal, the United Nations Service Medal, the Republic  
10 of Korea War Service Medal, the Republic of Korea  
11 Presidential Unit Citation, two Silver Stars and the Purple  
12 Heart.

13 (5) PFC Balog is survived by numerous nieces, nephews  
14 and cousins in Ohio and southwestern Pennsylvania.

15 (b) Designation.--The bridge, identified as Bridge Key  
16 45509, carrying U.S. Route 40 over Pennsylvania Route 43 in  
17 Redstone Township, Fayette County, is designated as the PFC John  
18 Balog Memorial Bridge.

19 (c) Signs.--The Department of Transportation shall erect and  
20 maintain appropriate signs displaying the name of the bridge to  
21 traffic in both directions on the bridge.

22 Section 33. Sgt. Earl D. Barkley Memorial Bridge.

23 (a) Findings.--The General Assembly finds and declares as  
24 follows:

25 (1) Sgt. Earl D. Barkley was born October 15, 1950, in  
26 Connellsville, Fayette County.

27 (2) Sgt. Barkley served in the Vietnam War with E  
28 Company, First Battalion, 501st Infantry in the United States  
29 Army.

30 (3) On November 9, 1971, Sgt. Barkley bravely gave his

1 life for his country. He died in an explosion in Thua Thien  
2 Province, South Vietnam.

3 (4) For his valiant service, Sgt. Barkley was awarded  
4 the Purple Heart along with the National Defense Medal, the  
5 Vietnam Service Medal and the Vietnam Campaign Medal.

6 (b) Designation.--The bridge, identified as Bridge Key  
7 47947, carrying State Route 1054 over Indian Creek in Saltlick  
8 Township, Fayette County, is designated as the Sgt. Earl D.  
9 Barkley Memorial Bridge.

10 (c) Signs.--The Department of Transportation shall erect and  
11 maintain appropriate signs displaying the name of the bridge to  
12 traffic in both directions on the bridge.

13 Section 34. Captain Harry G. Cramer Memorial Highway.

14 (a) Findings.--The General Assembly finds and declares as  
15 follows:

16 (1) Captain Cramer was born May 24, 1926, in Johnstown.

17 (2) Captain Cramer graduated from Westmont-Upper Yoder  
18 High School in 1942 and from West Point in 1946.

19 (3) In the Korean War, Captain Cramer earned a Silver  
20 Star for valor and the Purple Heart with Oak Leaf Cluster for  
21 being wounded twice in combat.

22 (4) Captain Cramer became an original "Green Beret" when  
23 the Special Forces were formed in the early 1950s.

24 (5) Captain Cramer led the first team of Green Berets to  
25 Vietnam in 1957.

26 (6) Captain Cramer was killed in Vietnam in an ambush on  
27 October 21, 1957.

28 (7) Captain Cramer was buried at his alma mater, West  
29 Point.

30 (b) Designation.--The section of State Route 403, also known

1 as Cramer Pike, from the intersection with State Route 3041 in  
2 West Taylor Township, Cambria County, to the intersection with  
3 State Route 8010, Segment 250 (Ramp E) in East Wheatfield  
4 Township, Indiana County, is designated as the Captain Harry G.  
5 Cramer Memorial Highway.

6 (c) Signs.--The Department of Transportation shall erect and  
7 maintain appropriate signs displaying the name of the highway to  
8 traffic in both directions on the highway.

9 Section 35. 173rd Airborne Brigade Highway.

10 (a) Findings.--The General Assembly finds and declares as  
11 follows:

12 (1) The 173rd Airborne Brigade was constituted in 1917  
13 as an infantry brigade and deployed to France in 1918 as part  
14 of the 87th Division. Upon returning to the United States a  
15 year later, the brigade was demobilized.

16 (2) Redesignated as the 87th Reconnaissance Troop, the  
17 troop fought in three European campaigns. Although not part  
18 of the brigade in World War II, the history of the 503rd  
19 Parachute Infantry Regiment is significant to the 173rd  
20 Airborne Brigade Combat Team, comprising half of its current  
21 fighting strength.

22 (3) The 503rd Parachute Infantry Regiment was formed in  
23 1941 at Fort Bragg. The regiment jumped into New Guinea in  
24 September 1943 as part of the first successful airborne  
25 combat jump in the Pacific Theater. On February 16, 1945, the  
26 regiment jumped onto the island of Corregidor and earned the  
27 Presidential Unit Citation.

28 (4) The 173rd Infantry Brigade was activated on Okinawa,  
29 Japan, in 1963 as the 173rd Airborne Brigade. The unit earned  
30 the nickname "Sky Soldiers" from the Nationalist Chinese

1       paratroopers.

2           (5) In 1965, the 173rd Airborne Brigade became the first  
3 major unit of the United States Army to serve in Vietnam. The  
4 unit conducted the only combat parachute jump of the war in  
5 February 1967. During more than six years of continuous  
6 combat, the brigade earned 14 campaign streamers and four  
7 unit citations. Sky Soldiers serving in Vietnam earned 13  
8 Medals of Honor. The brigade was deactivated in 1972.

9           (6) Reactivated in June 2000, the 173rd Airborne Brigade  
10 conducted numerous deployments across Europe. On March 26,  
11 2003, the 173rd Airborne Brigade added to its distinguished  
12 history when nearly 1,000 Sky Soldiers parachuted into Iraq  
13 in support of Operation Iraqi Freedom I. During the  
14 operation, one Sky Soldier was awarded the Silver Star.

15           (7) In 2005, the 173rd Airborne Brigade deployed to  
16 Afghanistan along the contentious Pakistan border in support  
17 of Operation Enduring Freedom VI. Five Sky Soldiers were  
18 awarded the Silver Star for gallantry in battle.

19           (8) Upon returning to Italy in 2006, the 173rd Airborne  
20 Brigade transformed into the 173rd Airborne Brigade Combat  
21 Team. In the spring of 2007, the 173rd Airborne Brigade  
22 Combat Team executed an extended deployment to eastern  
23 Afghanistan in support of Operation Enduring Freedom VIII,  
24 where soldiers exhibited incredible bravery, earning one  
25 Medal of Honor, one Distinguished Service Cross and 32 Silver  
26 Stars.

27           (9) In 2009, the 173rd Airborne Brigade Combat Team  
28 returned to Afghanistan for a third time in support of  
29 Operation Enduring Freedom X, continuing the team's proud  
30 tradition of selfless service while executing a difficult

1 build mission south of Kabul.

2 (10) In 2012, the 173rd Airborne Brigade Combat Team  
3 returned to Afghanistan in support of Operation Enduring  
4 Freedom XIII, returning to Logar and Wardak Provinces, where  
5 they executed the difficult task of reducing the footprint of  
6 the brigade while continuing to train their Afghan  
7 counterparts.

8 (11) Upon returning to Italy in 2013, the 173rd Airborne  
9 Brigade Combat Team was redesignated as the 173rd Airborne  
10 Brigade. Today, Sky Soldiers continue the distinction of  
11 honored service dating back to World War I and proudly  
12 represent the Airborne fighting spirit wherever they serve.

13 (b) Designation.--The portion of Pennsylvania Route 173

26 (2) Before enlisting in the United States Army, PFC  
27 Frantz loved being outdoors and enjoyed fishing, working in  
28 construction and driving fast cars. He was especially fond of  
29 his dog, "Whimpy."

30 (3) Upon enlisting, PFC Frantz served in the Vietnam War

1 with B Company, 2nd Battalion, 14th Infantry Regiment, 25th  
2 Infantry Division.

3 (4) On the night of August 29, 1968, PFC Frantz was  
4 killed in action in the Hau Nghia Province near Saigon, South  
5 Vietnam, when his squad came under hostile mortar attack. He  
6 suffered fatal wounds while bravely defending his squad's  
7 position.

8 (5) For his service to the United States, PFC Frantz was  
9 awarded the Combat Infantry Badge, Sharpshooter Badge,  
10 National Defense Medal, Vietnam Service Medal, Vietnam  
11 Campaign Medal, a Bronze Star and the Purple Heart.

12 (b) Designation.--The bridge, identified as Bridge Key  
13 53848, carrying Pennsylvania Route 36 over Canoe Creek in Bell  
14 Township, Jefferson County, is designated the PFC Larry E.  
15 Frantz Memorial Bridge.

16 (c) Signs.--The Department of Transportation shall erect and

19 Section 37. Trooper Jacques F. Rougeau, Jr., Memorial  
20 Interchange.

21 (a) Findings.--The General Assembly finds and declares as

23 (1) Jacques F. "Jay" Rougeau, Jr., was born September 7,  
24 1993, in San Diego, California, to Angela and Carlo of  
25 Millcreek Township.

26 (2) Trooper Rougeau was raised and educated in Corry and  
27 graduated from Corry Area High School in 2012.

28 (3) Trooper Rougeau attended Penn State Behrend before  
29 graduating from The Pennsylvania State University Main Campus  
30 in 2015 with a bachelor's degree in criminology.

1 (4) Trooper Rougeau worked for Weis Markets in loss  
2 prevention for several years before entering the Pennsylvania  
3 State Police Academy where he graduated on January 8, 2021,  
4 as a member of the 160th class.

5 (5) For the majority of Trooper Rougeau's State Police  
6 career, he was stationed with troops in York, but in March  
7 2023, he was transferred to Troop G in Lewistown.

8 (6) Tragically, on June 17, 2023, Trooper Rougeau was  
9 fatally shot during a manhunt for a gunman who had opened  
10 fire on the Troop G Lewistown Station that morning.

11 (7) Trooper Rougeau loved golf, basketball, flying  
12 drones and rooting for Penn State football, and had a  
13 fascination with aviation.

14 (8) Trooper Rougeau loved his boxers, Winnie and  
15 Charlie.

16 (9) In addition to his mother, Angela, Trooper Rougeau  
17 is survived by his wife, Chloe (Miller) Rougeau, whom he  
18 married September 30, 2017, his sister, Christina Rougeau-  
19 Bailey, and her husband, Colton, and brother, Justin Hunt,  
20 all of Corry, Pennsylvania.

21 (b) Designation.--The interchange of U.S. Route 22/322 with  
22 Arch Rock Road in Fermanagh Township, Juniata County, is  
23 designated the Trooper Jacques F. Rougeau, Jr., Memorial  
24 Interchange.

25 (c) Signs.--The Department of Transportation shall erect and

4 (2) A graduate of Central Bucks East High School in  
5 2011, CPT Bednarzyk continued his studies at The Pennsylvania  
6 State University, where he was enrolled in the Reserve  
7 Officers' Training Corps program.

8 (3) CPT Bednarzyk served three years in the Army, first  
9 as a Platoon Leader in the 1st Battalion, 41st Infantry  
10 Regiment, 4th Infantry Division, at Fort Carson, Colorado,  
11 and most recently as a Platoon Leader in Echo Company, 3rd  
12 Battalion, 75th Ranger Regiment.

13 (4) On September 7, 2018, CPT Bednarzyk was killed in a  
14 Stryker vehicle accident during a nighttime training  
15 exercise.

16 (5) CPT Bednarzyk is laid to rest in the Washington  
17 Crossing National Cemetery in Newtown, Bucks County.

18 (6) For his sacrifice and service, CPT Bednarzyk was  
19 awarded the Ranger Tab, Air Assault Badge, Parachutist Badge,  
20 Expert Infantryman's Badge, Army Achievement Medal with one  
21 oak leaf cluster, National Defense Service Medal, Armed  
22 Forces Expeditionary Medal, Global War on Terrorism Service  
23 Medal, Army Service Ribbon and NATO Medal.

24 (b) Designation.--The bridge, identified as Bridge Key  
25 47695, carrying U.S. Route 202 over Almshouse Road in Doylestown  
26 Township, Bucks County, is designated as the CPT Connor J.  
27 Bednarzyk, USA Memorial Bridge.

28 (c) Signs.--The Department of Transportation shall erect and  
29 maintain appropriate signs displaying the name of the bridge to

2 Section 39. Staff Sergeant John F. Curcio Memorial Bridge.

3 (a) Findings.--The General Assembly finds and declares as  
4 follows:

5 (1) John F. Curcio was born May 23, 1925, in Brooklyn,  
6 New York, to the late Anthony and Stella (Pagnotto) Curcio.

7 (2) Staff Sergeant Curcio worked for the Pennsylvania  
8 Railroad, Penn Central and Conrail from 1947 to 1984.

9 (3) Staff Sergeant served in the 8th United States Army  
10 Air Forces 458th Bomber Group during World War II as a staff  
11 sergeant, completing 35 combat missions, including the Battle  
12 of the Bulge and the invasion at Normandy.

13 (4) For his service, Staff Sergeant Curcio was awarded  
14 the French Legion of Honor Medal and the Air Medal with four  
15 oak leaf clusters.

16 (5) Staff Sergeant Curcio was a member of St. Joseph  
17 Catholic Church and a graduate of St. Joseph High School.

18 (6) In his spare time, Staff Sergeant Curcio enjoyed  
19 hunting and fishing and was instrumental in placing flags on  
20 the Renovo Bridge.

21 (7) Staff Sergeant Curcio's other memberships included  
22 the Sons of Italy, Veterans of Foreign Wars 40/8, the  
23 American Legion where he served as a past commander and the  
24 Elks Lodge as a past Exalted Ruler, all of Renovo.

25 (8) Staff Sergeant Curcio is survived by two sisters,  
26 Rosemary Andrus of Lock Haven and Ellen Smith of Ashburn,  
27 Virginia, and a host of nieces and nephews.

28 (b) Designation.--The bridge, identified as Bridge Key  
29 12099, carrying Pennsylvania Route 120, also known as Renovo  
30 Road, over Young Women's Creek in Chapman Township, Clinton

1 County, is designated the Staff Sergeant John F. Curcio Memorial  
2 Bridge.

11 (2) Mr. Waller was a graduate of Washington High School  
12 and attended Carlisle Business School and the University of  
13 Pittsburgh and received an associate's degree from Dean Tech.

14 (3) In 1948, Mr. Waller was honorably discharged from  
15 the United States Army, where he served as administrator of  
16 company funds to all military units of Pennsylvania.

17 (4) On July 10, 1954, Mr. Waller married Shirley James  
18 of Buffalo, New York.

19 (5) Mr. Waller climbed the business ladder in the late  
20 1950s, but also felt the need to ascend to a higher calling  
21 when, at the age of 31, he took office as president of the  
22 NAACP's Washington Branch in 1959.

23 (6) During his tenure as president of the NAACP's  
24 Washington Branch, Mr. Waller helped bring about a public  
25 discourse toward the elimination of de facto segregation in  
26 Washington's school system.

27 (7) In addition to the NAACP, nearly 40 different  
28 organizations benefited from Mr. Waller's direct leadership  
29 and philanthropic efforts over the years, including  
30 Washington Hospital, Washington Financial Bank, Waynesburg

1 University and Washington County Community Foundation.

2 (8) Mr. Waller's strong religious faith guided his  
3 course in life, as he was a life-long member of Nazareth  
4 Baptist Church in Washington and served the church as a  
5 deacon and trustee.

6 (9) Mr. Waller passed away on February 20, 2009, at the  
7 age of 80.

8 (10) Posthumously, Mr. Waller was recognized with the  
9 Human Rights Lifetime Leadership Award by the NAACP's  
10 Washington Branch, and most recently, the Washington County  
11 Historical Society created the Waller-McDonald Collection of  
12 African American History, in honor of Mr. Waller and fellow  
13 civil rights leader James R. McDonald.

14 (11) Most recently on March 11, 2020, Mr. Waller, along  
15 with five other honorees, was posthumously inducted into the  
16 Washington County Historical Society's Hall of Fame.

17 (b) Designation.--The bridge, identified as Bridge Key  
18 44399, located on that portion of State Route 4049 over  
19 Interstate 70 in South Strabane Township, Washington County, is  
20 designated as the Louis E. Waller Memorial Bridge.

3 Service Regiment, B Company in Quang Nam, Vietnam.

4 (3) Lance Corporal Segich was on active duty in Vietnam  
5 as a member of a patrol designated BA-213, consisting of  
6 seven Marines and one ARVN and shortly after midnight on May  
7 12, 1970, Lance Corporal Segich and another Marine member of  
8 the team left their ambush site to investigate their  
9 surroundings. Lance Corporal Segich was in the lead when the  
10 other Marine stumbled and fell which caused his rifle to  
11 discharge, mortally wounding Lance Corporal Segich.

12 (4) Lance Corporal Segich is interred in the Umbria  
13 Cemetery in Osceola Mills, Clearfield County.

14 (5) For his valiant service, Lance Corporal Segich was  
15 awarded the Combat Action Ribbon, Marksmanship Badge,  
16 National Defense Service Medal, Vietnam Campaign Medal,  
17 Vietnam Service Medal, Marine Corps Presidential Unit  
18 Citation, Vietnam Gallantry Cross, Marine Corps Good Conduct  
19 Medal and the Marine Corps Expeditionary Medal.

20 (b) Designation.--The bridge, identified as Bridge Key 9570,

22 Township, Centre County, is designated the Lance Corporal  
23 Michael P. Segich Memorial Bridge.

1 Altoona, Blair County.

2 (2) Corporal Walter served in the Vietnam War with D  
3 Company, 2nd Battalion, 12th Cavalry, 1st Cavalry Division of  
4 the United States Army.

5 (3) On October 11, 1970, Corporal Clyde E. Walter, Jr.,  
6 bravely gave his life for his country after encountering  
7 hostile gunfire in the Phuoc Long Province in South Vietnam.

8 (4) For his bravery and gallantry in action, Corporal  
9 Walter was awarded the Silver Star, Air Medal, Army  
10 Commendation Medal with "V" for heroism, National Defense  
11 Service Medal, Vietnam Service Medal, Vietnam Campaign Medal,  
12 Combat Infantryman Badge, Expert Badge with Machine Gun Bar,  
13 Sharpshooter Badge with Rifle Bar, Good Conduct Medal and the  
14 Purple Heart.

15 (b) Designation.--The bridge, identified as Bridge Key 5759,  
16 located on that portion of State Route 3002 over South Poplar

18 Corporal Clyde E. Walter, Jr., Memorial Bridge.

23 (a) Findings.--The General Assembly finds and declares as

25 (1) Staff Sgt. Jae S. Moon was born June 18, 1985, in  
26 Incheon, South Korea.

27 (2) In 2003, upon graduating from Neshaminy High School,  
28 he enlisted in the United States Army to help pay for  
29 college. His dream was to become an FBI agent.

30 (3) He served in Operation Iraqi Freedom in Company B,

1 2D Battalion, 12th Infantry of the United States Army.

2 (4) On December 25, 2006, Staff Sgt. Moon died from  
3 wounds received when he was struck by an IED blast in  
4 Baghdad, Iraq.

5 (5) For his valiant service, Staff Sgt. Moon was awarded  
6 the Army Commendation Medal, Army Achievement Medal, Army  
7 Good Conduct Medal, National Defense Service Medal, Korean  
8 Defense Service Medal, Global War on Terrorism Expeditionary  
9 Medal, Global War on Terrorism Service Medal, Non-  
10 Commissioned Officer Professional Development Ribbon, Army  
11 Service Ribbon, Overseas Service Ribbon, Combat Infantryman  
12 Badge, the Bronze Star and the Purple Heart.

13 (b) Designation.--The bridge, identified as Bridge Key 7178,

26 (2) Springer earned a bachelor of arts degree in social  
27 sciences in 1964 and a master of science degree in  
28 international affairs in 1969, both from George Washington  
29 University.

30 (3) Springer enlisted in the United States Air Force in

1 October 1952.

2 (4) Springer was deployed to Vietnam in 1965, first at  
3 Bien Hoa Air Base as an intelligence officer with the 6251st  
4 Tactical Fighter Wing and later as chief of intelligence with  
5 the 1st Air Commando Squadron at Pleiku Air Base.

6 (5) After completing Air War College in May 1972,  
7 Springer was assigned to Air Force headquarters as special  
8 assistant to the Air Force vice chief of staff.

9 (6) In June 1978, Lieutenant General Springer took  
10 command of the 435th Tactical Airlift Wing at Rhein-Main Air  
11 Base in West Germany. He then became deputy chief of staff  
12 for personnel at Military Airlift Command headquarters in  
13 August 1981.

14 (7) In August 1985, Springer was assigned to Air Force  
15 headquarters as Air Force inspector general.

16 (8) From 1987 until his retirement in 1988, Springer  
17 served as vice commander in chief of the Military Airlift  
18 Command at Scott Air Force Base in Illinois.

19 (9) Lieutenant General Springer was a command pilot with  
20 more than 6,000 flying hours and 72 combat missions.

21 (10) Lieutenant General Robert D. Springer died on  
22 August 19, 2021.

23 (11) Springer's military decorations and awards include  
24 the Distinguished Service Medal, Legion of Merit,  
25 Distinguished Flying Cross, Meritorious Service Medal with  
26 three oak leaf clusters, Air Medal with oak leaf cluster,  
27 National Defense Service Medal with service star, Korean  
28 Service Medal, Vietnam Service Medal with three service  
29 stars, Humanitarian Service Medal, Air Force Overseas Ribbon-  
30 Long, Air Force Longevity Service Award Ribbon with six oak

1 leaf clusters, Armed Forces Reserve Medal, Small Arms Expert  
2 Marksmanship Ribbon, United Nations Service Medal, Republic  
3 of Vietnam Campaign Medal and the Bronze Star.
