A RESOLUTION

- 1 Directing the Legislative Budget and Finance Committee to
- conduct a study and issue a report on the impact of housing
- on health in this Commonwealth.
- 4 WHEREAS, Housing quality includes the physical condition of a
- 5 home, adequate and appropriate utility service, the
- 6 characteristics of the area in which a home is located and a
- 7 home's affordability; and
- 8 WHEREAS, Housing is considered affordable when it costs less
- 9 than 30% of a family's income; and
- 10 WHEREAS, Nearly 1.5 million Pennsylvania households spend
- 11 more than 30% of their income on housing; and
- 12 WHEREAS, Nearly 29% of children in this Commonwealth live in
- 13 cost-burdened households; and
- 14 WHEREAS, An individual who identifies as an ethnic minority
- 15 is more likely to live in unaffordable housing, which means the
- 16 individual is also more likely to face associated health
- 17 challenges; and
- 18 WHEREAS, The Federal Reserve Bank of Philadelphia reports a

- 1 Statewide shortage of 253,981 rental homes that are both
- 2 affordable and available to people at or below 30% of median
- 3 family income, often leading to homelessness; and
- 4 WHEREAS, People experiencing homelessness are more likely to
- 5 have health problems than those who are well-housed; and
- 6 WHEREAS, Inadequate nutrition and medical care are associated
- 7 with the lack of access to affordable housing; and
- 8 WHEREAS, Residents of highly impoverished, unsafe
- 9 neighborhoods have an increased likelihood of adverse physical
- 10 and mental health effects; and
- 11 WHEREAS, Substandard housing propagates infectious diseases
- 12 through contaminated water, poor waste disposal systems and
- 13 unsanitary conditions; and
- 14 WHEREAS, Substandard housing increases the risk of burns and
- 15 other injuries from exposed or unconventional heating sources,
- 16 unguarded windows and sills, broken glass, obsolete fixtures and
- 17 other hazards; and
- 18 WHEREAS, Children and senior citizens are particularly
- 19 vulnerable to the health effects of substandard housing; and
- 20 WHEREAS, More than 1,300 elderly Pennsylvanians have died
- 21 from accidental falls in unsafe houses; and
- 22 WHEREAS, Dampness, unfiltered air, poor ventilation, a lack
- 23 of heat and unclean or unsafe flooring contribute to respiratory
- 24 and pulmonary conditions, including asthma; and
- 25 WHEREAS, Homes that are poorly weatherized or lack adequate
- 26 utility service can contribute to ill health; and
- 27 WHEREAS, Statewide, 40% of the houses tested for radon have
- 28 high levels of the carcinogenic gas; and
- 29 WHEREAS, Older houses are a source of childhood lead exposure
- 30 and lead poisoning; and

- 1 WHEREAS, Because Pennsylvania has the second largest number
- 2 of pre-1950 houses in the nation, lead remains a health hazard
- 3 in our communities; and
- 4 WHEREAS, A growing number of agencies and organizations
- 5 support research showing the direct effects of housing quality
- 6 on health; and
- 7 WHEREAS, The United States Department of Housing and Urban
- 8 Development, the Pennsylvania Safe and Healthy Homes Program,
- 9 the Robert Wood Johnson Foundation's Commission to Build a
- 10 Healthier America, the Housing Alliance of Pennsylvania, the
- 11 Center for Housing Policy, the Urban Institute, the Brookings
- 12 Institute and the Healthy Rowhouse Project are among these
- 13 entities; and
- 14 WHEREAS, Health care plans and providers in several states,
- 15 including Texas, Arizona and Pennsylvania, are working to
- 16 improve health care outcomes through housing; and
- 17 WHEREAS, Pennsylvania has begun to explore solutions through
- 18 the Department of Community and Economic Development's
- 19 Neighborhood Assistance Program; and
- 20 WHEREAS, The University of Pittsburgh Medical Center,
- 21 Allegheny Health Network and Children's Hospital of Philadelphia
- 22 are developing initiatives integrating housing and health; and
- 23 WHEREAS, The Pennsylvania Housing Affordability and
- 24 Rehabilitation Enhancement Fund provides significant aid to
- 25 households below 50% of median income and has made substantial
- 26 contributions to improving the housing stock and health of
- 27 thousands of Pennsylvanians; and
- 28 WHEREAS, Current State-specific data is required to better
- 29 provide for housing and health benefits in this Commonwealth;
- 30 therefore be it

- 1 RESOLVED, That the Senate direct the Legislative Budget and
- 2 Finance Committee to conduct a study and issue a report on the
- 3 impact of housing on health in this Commonwealth; and be it
- 4 further
- 5 RESOLVED, That the study include background information and
- 6 data relating to housing conditions, including access to utility
- 7 service, and health effects described in this resolution, a
- 8 review of health-related housing initiatives across the nation
- 9 and any other information or data deemed necessary or
- 10 appropriate; and be it further
- 11 RESOLVED, That the study include an analysis of the cost of
- 12 health expenditures related to unmet housing needs, including
- 13 Medicaid, Medicare and unreimbursed care provided by hospitals;
- 14 and be it further
- 15 RESOLVED, That the study include an analysis of the health
- 16 care cost savings achievable through addressing unmet housing
- 17 needs; and be it further
- 18 RESOLVED, That the study include an analysis of the efficacy
- 19 of particular interventions to address unmet housing needs,
- 20 improve health outcomes and reduce health care expenditures; and
- 21 be it further
- 22 RESOLVED, That the study include an analysis of disaggregated
- 23 sociodemographic data related to health and housing; and be it
- 24 further
- 25 RESOLVED, That the analyzed disaggregated sociodemographic
- 26 data be made publicly available on Open Data Pennsylvania; and
- 27 be it further
- 28 RESOLVED, That, in conducting the study, the committee
- 29 consult other departments, agencies, organizations, entities or
- 30 persons as necessary or appropriate; and be it further

- 1 RESOLVED, That the committee solicit input from other
- 2 departments, agencies, organizations, entities or persons on
- 3 barriers to, and best practices for, collecting demographic
- 4 data; and be it further
- 5 RESOLVED, That the committee issue a report of its findings
- 6 and recommendations to the Senate within one year of the
- 7 adoption of this resolution; and be it further
- 8 RESOLVED, That the committee's report of its findings and
- 9 recommendations include policy changes that the collected
- 10 demographic data indicates are necessary to reduce disparities.
