SECOND CONSIDERATION CHILDREN & YOUTH BILL

HOUSE 285

An Act amending Titles 23 (Domestic Relations) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in proceedings prior to petition to adopt, further providing for grounds for involuntary termination; and, in juvenile matters, further providing for disposition of dependent child. (Representatives KRAJEWSKI, KINSEY, CONKLIN and others) – Children & Youth, March 27, 2024

This bill provides for grounds for involuntary termination in juvenile matters.

SECOND CONSIDERATION COMMERCE BILL

HOUSE 1172 2730

An Act amending Title 1 (General Provisions) of the Pennsylvania Consolidated Statutes, in rules of construction, further providing for definitions. (Representatives DALEY, RABB, HILL-EVANS and others) – Commerce, April 29, 2024

This bill allows for alkaline hydrolysis, or water-based cremation, as an alternative to traditional flame cremation.

SECOND CONSIDERATION CONSUMER PROTECTION, TECHNOLOGY AND **UTILITIES BILL**

HOUSE 2017

An Act amending Title 50 (Mental Health) of the Pennsylvania Consolidated Statutes, providing for protection of minors on social 2746 media; and imposing penalties. (Representatives MUNROE, DONAHUE, BOROWSKI and others) - Consumer Protection. Technology & Utilities, March 25, 2024

This bill amends Title 50 to provide protections for minors using social media and imposing penalties.

SECOND CONSIDERATION **EDUCATION BILL**

HOUSE

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school directors, 2112 further providing for school director training programs. PROBST, (Representatives MADDEN, **HILL-EVANS** others) - Education, January 2, 2024

This bill enhances and makes more efficient the training of elected school board officials.

SECOND CONSIDERATION HEALTH BILL

HOUSE

An Act amending the act of June 13, 2008 (P.L.182, No.27), known as the Clean Indoor Air Act, further providing for title of 2317 act, for definitions, for prohibition, for signage, for enforcement, for preemption of local ordinances and for repeal; and making editorial changes. (Representatives FRANKEL, RABB, D. WILLIAMS and others) - Health, April 17, 2024

This bill protects Pennsylvania's workers, patrons and clients from secondhand smoke by closing loopholes in the Clean Indoor Air Act.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, further providing for the offense of stalking. (Representatives POWELL, SCHLOSSBERG, CIRESI and others) - Judiciary, April 29, 2024

This bill creates an offense of unauthorized location tracking.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 1806 2238

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, further providing for false statements, investigations and penalty; and imposing penalties. (Representatives MAYES, D. MILLER, MADDEN and others) – Judiciary, April 17, 2024

This bill increases the grading thresholds for welfare fraud to allow the Office of Inspector General to pursue a greater number of cases at the Magisterial District Justice level.

SECOND CONSIDERATION LABOR & INDUSTRY BILL

HOUSE **2104**

An Act amending the act of October 27, 1955 (P.L.744, No.222), known as the Pennsylvania Human Relations Act, further providing for powers and duties of the commission; providing for policies and procedures; and establishing the Human Relations Training Fund. (Representatives MADDEN, SCOTT, PROBST and others) - Labor & Industry, April 29, 2024

This bill requires employers to adopt written policies regarding discrimination and harassment and establishes the Human Relations Training Fund.

SECOND CONSIDERATION LOCAL GOVERNMENT BILL

HOUSE 961 2439

An Act amending Title 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in preliminary provisions, providing for county property contact information list; imposing duties on chief assessors; and providing for penalties. (Representatives SOLOMON, MERSKI, SIEGEL and others) - Local Government, March 19, 2024

This bill amends Title 68 to require individuals and businesses to submit basic information to counties when purchasing real property within the county.

SECOND CONSIDERATION PROFESSIONAL LICENSURE BILL

HOUSE **2200** 2889

An Act amending Title 63 (Professions and Occupations (State Licensed)) of the Pennsylvania Consolidated Statutes, in powers and duties, providing for criminal history background checks. (Representatives BURNS, VENKAT, GIRAL and others) - Professional Licensure, April 29, 2024

This bill requires applicants for health-related licenses to submit fingerprints as part of a background check.

SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

HOUSE 1463 2939

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in Commonwealth services, further providing for definitions relating to intrastate mutual aid; and, in emergency responder mental wellness and stress management, further providing for definitions. (Representatives BENHAM, D. MILLER, MADDEN and others) - Veterans Affairs & Emergency Preparedness, April 29, 2024

This bill defines "telecommunicator" and adds the profession to the definition of "emergency responder".

HOUSE 1632

An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in interpretation and definitions, further providing for definitions; and, in liability and compensation, providing for compensation for post-traumatic stress injury. (Representatives O'MARA, SOLOMON, GILLEN and others) - Veterans Affairs & Emergency Preparedness, April 17, 2024

This bill establishes that first responders may collect workers' compensation for post-traumatic stress injuries sustained in the course and scope of their work.

THIRD CONSIDERATION AND FINAL PASSAGE JUDICIARY BILL

1371 2788

An Act providing for duties of certifying officials and certifying agencies regarding the processing of certification form petitions. (Representatives HOHENSTEIN, MIHALEK, BURGOS and others) - Appropriations, March 26, 2024 Fiscal-Note Attached

This bill provides certifying agencies with clarity and consistency for providing nonimmigrant victims with documentation to use when applying for a U Visa.

THIRD CONSIDERATION AND FINAL PASSAGE TRANSPORTATION BILL

SENATE **656** 1519

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in liquid fuels and fuels tax, further providing for definitions and for imposition of tax, exemptions and deductions and providing for electric vehicle road user charge; and imposing penalty. (Senators ROTHMAN, DUSH. AND WARD) - Appropriations, April 2024 **Fiscal-Note** 10, **Attached**

This bill imposes an annual fee of \$290 per year on certain noncommercial passenger electric vehicles and provides for the Alternative Fuels Tax on Electricity.
