An Act amending the act of April 14, 1972 (P.L.221, No.63), known as the Pennsylvania Drug and Alcohol Abuse Control Act, further providing for consent of minor. (Representatives HAHN, McNEILL, NEILSON and others) – Health, February 6, 2017

OVER

This bill amends the Drug and Alcohol Abuse Control Act to allow for parental consent.

An Act amending the act of May 29, 2012 (P.L.549, No.54), known as the Primary Stroke Center Recognition Act, further providing for short title, for definitions, for recognition of centers, for emergency medical services and for biennial report. (Representatives MACKENZIE, BAKER, DEAN and others) - Health, February 6, 2017

VOTE

(C)

This bill adds acute stroke-ready hospitals and comprehensive stroke centers to the provisions of the Primary Stroke Center Recognition Act.

#### SECOND CONSIDERATION INSURANCE BILL

HOUSE **152** 

An Act amending Title 40 (Insurance) of the Pennsylvania
Consolidated Statutes, in general provisions, providing for life
insurance database. (Representatives M. QUINN, DeLUCA, PICKETT
and others) - Insurance, February 6, 2017

OVER

This bill provides for life insurance database.

#### SECOND CONSIDERATION **JUDICIARY BILLS**

**HOUSE** 31

An Act providing for the Pennsylvania Officer Down Advisory; authorizing and directing the Pennsylvania State Police to establish 38 and maintain the Pennsylvania Officer Down Advisory; assessing costs; and providing for immunity and penalties. (Representatives D. COSTA, READSHAW, KNOWLES and others) - Judiciary, February 6, 2017

VOTE

This bill creates the PA Officer Down Advisory System to alert law enforcement agencies and the public regarding suspects who kill or seriously injure law enforcement officers.

**HOUSE** 

44

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in protection from abuse, further providing for commencement of proceedings. (Representatives DELOZIER, MARSICO, WATSON and others) - Judiciary, February 6, 2017

OVER

This bill amends the Protection from Abuse Act in order to provide the court with information regarding whether the defendant has been involved with a child abuse investigation.

HOUSE

128

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in offenses against the family, 94 further providing for the offense of dealing in infant children. (Representatives JOZWIAK, BAKER, MURT and others) - Judiciary, **February 6, 2017** 

 $\mathbf{VOTE}$ 

This bill amends Title 18 by establishing higher penalties for dealing in infant children.

**HOUSE** 

**159** 

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in juvenile matters, 123 further providing for definitions and for summary offenses. (Representatives NESBIT, MARSICO, WATSON and others) - Judiciary, February 6, 2017

 $\mathbf{VOTE}$ 

This bill amends Title 42 to clarify classification of delinquent act and summary offenses committed by juveniles.

#### SECOND CONSIDERATION TRANSPORTATION BILLS

**HOUSE** 103

An Act designating a bridge on that portion of State Route 980 over the Chartiers Creek in Canonsburg Borough, Washington 81 County, as the Officer Scott L. Bashioum Memorial Bridge. (Representatives NEUMAN, READSHAW, **ORTITAY** and others) - Transportation, February 6, 2017 1

VOTE

This bridge designates a bridge on a portion of S.R. 980 over the Chartiers Creek in Washington County as the Officer Scott L. Bashioum Memorial Bridge.

**HOUSE** 112

An Act designating a bridge on that portion of State Route 2014 88 over Lycoming Creek, City of Williamsport, Lycoming County, as the Alexander M. McFadden Memorial Bridge. (Representatives HENNESSEY, **CALTAGIRONE** WHEELAND, and others) - Transportation, February, 6, 2017 1

This bill designates a bridge on a portion of S.R. 2014 over Lycoming Creek in Lycoming County as the Alexander M. McFadden Memorial Bridge.
