33 An Act amending the act of April 14, 1972 (P.L.221, No.63), known as the Pennsylvania Drug and Alcohol Abuse Control Act, further providing for consent of minor. (Representatives HAHN, McNEILL, NEILSON and others) - **Health, February 6, 2017** **1**

OVER

This bill amends the Drug and Alcohol Abuse Control Act to allow for parental consent.

151 An Act amending the act of May 29, 2012 (P.L.549, No.54), known as the Primary Stroke Center Recognition Act, further providing for short title, for definitions, for recognition of centers, for emergency medical services and for biennial report. (Representatives MACKENZIE, BAKER, DEAN and others) - **Health, February 6, 2017** **1**

VOTE



This bill adds acute stroke-ready hospitals and comprehensive stroke centers to the provisions of the Primary Stroke Center Recognition Act.

(Representatives D. COSTA, READSHAW, KNOWLES and others) – Judiciary, February 6, 2017 **1**

VOTE



This bill creates the PA Officer Down Advisory System to alert law enforcement agencies and the public regarding suspects who kill or seriously injure law enforcement officers.

50 An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in protection from abuse, further providing for commencement of proceedings. (Representatives DELOZIER, MARSICO, WATSON and others) – Judiciary, February 6, 2017 **1**

OVER

This bill amends the Protection from Abuse Act in order to provide the court with information regarding whether the defendant has been involved with a child abuse investigation.

94 An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in offenses against the family, further providing for the offense of dealing in infant children. (Representatives JOZWIAK, BAKER, MURT and others) – Judiciary, February 6, 2017 **1**

This bill amends Title 18 by establishing higher penalties for dealing in infant children.

This bill amends Title 42 to clarify classification of delinquent act and summary offenses committed by juveniles.
