### SECOND CONSIDERATION **STATE GOVERNMENT BILL**

HOUSE An Act amending Title 24 (Education) of the Pennsylvania 205 Consolidated Statutes, in preliminary provisions relating to 1550 retirement for school employees, further providing for definitions. (Representatives PHILLIPS-HILL, BARRAR. **BLOOM** and others) - State Government, May 8, 2017 1

This bill amends the Public School Employees' Retirement Code to make PA School Boards Association employees hired after the effective date of the bill ineligible to be members of the Public School Employees' Retirement System.

HOUSE An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in limitation of time, 364 providing for ten year limitation, for mesne profits and for reimbursement and further providing for twenty-one year limitation. This bill amends Title 42 by adding a section providing for acquisition of title to real property by adverse possession in 10 years.

HOUSE An Act amending Title 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in real property, providing for 692 real estate foreclosure of vacant and abandoned property and for sheriff's commission and credit or attorney fees.
