### SECOND CONSIDERATION COMMERCE BILLS

**593** 

An Act amending Title 64 (Public Authorities and Quasi-Public Corporations) of the Pennsylvania Consolidated Statutes, in Commonwealth Financing Authority, further providing for Second Stage Loan Program. (Representatives THOMAS, DRISCOLL, McNEILL and others) - Rules, September 12, 2018

OVER

This bill provides for Second Stage Loan Program.

HOUSE **1213** 

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in consolidated county assessment, further providing for short title and scope of chapter and for appeals by taxing districts and providing for standards of redress in appeals. (Representatives KAMPF, GODSHALL, McGINNIS and others) - Commerce, September 26, 2018

OVER

This bill provides for short title and scope of chapter and for appeals by taxing districts.

HOUSE

**2241** 3290

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in other subjects of taxation, providing for prohibited fees, surcharges and taxes; and making inconsistent repeals. (Representatives MUSTIO, GROVE, DIAMOND and others) - Commerce, September 12, 2018

OVER

This bill amends Title 53 to prohibit fees, surcharges and taxes for food and beverage, and food/beverage containers.

### SECOND CONSIDERATION **CONSUMER AFFAIRS BILL**

**HOUSE 179** 

An Act amending Title 66 (Public Utilities) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in contract carrier by motor vehicle and broker, further providing for declaration of policy and definitions; and, in violations and penalties, further providing for unauthorized operation by carriers and brokers. (Representatives DAY, KNOWLES, D. COSTA and others) - Consumer Affairs, September 26, 2018

OVER

This bill amends Title 66 to increase penalties for unlicensed household goods movers operating in the Commonwealth.

### SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

**SENATE** 652

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in arson, criminal mischief and other property destruction, providing for the offense of critical infrastructure vandalism; and, in burglary and other criminal intrusion, further providing for the offense of criminal trespass. (Senators REGAN, MARTIN, SCARNATI and others) - Environmental Resources & Energy, October 10, 2018

OVER

This bill amends Title 18 to add the offense of a critical infrastructure facility trespasser.

**HOUSE** 332

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives GROVE, BLOOM, NELSON and others) - Finance, September 24, 2018

OVER

This bill provides for classes of income.

**HOUSE 871** 

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, 991 further providing for exemptions and special provisions. TAYLOR, SOLOMON, (Representatives DUNBAR and others) - Finance, October 9, 2018

OVER

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, further providing for exemptions and special provisions.

OVER

The bill amends the Local Tax Enabling Act related to the consolidated collection of local income taxes.

### HOUSE 1105 1315

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in realty transfer tax, further providing for definitions and for exempt parties. (Representatives RYAN, BARRAR, BOBACK and others) – Rules, September 12, 2018

OVER

This bill amends the Tax Reform Code to clarify the realty transfer tax exemption for veteran's organizations.

### HOUSE

1401 2610

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, providing for volumetric severance tax; and making a related repeal. (Representatives DiGIROLAMO, DeLISSIO, MURT and others) - Finance, September 12, 2018 11

OVER

This bill amends the Tax Reform Code to provide a natural gas severance tax.

HOUSE 1406

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, repealing provisions relating to contribution for Korea/Vietnam Memorial National Education Center and further providing for operational provisions. (Representatives COX, PETRARCA, DRISCOLL and others) - Finance. September 13, 2018

OVER

This bill repeals provisions relating to contribution for Korea/Vietnam Memorial National Education Center and further providing for operational provisions.

### SECOND CONSIDERATION FINANCE BILLS

HOUSE 2248 3485

An Act amending the act of April 3, 1992 (P.L.28, No.11), known as the Tuition Account Programs and College Savings Bond Act, in tuition account program, further providing for tuition account programs and funds and establishing the Keystone Scholars Grant Program and the Keystone Scholars Grant Program Account; and making editorial changes. (Representatives MILNE, B. O'NEILL, PEIFER and others) - Finance, September 13, 2018

OVER

This bill provides for tuition account programs and funds and establishing the Keystone Scholars Grant Program and the Keystone Scholars Grant Program Account.

### SECOND CONSIDERATION GAME AND FISHERIES BILL

HOUSE 1603

An Act amending Title 34 (Game) of the Pennsylvania Consolidated Statutes, in hunting and furtaking, further providing for trespass on private property while hunting. (Representatives B. MILLER, ZIMMERMAN, GODSHALL and others) - Game & Fisheries, September 12, 2018

OVER

This bill amends Title 34 to provide that the offense of Trespass while Hunting will be primary offense, and increasing penalties.

### SECOND CONSIDERATION HEALTH BILLS

**358** 

An Act providing for a volunteer health care practitioner certification; and imposing powers and duties on the Department of Health. (Representatives BAKER, PICKETT, MURT and others) - Health, October 1, 2018

OVER

This bill creates the Volunteer Health Care Practitioner Act.

**HOUSE 103** 

2738

An Act prohibiting certain benefit packages for children's health care and medical assistance to include gender or sex reassignment surgery or gender or sex transition services. (Representatives TOPPER, BAKER, BARRAR and others) – Health, October 2, 2018

OVER

This bill creates the Taxpayer-Funded Genera or Sex Reassignment Services Act.

**SENATE** 

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, further 1085 known as the ruman Services code, in page 1085 providing for definitions, for resources and for verification system, prohibiting eligibility for individuals convicted of drug distribution, prohibiting eligibility for violators of sexual offender registration, further providing for false statements, investigations and penalty and for prohibited use of public assistance funds, providing for lost access devices and further providing for violation and penalty. This bill amends the Human Services Code to increase the valuation of a family vehicle, lottery winnings which are attributable as resources, drug kingpin provisions, Megan's Law compliance provisions, changes the grading of welfare fraud, limits the use of an access device and establishes a cost and procedure for the replacement of a lost access device.

OVER

This bill establishes a statewide adult abuse registry within the Department of Human Services.

**SENATE 31** 

An Act amending the act of June 26, 2001 (P.L.755, No.77), known as the Tobacco Settlement Act, in Commonwealth universal 12 research enhancement, establishing the Spinal Cord Injury Research Program and Spinal Cord Research Advisory Committee, further providing for department responsibilities and for use of funds and providing for spinal cord injury research programs funding. (Senators SCAVELLO, TARTAGLIONE, GREENLEAF and others) - Human Services, October 15, 2018

VOTE



This bill provides for department responsibilities and for use of funds and providing for spinal cord injury research programs funding.

JUDICIARY BILLS **HOUSE** An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in protection from abuse, **further providing for relief.** (Representatives READSHAW, KNOWLES and others) - Judiciary, September 24, OVER This bill amends the Protection From Abuse Act to add another type of relief for the plaintiff by allowing the court to order the defendant to refrain from abusing the plaintiff's cat or dog. **HOUSE** An Act amending Title 20 (Decedents, Estates and Fiduciaries) 383 of the Pennsylvania Consolidated Statutes, in ownership of property 386 and legal title and equitable estate, further providing for right to dispose of a decedent's remains. (Representatives READSHAW, OVER BARBIN, KORTZ and others) - Rules, October 1, 2018 This bill amends the Probate, Estates and Fiduciaries Code to provide for "majority rule" in decisions regarding the disposition of a decedent's remains. **HOUSE** An Act amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous articles, further providing for persons not to possess, use, manufacture, control, sell or transfer OVER firearms: in community and municipal courts, further providing for masters; and adding provisions relating to extreme risk protection orders. (Representatives STEPHENS, CHARLTON, KULIK and others) - Rules, September 25, 2018 This bill adds a chapter to the Judicial Code to provide for extreme risk protection orders and makes consistent changes to the Crimes Code. **SENATE** An act amending Title 29 (Federal Relations) of the Pennsylvania 10 Consolidated Statutes, providing for immigration preemption and cooperation. (Senators McGARRIGLE, KILLION, BARTOLOTTA and others) - Judiciary, October 15, 2018 OVER This bill amends the Protection From Abuse Act to provide that a PFA order shall be tolled while a defendant is incarcerated, and then continued for 90 days when the defendant is released. **SENATE** An Act amending Titles 18 (Crimes and Offenses) and 42 VOTE (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in authorized disposition of offenders, further providing for restitution for injuries to person or property; and, in sentencing, further providing for victim impact statements. (Senators STEFANO, BOSCOLA, BROWNE and others) - Judiciary, October 15, 2018 This bill amends Title 18 to make crime victims other than natural persons eligible for restitution. **SENATE** An Act amending Title 42 (Judiciary and Judicial Procedure) VOTEof the Pennsylvania Consolidated Statutes, providing for victim and 2085 witness outreach; and, in post-trial matters, further providing for eligibility for relief and for jurisdiction and proceedings. An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in licensing of drivers, further providing for learner's permits and for driving while operating privilege is suspended or revoked; in miscellaneous provisions, further providing for the offenses of homicide by vehicle, aggravated assault by vehicle while driving under influence, aggravated assault by vehicle while driving under the influence and for accidents involving death or personal injury while not properly licensed; and, in driving after imbibing alcohol or utilizing drugs, further providing for grading. (Senators RAFFERTY, DINNIMAN, MARTIN and others) – Judiciary, October 15, 2018

VOTE



This bill amends various sections in title 75 regarding homicide by vehicle and aggravated assault by vehicle, driving under license suspension and driving under the influence of alcohol or drugs.

SENATE 1092 1710

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, providing for sentencing for offenses involving domestic violence in the presence of a minor. (Senators MENSCH, ARGALL, COSTA and others) – Judiciary, October 15, 2018

VOTE



This bill amends Title 42 to provide a sentence enhancement for a simple assault or aggravated assault committed against a family or household member when the defendant knew the crime was witnessed by a minor who is also a family or household member of the defendant or the victim.

### SECOND CONSIDERATION JUDICIARY BILLS

**SENATE 1127** 

An Act amending Titles 18 (Crimes and Offenses) and 62 (Procurement) of the Pennsylvania Consolidated Statutes, in wiretapping and electronic surveillance, further providing for order authorizing interception of wire, electronic or oral communications; in trade and commerce, further providing for buying or exchanging Federal food order coupons, stamps, authorization cards or access devices and for fraudulent traffic in food orders; and, in source selection and contract formation, further providing for debarment or suspension. (Senators AUMENT, SCHWANK, SCAVELLO and others) – Judiciary, October 15, 2018

VOTE



This bill amends Title 18 and Title 62 in order to create new penalties for trafficking in Supplemental Nutrition Assistance Program benefits.

SENATE **1209** 

An Act amending the act of November 29, 2006 (P.L.1471, No.165), known as the Sexual Assault Testing and Evidence Collection Act, further providing for sexual assault evidence collection program; and requiring the Pennsylvania State Police to complete and submit a report. (Senators LANGERHOLC, RESCHENTHALER, KILLION and others) – Judiciary, October 15, 2018

VOTE



This bill amends the Sexual Assault Testing and Evidence Collection Act regarding timeframes for the submission of sexual assault evidence.

## SECOND CONSIDERATION LABOR & INDUSTRY BILL

HOUSE 2571 3883

An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, in preliminary provisions, further providing for definitions; in employee rights, providing for payments to employee organizations; in scope of bargaining, providing for collection of payments from nonmembers; and making related repeals. (Representatives KLUNK, BLOOM, CORR and others) - Labor & Industry, October 10, 2018

OVER

This bill amends the Public Employe Relations Act to ensure that nonmembers of public-sector unions are aware of their right not to contribute any monies to the representative union.

### SECOND CONSIDERATION LIQUOR CONTROL BILL

HOUSE 1741 2338

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for authority to issue liquor licenses to hotels, restaurants and clubs, for sale of malt or brewed beverages by liquor licensees, for retail dispensers' restrictions on purchases and sales and for premises to be vacated by patrons. (Representatives MARSHALL, MILLARD, MULLERY and others) - Liquor Control, October 2, 2018

OVER

This bill amends Title 47 to allow club license holders to sell six packs to their members.

## SECOND CONSIDERATION LOCAL GOVERNMENT BILLS

HOUSE **641** 

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in assessments of persons and property, providing for senior property tax freeze. (Representatives GROVE, SCHWEYER, JAMES and others) – Local Government, October 11, 2018

OVER

This bill establishes an Optional Senior Property Tax Freeze program.

HOUSE 1142 1365

An Act amending the act of December 18, 1984 (P.L.1005, No.205), known as the Municipal Pension Plan Funding Standard and Recovery Act, in standards for municipal pension systems, further providing for definitions and providing for special procedures for certain professional services contracts. (Representatives BRIGGS AND GODSHALL) - Rules, October 15, 2018

OVER

This bill provides for definitions and providing for special procedures for certain professional services contracts.

**SENATE 403** 

228 f

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in employees, further providing for commission members. (Senators BREWSTER, GREENLEAF, RESCHENTHALER and others) – Local Government, October 15, 2018

OVER


This bill amends Title 53 to remove the FBI from the Municipal Police Officers Education and Training Commission and replaces them with a member of the State FOP.

### SECOND CONSIDERATION PROFESSIONAL LICENSURE BILL

**SENATE** 780

An Act relating to telemedicine; authorizing the regulation of telemedicine by professional licensing boards; and providing for insurance coverage of telemedicine. (Senators VOGEL, YAW, BARTOLOTTA and others) - Professional Licensure, September 26,

VOTE



This bill establishes the Telemedicine Act to specifically authorize health care providers to use telemedicine and require insurers to provide coverage and reimbursement for its use.

### SECOND CONSIDERATION STATE GOVERNMENT BILLS

**HOUSE** 

28

An Act amending Titles 42 (Judiciary and Judicial Procedure) and 53 (Municipalities Generally) of the Pennsylvania Consolidated 2006 Statutes, in matters affecting government units, providing for exceptions to governmental immunity related to unauthorized aliens; and, in preemptions, providing for restriction on municipal regulation of official and employee communications relating to **immigration status.** (Representatives WHITE, PICKETT, A. HARRIS and others) - Rules, September 13, 2018

OVER

This bill amends Titles 42 and 53 define sanctuary municipalities, establish liability for damages, and set reporting requirements for public officials/employees/law enforcement.

**HOUSE** 

466

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in officers serving process and enforcing orders, further providing for powers and duties of the sheriff. (Representatives MARSHALL, DOWLING, A. HARRIS and others) - State Government, June 21, 2018

OVER

This bill would give full police powers to sheriffs and deputy sheriffs.

**HOUSE** 

An Act amending Title 65 (Public Officers) of the Pennsylvania Consolidated Statutes, in open meetings, further providing for public notice and providing for notification of agency business required and exceptions. (Representatives CHRISTIANA, D. COSTA, BARRAR and others) - Rules, October 10, 2018

OVER

This bill amends the Sunshine Act to require increased publication of meeting agendas before public meetings and to preclude agencies from taking official action on matters that the agency does not list on the agenda.

### SECOND CONSIDERATION STATE GOVERNMENT BILLS

HOUSE 1642 3357

An Act providing for an inventory of State-owned assets for the development of mobile broadband services in unserved areas and underserved areas of this Commonwealth. (Representatives PHILLIPS-HILL, SNYDER, BIZZARRO and others) – State Government, June 22, 2018

OVER

This bill directs the Department of General Services to conduct an inventory of existing state owned communications assets.

HOUSE 2105 4066

An Act abolishing numerous State authorities, boards, commissions, committees, councils and representatives; and making related repeals. (Representatives FRITZ, GROVE, BLOOM and others) - State Government, October 9, 2018

OVER

This bill repeals numerous Underutilized or outdated Boards, Councils, and Commissions.

SENATE 353

An Act authorizing the Department of General Services, with the approval of the Governor and the Department of Military and 2088 Veterans Affairs, to grant and convey to the Pennhurst Memorial Preservation Alliance, or its assigns, a certain tract of land with certain improvements on it situate in East Vincent Township, Chester County; authorizing and directing the Department of General Services, with the approval of the Governor, to grant and convey to 812 Market, Inc., or its assigns, certain lands and improvements situate in the City of Harrisburg, Dauphin County; authorizing the Department of Transportation, with the approval of the Governor, to grant and convey to Two Farms Inc., certain lands situate in the Collegeville Borough, Montgomery County; authorizing the Department of General Services, with the approval of the Governor, to grant and convey, at a price to be determined through a competitive bid process, certain lands, buildings and improvements situate in the Borough of Chambersburg, Franklin County; authorizing the Department of General Services, with the approval of the Department of Transportation and the Governor, to grant and convey, at a price to be determined through a competitive bid process, certain lands, buildings and improvements situate partially in the 6th Ward City of Washington and situate partially in South Strabane Township, Washington County; and authorizing the Department of General Services, with the approval of the Pennsylvania Historical and Museum Commission and the Governor, to grant and convey to Jose L. 


