SECOND CONSIDERATION **HEALTH BILLS**

HOUSE An Act amending the act of June 13, 1967 (P.L.31, No.21), 357 known as the Human Services Code, in public assistance, providing for medical assistance deemed eligibility program for home care, home health and older adult daily living services. (Representatives BERNSTINE, RYAN, McNEILL and others) - Health, February 20, 2019

This bill amends the Human Services Code to create a new section for deemed eligibility for home care, home health care and older adult daily living center services.

SECOND CONSIDERATION HEALTH BILLS

An Act providing for certification of central service technicians; imposing continuing education requirements on central service technicians; providing for duties of hospitals and ambulatory surgical facilities and the Department of Health; and regulating the practice of surgical technology and surgical technologists. (Representatives KAUFFMAN, MURT, PYLE and others) - Health, February 20, 2019 1

This bill establishes a freestanding act to provide for the certification of central service technicians and surgical technologists, as administered by the Department of Health.

SECOND CONSIDERATION STATE GOVERNMENT BILL

An Act amending Title 71 (State Government) of the Pennsylvania Consolidated Statutes, in preliminary provisions relating to retirement for State employees and officers, further providing for definitions. (Representatives COX, BARRAR, BERNSTINE and others) - State Government, February 20, 2019 1

This bill prohibits future employees of the Susquehanna River Basin Commission from being members of the State Employees Retirement System.

SECOND CONSIDERATION URBAN AFFAIRS BILL

An Act providing for the establishment of first-time home buyer avings accounts for first-time home buyers in this Commonwealth. (Representatives BROWN, BIZZARRO, A. DAVIS and others) – Urban Affairs, February 20, 2019

This bill creates the Pennsylvania First-Time Home Buyers Savings Account.
