#### SECOND CONSIDERATION CHILDREN AND YOUTH BILLS

**309** 

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in departmental powers and duties as to supervision, providing for Keystone STARS Program participants; and, in departmental powers and duties as to licensing, further providing for fees, providing for Keystone STARS Program participants and further providing for definition. (Representatives MEHAFFIE, SOLOMON, A. DAVIS and others) - Children & Youth, March 12, 2019

OVER

This bill requires child care facilities to publicly display their Keystone STARS rating.

An act amending Title 67 (Public Welfare) of the Pennsylvania Consolidated Statutes, in preliminary provisions, further providing for definitions; in medical assistance hearings and appeals, further providing for definitions; in public welfare generally, providing for adoption opportunities and for family finding and kinship care; establishing the Kinship Care Program and the Subsidized Permanent Legal Custodianship Program; making related repeals; and making editorial changes. (Representatives BOBACK, HOWARD, LONGIETTI and others) - Children & Youth, April 17, 2019

VOTE

This bill re-enacts sections of Act 80 of 2012 which was rules unconstitutional, in order to provide adoption subsidies.

An Act amending the act of July 7, 1980 (P.L.380, No.97), known as the Solid Waste Management Act, in general provisions, further providing for powers and duties of the department. (Representatives MAKO, HAHN, AND FREEMAN) – Environmental Resources & Energy, April 29, 2019

This bill amends the Solid Waste Management Act to require DEP to forward EPA notices of noncompliance to municipalities where the violation has occurred.

An Act providing for the administration of permits by State agencies, for a tracking system for permit applications, for the establishment of permit programs and for annual reports. (Representatives ROTHMAN, RYAN, BERNSTINE and others) - Environmental Resources & Energy, April 29, 2019

This bill reforms the administration of permits in the Commonwealth.

An Act providing for regulatory compliance. (Representatives 812 O'NEAL, KAIL, TOPPER and others) – Environmental Resources & Energy, April 29, 2019

This bill establishes the freestanding State Agency Regulatory Compliance Officer Act.

### SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILLS

**806** 

An Act amending the act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act, further providing for definitions, for proposed regulations and procedures for review and for final-form regulations and final-omitted regulations and procedures for review; providing for regulations deemed withdrawn; further providing for procedures for subsequent review of disapproved final-form or final-omitted regulations by the commission; and providing for concurrent resolution required for economically significant regulations. (Representatives KEEFER, GREINER, GROVE and others) - Environmental Resources & Energy, April 29, 2019

VOTE

This bill amends the Regulatory Review Act to establish a process under which economically significant regulations must be approved by the House and the Senate before they go into effect.

An Act amending the act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act, further providing for definitions and for existing regulations; and establishing the Independent Office of the Repealer and providing for its power and duties. (Representatives KLUNK, RYAN, PICKETT and others) - Environmental Resources & Energy, April 29, 2019



This bill establishes and Office of the Repealer.

#### SECOND CONSIDERATION HEALTH BILL

HOUSE 427 1089

An Act providing for health insurance coverage requirements for stage four, advanced metastatic cancer. (Representatives BENNINGHOFF, BARRAR, BERNSTINE and others) – Health, April 8, 2019

OVER

This bill is a freestanding act which addresses treatment of stage four, advanced metastatic cancer.

### SECOND CONSIDERATION LABOR & INDUSTRY BILL

**HOUSE 785** 

An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, further providing for definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) - Labor & Industry, March 20, 2019

OVER

This bill amends the Public Employe Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.

#### SECOND CONSIDERATION TRANSPORTATION BILL

**HOUSE 374** 

An Act amending Titles 27 (Environmental Resources) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, providing for Keystone Tree Fund; and, in registration of vehicles, providing for contributions to the Keystone Tree Fund. (Representatives EVERETT, SOLOMON, PASHINSKI and others) - Transportation, April 17, 2019

**OVER** 


This bill amends Title 27 & 75 to provide for Keystone Tree Fund.
