An Act providing appropriations from the General Fund for the expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, the public debt and the public schools for the fiscal year July 1, 2019, to June 30, 2020, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2019; providing appropriations from special funds and accounts to the Executive and Judicial Departments for the fiscal year July 1, 2019, to June 30, 2020, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2019; and providing for the appropriation of Federal funds to the Executive and Judicial Departments for the fiscal year July 1, 2019, to June 30, 2020, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2019. 

(Representatives MEHAFFIE, SOLOMON, A. DAVIS and others) - Children & Youth, April 30, 2019


This bill requires child care facilities to publicly display their Keystone STARS rating.

#### SECOND CONSIDERATION EDUCATION BILLS

An Act amending the act of March 10, 1949 (P.L.30, No.14), hown as the Public School Code of 1949, in educational tax credits, further providing for definitions and for limitations. (Representatives TURZAI, MILLARD, REESE and others) - Education, May 1, 2019



This bill provides for the expansion of the Educational Improvement Tax Credit Program.





This bill would update outdated terminology in the School Code.


#### SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

HOUSE 247 999 An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, in development, further providing for well permits. (Representatives OBERLANDER, FRITZ, JAMES and others) - Environmental Resources & Energy, March 25, 2019 12

This bill amends Title 58 to provide for cross unit drilling.

HOUSE 332 310 An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in jurisdiction of appellate courts, providing for commerce court program; and, in organization and jurisdiction of courts of common pleas, providing for commerce courts. (Representatives GROVE, PICKETT, KAUFFMAN and others) – Judiciary, May 1, 2019 1



This bill provides for commerce court program and in organization and jurisdiction of courts of common pleas, providing for commerce courts.

#### SECOND CONSIDERATION LABOR & INDUSTRY BILL


HOUSE 785 An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, further providing for 856 definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) - Labor & Industry, March 20, 2019 13

This bill amends the Public Employe Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.



This bill provides for governing bodies of airport authorities located in counties of the second class.

#### **SECOND CONSIDERATION STATE GOVERNMENT BILLS**
