An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in size, weight and load, further providing for permit for movement during course of manufacture; and, in powers of department and local authorities, further providing for power of Governor during emergency. (Representatives CAUSER, PASHINSKI, BARRAR and others) - Agriculture & Rural Affairs, May 6, 2019

This bill provides for milk hauling during a declared disaster emergency.


SECOND CONSIDERATION CHILDREN AND YOUTH BILL

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in departmental powers and duties as to supervision, providing for Keystone STARS Program participants; and, in departmental powers and duties as to licensing, further providing for fees, providing for Keystone STARS Program participants and further providing for definition. (Representatives MEHAFFIE, SOLOMON, A. DAVIS and others) - Children & Youth, April 30, 2019 3

This bill requires child care facilities to publicly display their Keystone STARS rating.

HOUSE 427 1089 An Act providing for health insurance coverage requirements for stage four, advanced metastatic cancer. (Representatives BENNINGHOFF, BARRAR, BERNSTINE and others) - Health, April 8, 2019 10

This bill is a freestanding act which addresses treatment of stage four, advanced metastatic cancer.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON, SIMS and others) - Judiciary, May 06, 2019 1

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

> A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, organizing the Judiciary into representative districts and further providing for residency requirements. (Representatives DIAMOND, BERNSTINE, CAUSER and others) – Judiciary, May 06, 2019 1

This bill is a Joint Resolution proposing an amendment to the PA Constitution that creates regional districts from which Supreme Court justices, Superior Court and Commonwealth Court judges would be elected.





SECOND CONSIDERATION JUDICIARY BILLS



An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in matters affecting government units, providing for special standing in constitutional challenges. (Representatives ECKER, SCHEMEL, DIAMOND and others) – Judiciary, May 06, 2019



This bill amends Title 42 to allow either or both chambers of the General Assembly to intervene as a party in a judicial proceeding where a statute is alleged to be unconstitutional.

SECOND CONSIDERATION LABOR & INDUSTRY BILL

HOUSE 785 856 An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, further providing for definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) - Labor & Industry, March 20, 2019 14

This bill amends the Public Employe Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.




An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in municipal authorities, providing for governing bodies of airport authorities located in counties of the second class. (Representatives TURZAI, HENNESSEY, RYAN and others) – Local Government, May 1, 2019 2

This bill provides for governing bodies of airport authorities located in counties of the second class.

(Representatives EVERETT, SOLOMON, PASHINSKI and others) – Transportation, April 17, 2019 5

This bill amends Title 27 & 75 to provide for Keystone Tree Fund.

627 An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in miscellaneous provisions, further providing for odometer disclosure requirements. (Representatives ROTHMAN, RYAN, BERNSTINE and others) – Transportation, May 1, 2019 2

This bill provides for odometer disclosure requirements.

An Act repealing the act of July 16, 1941 (P.L.386, No.149), entitled "An act providing for the establishment, construction, 1224 operation and maintenance of a mountain ridge road or parkway in the Pocono Mountains through, bordering or accessible to the counties of Monroe, Northampton, Carbon, Luzerne, Lackawanna, Wayne and Pike, to be known as the "Pocono Mountain Memorial Parkway"; providing for the creation of the Pennsylvania Parkway Commission, and conferring powers, and imposing duties on said commission; authorizing the issuance of parkway revenue bonds of the Commonwealth, payable solely from tolls, to pay the cost of such parkway; providing that no debt of the Commonwealth shall be incurred in the exercise of any of the powers granted by this act; providing for the collection of tolls for the payment of such bonds and for the cost of maintenance, operation and repair of the parkway; making such bonds exempt from taxation; constituting such bonds legal investments in certain instances; prescribing

This bill provides for the establishment, construction, operation and maintenance of a mountain ridge road or parkway in the Pocono Mountains through, bordering or accessible to the counties of Monroe, Northampton, Carbon, Luzerne, Lackawanna, Wayne and Pike, to be known as the "Pocono Mountain Memorial Parkway."
