SECOND CONSIDERATION CHILDREN AND YOUTH BILL

309

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in departmental powers and duties as to supervision, providing for Keystone STARS Program participants; and, in departmental powers and duties as to licensing, further providing for fees, providing for Keystone STARS Program participants and further providing for definition. (Representatives MEHAFFIE, SOLOMON, A. DAVIS and others) - Children & Youth, April 30, 2019

OVER

This bill requires child care facilities to publicly display their Keystone STARS rating.

SECOND CONSIDERATION EDUCATION BILLS

HOUSE 239

An Act amending the act of June 27, 1991 (P.L.70, No.10), entitled "An act requiring the superintendent of every public school district to make available, upon request, lists of graduating seniors to armed forces recruiters; and providing a penalty for the misuse of any such lists," further providing for title and for legislative intent; providing for short title and for definitions; and further providing for list of seniors to be compiled, for optional compliance by nonpublic schools and for reimbursement of costs. (Representatives READSHAW, MURT, JAMES and others) - Education, May 13, 2019

OVER

This bill provides for list of seniors to be compiled, for optional compliance by nonpublic schools and for reimbursement of costs.

SECOND CONSIDERATION EDUCATION BILLS

HOUSE 355

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, providing for advertising; and, in charter schools, further providing for definitions, for charter school requirements, for powers of board of trustees and for fund balance limits. (Representatives REESE, DOWLING, MARSHALL and others) – Education, June 11, 2019

C VOTE

This bill provides to increase ethical and transparency requirements for charter schools.

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in charter schools, further providing for charter school requirements, for facilities and for school district and intermediate unit responsibilities. (Representatives DOWLING, REESE, TOPPER and others) - Education, June 11, 2019



This bill updates charter school facility provisions.

HOUSE **357**

1746

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in pupils and attendance, providing for transfer of attendance records to another school entity or nonpublic school; in charter schools, further providing for establishment of charter school, for contents of application and for term and form of charter, providing for amendments and further providing for enrollment, for cyber charter school requirements and prohibitions and for establishment of cyber charter school. (Representatives TOPPER, DOWLING, HICKERNELL and others) - Education, June 11, 2019



This bill creates uniform processes and procedures for charter schools.

HOUSE **358**

174

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in terms and courses of study, further providing for agreements with institutions of higher education; and, in opportunities for educational excellence, further providing for definitions, for responsibilities of school entities and for concurrent enrollment agreements. (Representatives MARSHALL, REESE, TOPPER and others) – Education, June 11, 2019



This bill permits dual enrollment for charter school students.

SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

HOUSE **247**

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, in development, further providing for well permits. (Representatives OBERLANDER, FRITZ, JAMES and others) - Environmental Resources & Energy, May 13, 2019

OVER

This bill amends Title 58 to provide for cross unit drilling.

SECOND CONSIDERATION FINANCE BILL

SENATE 613

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in administrative organization, repealing provisions relating to employees with access to Federal tax information and providing for criminal history background checks of employees and contractors with access to Federal tax information. (Senator MENSCH) - Finance, June 11, 2019

VOTE

This bill amends the Administrative Code to comply with criminal background requirements with IRS.

SECOND CONSIDERATION HEALTH BILL

HOUSE 427

An Act providing for health insurance coverage requirements for stage four, advanced metastatic cancer. (Representatives 1089 BENNINGHOFF, BARRAR, BERNSTINE and others) - Health, May 22, 2019

OVER

This bill is a freestanding act which addresses treatment of stage four, advanced metastatic cancer.

SECOND CONSIDERATION JUDICIARY BILL

HOUSE

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and 1630 adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON. SIMS and others) - Judiciary, May 06, 2019 13

OVER

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

SECOND CONSIDERATION LABOR & INDUSTRY BILL

785

An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, further providing for definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) - Labor & Industry, May 8, 2019 11

OVER

This bill amends the Public Employe Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.

SECOND CONSIDERATION LOCAL GOVERNMENT BILL

HOUSE 1074

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in municipal authorities, providing for governing bodies of airport authorities located in counties of the second class. (Representatives TURZAI, HENNESSEY, RYAN and others) - Local Government, May 1, 2019

OVER

This bill provides for governing bodies of airport authorities located in counties of the second class.

SECOND CONSIDERATION TOURISM AND RECREATIONAL DEV. BILL

HOUSE 448

An Act amending the act of June 12, 2018 (P.L.136, No.28), known as the Pennsylvania Commission for the United States Semiquincentennial Act, further providing for composition. (Representatives KAUFER, SOLOMON, MILLARD and others) - Tourism & Recreational Development, June 11, 2019 1

WOIE

This bill adds the Director of the PA Emergency Management Agency and the Commissioner of the PA State Police to the PA Commission for the U.S. Semiquincentennial.

THIRD CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILL

HOUSE 1037

An Act amending the act of November 10, 1999 (P.L.491, No.45), known as the Pennsylvania Construction Code Act, in preliminary provisions, further providing for definitions and for application; and, in exemptions, applicability and penalties, further providing for penalties. (Representatives LAWRENCE, CAUSER, BERNSTINE and others) - Appropriations, May 15, 2019 Fiscal-Note Attached

OVER

This bill amends the PA Construction Code Act to exempt historic agricultural buildings, when used for private events and meeting certain safety provisions, from the provisions of the code.

THIRD CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

827

An Act designating certain activity by the Delaware River Basin Commission as the exercise of the power of eminent domain that entitles the owners of the property in question to appropriate and just compensation. (Representatives FRITZ, JAMES, PICKETT and others) – Appropriations, May 14, 2019 Fiscal-Note Attached 9

OVER

This bill designates certain activity by the Delaware River Basin Commission as the exercise of the power of eminent domain that entitles the owners of the property in question to appropriate and just compensation.

THIRD CONSIDERATION HEALTH BILL

HOUSE 1005 2022

An Act amending the act of October 27, 2014 (P.L.2911, No.191), known as the Achieving Better Care by Monitoring All Prescriptions Program (ABC-MAP) Act, further providing for purpose, for definitions, for powers and duties of board and for establishment of program and providing for requirements for first responder agencies and hospital emergency departments and for requirements for coroners and medical examiners. (Representatives COX, BERNSTINE, BROWN and others) – Appropriations, June 10, 2019 Fiscal-Note Attached

OVER

This bill amends the Achieving Better Care by Monitoring All Prescriptions Program Act to include the administration of naloxone in apatient's record on the ABC-MAP databasde.
