

#### SECOND CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILLS

HOUSE 1518 2015


An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, providing for grant programs; and making a related repeal. (Representatives DeLISSIO, CAUSER, PASHINSKI and others) - Rules, June 12, 2019



This bill provides for Agriculture and Youth Development Grants.

HOUSE 1519 1914

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, providing for Commonwealth Specialty Crop Block Grant Program. (Representatives RABB, CAUSER, PASHINSKI and others) – Rules, June 12, 2019



This bill provides for State-level Specialty Crop Block Grants.

HOUSE 1520

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, providing for grant programs. (Representatives SNYDER, CAUSER, PASHINSKI and others) - Rules, June 12, 2019




This bill creates a grant program for small or new meat processors.

### SECOND CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILLS

HOUSE 1521 2016

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, in Pennsylvania Preferred Trademark, providing for military veterans; and making editorial changes. (Representatives PASHINSKI, CAUSER, BERNSTINE and others) - Rules, June 12, 2019



This bill provides for participation in a PA Preferred Homegrown by Heroes Program.

#### SECOND CONSIDERATION CHILDREN AND YOUTH BILLS

**309** 

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in departmental powers and duties as to supervision, providing for Keystone STARS Program participants; and, in departmental powers and duties as to licensing, further providing for fees, providing for Keystone STARS Program participants and further providing for definition. (Representatives MEHAFFIE, SOLOMON, A. DAVIS and others) - Children & Youth, June 12, 2019

OVER

This bill requires child care facilities to publicly display their Keystone STARS rating.

#### SECOND CONSIDERATION EDUCATION BILL

An Act amending the act of June 27, 1991 (P.L.70, No.10), entitled "An act requiring the superintendent of every public school district to make available, upon request, lists of graduating seniors to armed forces recruiters; and providing a penalty for the misuse of any such lists," further providing for title and for legislative intent; providing for short title and for definitions; and further providing for list of seniors to be compiled, for optional compliance by nonpublic schools and for reimbursement of costs. (Representatives READSHAW, MURT, JAMES and others) - Education, May 13, 2019

**OVER** 

This bill provides for list of seniors to be compiled, for optional compliance by nonpublic schools and for reimbursement of costs.

## SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, in development, further providing for well permits. (Representatives OBERLANDER, FRITZ, JAMES and others) - Environmental Resources & Energy, May 13, 2019 12

**OVER** 

This bill amends Title 58 to provide for cross unit drilling.

#### SECOND CONSIDERATION FINANCE BILL

**SENATE 478** 

An Act amending the act of March 4, 1971 (P.L.6, No.2), known

942 as the Tax Reform Code of 1971, providing for beginning farmer
tax credit. (Senators VOGEL, J. WARD, STREET and
others) - Finance, June 17, 2019

VOTE

This bill amends the Tax Reform Code to establish the Beginning Farmer Management Tax Credit.

#### SECOND CONSIDERATION HEALTH BILL

**HOUSE 427** 

An Act providing for health insurance coverage requirements for stage four, advanced metastatic cancer. (Representatives BENNINGHOFF, BARRAR, BERNSTINE and others) - Health, May 22, 2019

OVER

This bill is a freestanding act which addresses treatment of stage four, advanced metastatic cancer.

#### SECOND CONSIDERATION JUDICIARY BILL

HOUSE

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON, SIMS and others) – Judiciary, May 06, 2019

**OVER** 

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

#### SECOND CONSIDERATION LABOR & INDUSTRY BILLS

**HOUSE 785** 

An Act amending the act of July 23, 1970 (P.L.563, No.195), 856 known as the Public Employe Relations Act, further providing for definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) - Labor & Industry, May 8, 2019

OVER

This bill amends the Public Employe Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.

**HOUSE** 

**1537** 

An Act amending the act of December 5, 1936 (2nd Sp.Sess., 1937 P.L.2897, No.1), known as the Unemployment Compensation 1936 Law, in contributions by employers and employees, further providing for contributions by employees. (Representatives HARKINS, COX, SCHLOSSBERG and others) - Rules, June 12, 2019

OVER

This bill amends the Unemployment Compensation Law to provide additional flexibility for the scheduled drawdown of dollars allocated for the Benefit Modernization project.

#### **SECOND CONSIDERATION** LOCAL GOVERNMENT BILL

**HOUSE** 

An Act amending the act of July 10, 1990 (P.L.404, No.98), known as the Real Estate Appraisers Certification Act, further providing for definitions and for State Board of Certified Real Estate Appraisers. (Representatives JAMES, MOUL, EVERETT and others) - Local Government, June 17, 2019 1

VOTE

This bill adds two Certified Pennsylvania Evaluators to the State Board of Certified Real Estate Appraisers.

**HOUSE** 

1033

An Act amending the act of April 16, 1992 (P.L.155, No.28), known as the Assessors Certification Act, further providing for definitions and for duties of board; repealing provisions relating to qualifications; further providing for certification; providing for employees of political subdivisions; and further providing for disciplinary and correction measures and for unlawful practice. (Representatives MOUL, JAMES, EVERETT and others) - Local Government, June 17, 2019

VOTE

This bill amends the Assessors Certification Act to improve the training of revaluation company employees and Certified Pennsylvania Evaluators.

# SECOND CONSIDERATION LOCAL GOVERNMENT BILL

HOUSE 1034 1206

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in consolidated county assessment, further providing for definitions, for changes in assessed valuation and for abstracts of building and demolition permits to be forwarded to the county assessment office. (Representatives EVERETT, JAMES, MOUL and others) - Local Government, June 17, 2019

VOTE

This bill amends the Consolidated County Assessment Act to clarify the procedure for counties to receive copies of building permits.

HOUSE 1035

An Act amending the act of October 27, 1979 (P.L.241, No.78), entitled "An act authorizing political subdivisions, municipality authorities and transportation authorities to enter into contracts for the purchase of goods and the sale of real and personal property where no bids are received," further providing for title of the act; adding a short title; and providing for contracts for services. (Representatives SAPPEY, JAMES, MOUL and others) - Local Government, June 17, 2019



This bill clarifies the procedure that allows municipalities to award contracts after failing to receive a bid.

HOUSE 1036 1208

An Act amending Title 8 (Boroughs and Incorporated Towns) of the Pennsylvania Consolidated Statutes, in elections of officers, further providing for decrease in number of members of council. (Representatives MOUL, JAMES, EVERETT and others) - Local Government, June 17, 2019



This bill amends the Borough Code to change the procedure to shrink the size of council.

HOUSE 1074 1614

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in municipal authorities, providing for governing bodies of airport authorities located in counties of the second class. (Representatives TURZAI, HENNESSEY, RYAN and others) – Local Government, June 17, 2019

OVER

This bill provides for governing bodies of airport authorities located in counties of the second class.

#### SECOND CONSIDERATION STATE GOVERNMENT BILLS

HOUSE 1379

An Act repealing the act of June 22, 1935 (P.L.446, No.187), referred to as the Sunday Polo Act. (Representatives RIGBY, SCHMITT, POLINCHOCK and others) - State Government, June 17, 2019

C)

This bill repeals Act 187 of 1935 known, as the Sunday Polo Act.

HOUSE 1405 1725

An Act repealing the act of June 22, 1935 (P.L.449, No.188), referred to as the Sunday Tennis Act. (Representatives HERSHEY, BERNSTINE, GLEIM and others) - State Government, June 17, 2019

VOTE

This bill repeals Act 188 of 1935, known as the Sunday Tennis Act.

# SECOND CONSIDERATION TRANSPORTATION BILL

SENATE 338

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in size, weight and load, further providing for width of vehicles. (Senators LANGERHOLC, J. WARD, MARTIN and others) – Transportation, June 17, 2019

VOLE



This bill provides to increase the maximum width for implements of husbandry to travel on roadways to 18 feet.

### THIRD CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILL

**HOUSE 1037** 

An Act amending the act of November 10, 1999 (P.L.491, No.45), known as the Pennsylvania Construction Code Act, in preliminary provisions, further providing for definitions and for application; and, in exemptions, applicability and penalties, further providing for penalties. (Representatives LAWRENCE, CAUSER, BERNSTINE and others) - Appropriations, May 15, 2019 Fiscal-Note Attached

OVER

This bill amends the PA Construction Code Act to exempt historic agricultural buildings, when used for private events and meeting certain safety provisions, from the provisions of the code.

### THIRD CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

**HOUSE 827** 

An Act designating certain activity by the Delaware River Basin

Commission as the exercise of the power of eminent domain that
entitles the owners of the property in question to appropriate and
just compensation. (Representatives FRITZ, JAMES, PICKETT and
others) - Appropriations, May 14, 2019 Fiscal-Note
Attached

**OVER** 

This bill designates certain activity by the Delaware River Basin Commission as the exercise of the power of eminent domain that entitles the owners of the property in question to appropriate and just compensation.

#### THIRD CONSIDERATION HEALTH BILL

HOUSE 1005 2022

An Act amending the act of October 27, 2014 (P.L.2911, No.191), known as the Achieving Better Care by Monitoring All Prescriptions Program (ABC-MAP) Act, further providing for purpose, for definitions, for powers and duties of board and for establishment of program and providing for requirements for first responder agencies and hospital emergency departments and for requirements for coroners and medical examiners. (Representatives COX, BERNSTINE, BROWN and others) – Appropriations, June 10, 2019 Fiscal-Note Attached

**OVER** 

This bill amends the Achieving Better Care by Monitoring All Prescriptions Program Act to include the administration of naloxone in apatient's record on the ABC-MAP databasde.

# THIRD CONSIDERATION INSURANCE BILL

HOUSE 1283

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in judgments and other liens, further providing for exemption of particular property. (Representatives MOUL, PICKETT, RYAN and others) – Appropriations, June 03, 2019 Fiscal-Note Attached 7

OVER

This bill amends Title 40 and Title 42 to provide consumer protections for annuity benefit plans.
