An Act providing for the capital budget for the fiscal year 985 2019-2020. (Senator HUGHES) - Appropriations, November 21, 2019

An Act providing for the capital budget for fiscal year 2019-2020; itemizing public improvement projects, furniture and equipment projects, transportation assistance, redevelopment assistance projects, flood control projects, Pennsylvania Fish and Boat Commission projects and Manufacturing Fund projects leased or assisted by the Department of General Services and other State agencies, together with their estimated financial costs; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects to be constructed, acquired or assisted by the Department of General Services and other State agencies; authorizing the use of current revenue for the purpose of financing the projects to be constructed, acquired or assisted of by the Department of General Services and other State agencies stating the estimated useful life of the projects; restricting use of funds on and making appropriations. projects: BROWNE) - Appropriations, November 21, 2019

An Act amending the act of June 18, 1982 (P.L.549, No.159), entitled "An act providing for the administration of certain 1434 Commonwealth farmland within the Department of Agriculture," further providing for agricultural land conservation assistance grant program. (Representatives FEE, RYAN, BERNSTINE others) - Agriculture & Rural Affairs, November 20, 2019

OVER

This bill provides for the administration of certain Commonwealth farmland within the Department of Agriculture," further providing for agricultural land conservation assistance grant program.

#### **SECOND CONSIDERATION CHILDREN AND YOUTH BILLS**

HOUSE 309

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in departmental powers and duties as to supervision, providing for Keystone STARS Program participants; and, in departmental powers and duties as to licensing, further providing for fees, providing for Keystone STARS Program participants and further providing for definition. (Representatives MEHAFFIE, SOLOMON, A. DAVIS and others) - Children & Youth,

OVER

This bill requires child care facilities to publicly display their Keystone STARS rating.

**HOUSE** 

1290

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, 2818 further providing for definitions, for reporting procedure, for disposition of complaints received, for responsibility for investigation, for access to information in Statewide database, for information in Statewide database and for release of information in confidential reports. (Representatives POLINCHOCK, BOBACK, CIRESI and others) - Children & Youth, November 21, 2019

VOTE

This bill amends Title 23 in Child Protective Services/Military Families.

**HOUSE** 

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, 2185 further providing for employees having contact with children; adoptive and foster parents. (Representative BOBACK) - Rules, October 29, 2019

OVER

This bill amends the Child Protective Services Law to provide for additional background check requirements and to restrict provisional employment arrangements.

#### SECOND CONSIDERATION **EDUCATION BILLS**

HOUSE 434

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in certification of 2743 teachers, providing for a cultural competence continuing professional development course; and, in terms and courses of study, further providing for Holocaust, genocide and human rights violations instruction. (Representatives SOLOMON, GROVE, T. DAVIS and others) - Education, October 28, 2019

OVER

This bill amends the Public School Code to require the Department of Education to develop and implement a continuing professional education course on cultural awareness.

**HOUSE** 1800

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school district financial 2886 recovery, providing for duties of receivers in certain districts. (Representatives TURZAI. ROTHMAN. REESE and others) - Education, November 20, 2019 2

OVER

This bill amends the Public School Code to provide for a program of tuition grants for certain school districts in receivership.

HOUSE

1881

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school security, further 2616 providing for school police officers powers and duties. (Representatives KAUFFMAN, STEPHENS, SNYDER and others) - Education, October 28, 2019 7

OVER

This bill amends the Public School Code to permit school police officers employed by a school district to exercise arrest powers if authorized by a court.

#### **SECOND CONSIDERATION** ENVIRONMENTAL RESOURCES AND ENERGY BILL

HOUSE **247** 

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, in development, further providing for well permits. (Representatives OBERLANDER, FRITZ, JAMES and others) - Environmental Resources & Energy, October 2019

OVER

This bill amends Title 58 to provide for cross unit drilling.

#### SECOND CONSIDERATION HEALTH BILL

SENATE **841** 1307

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, providing for the Health Care Cost Containment Council, for its powers and duties, for health care cost containment through the collection and dissemination of data, for public accountability of health care costs and for health care for the indigent. (Senators MARTIN, GORDNER, YAW and others) - Health, November 21, 2019

CO VOTE

This bill reauthorizes and modernizes the PA Health Cost Containment Council.

#### SECOND CONSIDERATION INSURANCE BILL

1862 2795

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, providing for protections for consumers receiving surprise balance bills for health care services from out-of-network providers. (Representatives PICKETT, DeLUCA, BROWN and others) – Insurance, October 30, 2019

OVER

This bill provides for protections for consumers receiving surprise balance bills from health care services from out-of-network providers.

#### SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 1111

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON, SIMS and others) - Judiciary, October 22, 2019

**OVER** 

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

**HOUSE 137** 

An Act amending the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, further providing for drug overdose response immunity. (Representatives QUINN, McNEILL, COX and others) - Judiciary, November 21, 2019

(C)

This bill amends Section 13.7 of the Controlled Substance, Drug, Device, and Cosmetic Act to provide that immunity shall apply to any individual who experiences an overdoes event only if the individual obtains a screening and referral for treatment.

### SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 616 2760

An Act amending the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, further providing for schedules of controlled substances. (Representatives OWLETT, PICKETT, RYAN and others) – Judiciary, November 21, 2019



This bill places the drug carfentanil, a fentanyl analogue, in Schedule II of the Controlled Substances, Drug, Device and Cosmetic Act.

HOUSE **1879** 

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, further providing for the offense of aggravated assault. (Representatives GILLESPIE, ULLMAN, MILLARD and others) – Judiciary, November 21, 2019



This bill amends the aggravated assault statute in order to add "a health care practitioner or technician".

### SECOND CONSIDERATION LABOR & INDUSTRY BILL

**HOUSE 785** 

An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, further providing for definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) - Labor & Industry, October 28, 2019

OVER

This bill amends the Public Employe Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.

## SECOND CONSIDERATION LOCAL GOVERNMENT BILLS

HOUSE 1074

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in municipal authorities, providing for governing bodies of airport authorities located in counties of the second class. (Representatives TURZAI, HENNESSEY, RYAN and others) – Local Government, October 21, 2019 10

OVER

This bill provides for governing bodies of airport authorities located in counties of the second class.

#### **SECOND CONSIDERATION LOCAL GOVERNMENT BILLS**

**HOUSE** 1750

An Act amending the act of June 24, 1931 (P.L.1206, No.331), known as The First Class Township Code, in general provisions relating to township officers, further providing for membership of associations and expenses of members. (Representatives THOMAS, DUNBAR, LONGIETTI and others) - Local Government, November 21, 2019

This bill authorizes First Class Townships to send newly elected commissioners to training prior to swearing in.

**HOUSE** 

An Act amending Titles 8 (Boroughs and Incorporated Towns) and 11 (Cities) of the Pennsylvania Consolidated Statutes, in associations and organizations relating to boroughs, further providing for authorization and expenses; and, in city officers and employees relating to third class cities, further providing for Pennsylvania Municipal League and other municipal affairs organizations. (Representatives THOMAS, DUNBAR, FREEMAN and others) - Local Government, November 21, 2019

VOTE

This bill authorizes Boroughs and Third Class Cities to send newly elected officials to training prior to swearing in.

**SENATE** 316

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, in township supervisors, 295 further providing for duties of supervisors. (Senators GORDNER, ALLOWAY, YUDICHAK and others) - Local Government, November 20, 2019



This bill authorizes Second Class Townships to send newly elected supervisors to training prior to swearing in.

#### **SECOND CONSIDERATION** STATE GOVERNMENT BILL

HOUSE

An Act amending the act of February 14, 2008 (P.L.6, No.3), known as the Right-to-Know Law, in preliminary provisions, further 1736 providing for definitions; in procedure, further providing for written requests; and, in judicial review, further providing for fee limitations. (Representatives SIMMONS, NEILSON, IRVIN and others) - State Government, October 28, 2019

OVER

This bill provides for written requests and further provides for fee limitations.

#### SECOND CONSIDERATION TRANSPORTATION BILLS

**HOUSE** 

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for 2058 definitions; in licensing of drivers, further providing for learners' permits; in rules of the road in general, repealing provisions relating to prohibiting text-based communications, prohibiting use of interactive wireless communications devices, imposing penalties and establishing the Distracted Driver Awareness Fund; and, in operation of vehicles miscellaneous provisions, further providing for the offense of homicide by vehicle and for the offense of aggravated assault by vehicle. (Representatives BROWN, READSHAW, STEPHENS and others) - Rules, September 19, 2019

OVER

This bill prohibits the use of hand-held interactive wireless communication devices while operating a motor vehicle.

**HOUSE** 

**1597** 

An Act designating the highway interchange of U.S. Route 222 with Mohns Hill Road, Cumru Township, Berks County, as the PVT 2056 Mahlon L. Fink Iwo Jima Memorial Highway Interchange. (Representatives GILLEN, NEILSON, **DONATUCCI** and others) - Transportation, October 30, 2019



This bill designates the highway interchange of U.S. Route 222 with Mohns Hill Road in Berks county as the PVT Mahlon L. Fink Iwo Jima Memorial Highway Interchange.

**HOUSE** 

1754

An Act designating a bridge on that portion of State Route 4021 over the Honeove Creek, Sharon Township, Potter County, as the 2345 Tec 5 C. Virgil Voorhees Memorial Bridge. (Representatives CAUSER, BURNS, CALTAGIRONE and others) - Transportation, October 30, 2019

OVER

This bill designates a bridge on a portion of S.R. 4021 in Potter County as the Tec 5 C. Virgil Voorhees Memorial Bridge.

**HOUSE** 

An Act designating a bridge on that portion of Pennsylvania Route 286 over Crooked Creek, Rayne Township, Indiana County, as the SFC Randy McCaulley Memorial Bridge. (Representatives DUSH, SCHMITT, HENNESSEY and others) - Transportation, October 30, 2019




This bill designates a bridge on a portion of S.R. 286 in Indiana County as the SFC Randy McCaulley Memorial Bridge.

#### SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE 1782 2739

An Act designating a bridge on that portion of State Route 1002, also known as Friend Lea Road, over U.S. Route 219 in Cambria Township, Cambria County, as the PFC Cyril T. Yeckley Memorial Bridge. (Representatives BURNS, BIZZARRO, COX and others) - Transportation, October 30, 2019



This bill designates a bridge on a portion of S.R. 1002 in Cambria County as the PFC Cyril T. Yeckley Memorial Bridge.

#### SECOND CONSIDERATION URBAN AFFAIRS BILL

HOUSE **122** 

An Act amending Title 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in home inspections, further providing for home inspection reports. (Representatives KORTZ, HELM, READSHAW and others) – Urban Affairs, September 23, 2019

**OVER** 

This bill provides for home inspection reports.

#### SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

**HOUSE 432** 

3<mark>2</mark> 2568 An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in interpretation and definitions, further providing for definitions; and, in liability and compensation, further providing for compensation for post-traumatic stress injury. (Representatives BARRAR, SAINATO, BIZZARRO and others) - Veterans Affairs & Emergency Preparedness, October 23, 2019

OVER

This bill requires post-traumatic stress injuries to be compensable under workers compensation for first responders, including 911 center dispatchers and call takers, and corrections officers.

HOUSE

2508

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in emergency management services, providing for emergency response payment. (Representatives DUSH, JOZWIAK, GREINER and others) - Veterans Affairs & Emergency Preparedness, October 23, 2019

OVER

This bill authorizes Volunteer Fire Departments to bill for real and reasonable costs.

### SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

HOUSE 1347

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in casualty insurance, further providing for billing. (Representatives MASSER, WHEELAND, IRVIN and others) – Veterans Affairs & Emergency Preparedness, October 23, 2019

**OVER** 

This bill requires insurance carriers to reimburse ambulance companies directly that are not in the insurance carrier's network.

### THIRD CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILL

HOUSE 1037

An Act amending the act of November 10, 1999 (P.L.491, No.45), known as the Pennsylvania Construction Code Act, in preliminary provisions, further providing for definitions and for application; and, in exemptions, applicability and penalties, further providing for penalties. (Representatives LAWRENCE, CAUSER, BERNSTINE and others) – Appropriations, November 18, 2019 Fiscal-Note Attached

**OVER** 

This bill amends the PA Construction Code Act to exempt historic agricultural buildings, when used for private events and meeting certain safety provisions, from the provisions of the code.

An Act amending Title 42 (Judiciary and Judicial Procedure)

OVER

This bill amends Title 40 and Title 42 to provide consumer protections for annuity benefit plans.

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, organizing the 168 Judiciary into representative districts and further providing for residency requirements. OVER

This bill proposes integrated amendments to the Constitution of the Commonwealth of Pennsylvania, organizing the Judiciary into representative districts and further providing for residency requirements.

This bill provides for the definitions of "injury," "personal injury" and "injury arising in the course of his employment," providing for diseases with long latency periods between occupational exposure and manifestation of the disease.




