SECOND CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILLS

HOUSE 881

An Act amending the act of June 18, 1982 (P.L.549, No.159), entitled "An act providing for the administration of certain Commonwealth farmland within the Department of Agriculture," further providing for agricultural land conservation assistance grant program. (Representatives FEE, RYAN, BERNSTINE and others) - Agriculture & Rural Affairs, November 20, 2019

OVER

This bill provides for the administration of certain Commonwealth farmland within the Department of Agriculture," further providing for agricultural land conservation assistance grant program.

HOUSE

918 2778

An Act repealing the act of May 20, 1857 (P.L.617, No.658), entitled "An act making an Appropriation from the State Treasury, in aid of the Farmers' High School." (Representatives SCHMITT, DIAMOND, RYAN and others) - Agriculture & Rural Affairs, January 7, 2020

VOTE



This bill eliminates an unnecessary/obsolete appropriation to Penn State.

SECOND CONSIDERATION **CHILDREN AND YOUTH BILLS**

HOUSE 309

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in departmental powers and 289 known as the Human Scribes Code, in Translation of Market Stars Program duties as to supervision, providing for Keystone STARS Program participants; and, in departmental powers and duties as to licensing, further providing for fees, providing for Keystone STARS Program participants and further providing for definition. (Representatives MEHAFFIE, SOLOMON, A. DAVIS and others) - Children & Youth, **December 18, 2019**

OVER

This bill requires child care facilities to publicly display their Keystone STARS rating.

HOUSE

1633

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, 2185 further providing for employees having contact with children; adoptive and foster parents. (Representative BOBACK) - Rules, October 29, 2019 13

OVER

This bill amends the Child Protective Services Law to provide for additional background check requirements and to restrict provisional employment arrangements.

SECOND CONSIDERATION EDUCATION BILLS

HOUSE

434

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in certification of 2743 teachers, providing for a cultural competence continuing professional development course; and, in terms and courses of study, further providing for Holocaust, genocide and human rights violations instruction. (Representatives SOLOMON, GROVE, T. DAVIS and others) - Education, October 28, 2019

OVER

This bill amends the Public School Code to require the Department of Education to develop and implement a continuing professional education course on cultural awareness.

HOUSE

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school district financial 2886 recovery, providing for duties of receivers in certain districts. TURZAI, (Representatives ROTHMAN, REESE others) - Education, November 20, 2019 9

OVER

This bill amends the Public School Code to provide for a program of tuition grants for certain school districts in receivership.

SECOND CONSIDERATION EDUCATION BILLS

HOUSE 1881 2616

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school security, further providing for school police officers powers and duties. (Representatives KAUFFMAN, STEPHENS, SNYDER and others) – Education, October 28, 2019

OVER

This bill amends the Public School Code to permit school police officers employed by a school district to exercise arrest powers if authorized by a court.

SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, in development, further providing for well permits. (Representatives OBERLANDER, FRITZ, JAMES and others) - Environmental Resources & Energy, October 29, 2019

OVER

This bill amends Title 58 to provide for cross unit drilling.

SECOND CONSIDERATION FINANCE BILL

HOUSE 1796

An Act amending the act of May 30, 1984 (P.L.345, No.69), known as the First Class City Business Tax Reform Act, further providing for definitions. (Representatives WHITE, HILL-EVANS, PYLE and others) - Finance, December 17, 2019

VOTE

This bill amends the First Class City Business Tax Reform Act to provide a net operating loss deduction update.

SECOND CONSIDERATION INSURANCE BILL

HOUSE 1862

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, providing for protections for consumers receiving surprise balance bills for health care services from out-of-network providers. (Representatives PICKETT, DeLUCA, BROWN and others) – Insurance, October 30, 2019

OVER

This bill provides for protections for consumers receiving surprise balance bills from health care services from out-of-network providers.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 111 1630

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON, SIMS and others) - Judiciary, January 13, 2020

OVER

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

HOUSE 1555 3006

Amending Titles 42 (Judiciary and Judicial Procedure) and 61 (Prisons and Parole) of the Pennsylvania Consolidated States, in sentencing, further providing for order of probation and for modification or revocation of order of probation; in other criminal provisions, further providing for definitions and for supervisory relationship to offenders; and, in Pennsylvania Board of Probation and Parole, further providing for supervisory relationship to offenders. (Representatives DELOZIER, HARRIS, JONES and others) – Judiciary, December 17, 2019

OVER

This bill amends Title 42 to limit probationary terms, set forth a procedure for the courts to apply when addressing probation violations, restricting the sanctions for probation violators, providing various means by which a person on probation can reduce the length of that probation, and applying these changes retroactively.

HOUSE

1851 2573 An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, further providing for sentences for offenses committed with firearms and providing for sentences for persons not to possess, use, manufacture, control, sell or transfer firearms.. (Representatives STEPHENS, QUINN, BERNSTINE and others) – Judiciary, December 18, 2019

OVER

This bill amends two provisions in Title 42 to require mandatory minimum sentences for felons convicted of illegally possessing a firearm and to expand the definition of the term "crime of violence" to include the offense of a felon in possession of a firearm.

HOUSE 2040 2867

An Act providing for the PA Second Chance Jobs website and for powers and duties of the Department of Labor and Industry. (Representatives HARRIS, LEWIS, DELLOSO and others) – Judiciary, December 17, 2019

OVER

This bill creates the PA Second Chance Jobs website to provide a free and voluntary website where employers may advertise employment opportunities for former offenders.

SECOND CONSIDERATION JUDICIARY BILLS

SENATE

An Act amending the act of November 24, 1998 (P.L.882, No.111), known as the Crime Victims Act, in preliminary provisions, 1424 further providing for definitions; in crime victims, further providing for rights, for responsibilities of victims of crime under basic bill of rights, for responsibilities of State and local law enforcement agencies and for responsibilities of prosecutor's office; in administration, further providing for office, for powers and duties of victim advocate and for powers and duties of Office of Victims' Services; in parole advocacy, further providing for preparole notification to victim and for petitions to deny parole upon expiration of minimum sentence; in compensation, further providing for persons eligible for compensation, for filing of claims for compensation, for minimum allowable claim, for determination of claims, for emergency awards, for awards and for confidentiality of records; in services, further providing for eligibility of victims; in financial matters, further providing for costs and for costs for offender supervision programs; and, in enforcement, further providing for subrogation. (Senators BARTOLOTTA, HUGHES, HAYWOOD and others) - Judiciary, December 16, 2019

OVER

This bill amends the Crime Victims Act to make omnibus changes to victims' rights and compensation.

SECOND CONSIDERATION LABOR & INDUSTRY BILLS

HOUSE 785

An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, further providing for 856 definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) - Labor & Industry, October 28, 2019

OVER

This bill amends the Public Employe Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.

HOUSE

An Act repealing the act of July 1, 1978 (P.L.584, No.109), entitled "An act establishing an agency to create the linkage necessary for the planning of an economic development system for **Pennsylvania, and making an appropriation.**" (Representatives FEE, RYAN, PICKETT and others) - Labor & Industry, January 7, 2020



This bill repeals the Milrite Act.

SECOND CONSIDERATION LOCAL GOVERNMENT BILLS

HOUSE 523

An Act amending the act of June 13, 1836 (P.L.551, No.169), referred to as the General Road Law, further providing for repair 2576 of private roads. (Representatives DAY, BERNSTINE, MILLARD and others) - Local Government, January 7, 2020

 \mathbf{VOTE}

This bill provides for repair of private roads.

HOUSE 1074

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in municipal authorities, providing for governing bodies of airport authorities located in counties of the second class. (Representatives TURZAI, HENNESSEY, RYAN and others) - Local Government, January 7, 2020

OVER

This bill provides for governing bodies of airport authorities located in counties of the second class.

HOUSE 1408

An Act repealing the act of July 30, 1959 (P.L.585, No.192), entitled "An act permitting the completion of baseball games in cities of the first, second, second class A, and third class, and townships of the first class, notwithstanding provisions to the contrary." (Representatives LEWIS, POLINCHOCK, RYAN and others) - Local Government, January 7, 2020

VOTE

This bill repeals the Sunday Sports Law.

HOUSE

An Act amending the act of June 24, 1931 (P.L.1206, No.331), known as The First Class Township Code, in preliminary provisions, 3052 further providing for definitions, for excluded provisions, for construction of act generally, for construction of references, for how act applies and for saving clauses where class of townships changed, repealing provisions relating to exception as to taxation and further providing for legal advertising. (Representatives MOUL, JAMES, EVERETT and others) - Local Government, January 7, 2020

VOTE



This bill provides for consolidation and update of the First Class Township Code.

SENATE 690

An Act amending the act of May 27, 1953 (P.L.244, No.34), entitled "An act relating to and regulating the contracts of incorporated towns and providing penalties," further providing for power to convey. (Senators HUTCHINSON, MARTIN, J. WARD and others) - Local Government, January 7, 2020

VOTE



This bill provides for power to convey.

SECOND CONSIDERATION LOCAL GOVERNMENT BILLS

SENATE 691

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, in corporate powers, further providing for real property. (Senators HUTCHINSON, MARTIN, J. WARD and others) – Local Government, January 7, 2020

VOTE

This bill provides for real property.

SENATE 692

An Act amending Titles 8 (Boroughs and Incorporated Towns) and 11 (Cities) of the Pennsylvania Consolidated Statutes, in corporate powers, further providing for real property; and, in corporate powers, further providing for city property and affairs. (Senators HUTCHINSON, MARTIN, J. WARD and others) - Local Government, January 7, 2020



This bill provides for real property and in corporate powers.

SECOND CONSIDERATION STATE GOVERNMENT BILL

283

An Act amending the act of February 14, 2008 (P.L.6, No.3), known as the Right-to-Know Law, in preliminary provisions, further providing for definitions; in procedure, further providing for written requests; and, in judicial review, further providing for fee limitations. (Representatives SIMMONS, NEILSON, IRVIN and others) – State Government, October 28, 2019

OVER

This bill provides for written requests and further provides for fee limitations.

SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE

3 / 205

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in licensing of drivers, further providing for learners' permits; in rules of the road in general, repealing provisions relating to prohibiting text-based communications, prohibiting use of interactive wireless communications devices, imposing penalties and establishing the Distracted Driver Awareness Fund; and, in operation of vehicles miscellaneous provisions, further providing for the offense of homicide by vehicle and for the offense of aggravated assault by vehicle. (Representatives BROWN, READSHAW, STEPHENS and others) - Rules, December 10, 2019

OVER

This bill prohibits the use of hand-held interactive wireless communication devices while operating a motor vehicle.

OVER

This bill designates a bridge on a portion of S.R. 4021 in Potter County as the Tec 5 C. Virgil Voorhees Memorial Bridge.

SENATE

607 1384 An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in rules of the road in general, further providing for speed timing devices. (Senators SCAVELLO, MARTIN, BROWNE and others) – Transportation, December 9, 2019

OVER

This bill amends Title 75 to provide for speed timing devices.

SECOND CONSIDERATION URBAN AFFAIRS BILL

HOUSE 177

2 1012

An Act amending Title 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in home inspections, further providing for home inspection reports. (Representatives KORTZ, HELM, READSHAW and others) – Urban Affairs, December 16, 2019

OVER

This bill provides for home inspection reports.

SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

HOUSE

2568

An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in interpretation and definitions, further providing for definitions; and, in liability and compensation, further providing for compensation for post-traumatic stress injury. (Representatives BARRAR, SAINATO, BIZZARRO and others) - Veterans Affairs & Emergency Preparedness, October 23, 2010

OVER

This bill requires post-traumatic stress injuries to be compensable under workers compensation for first responders, including 911 center dispatchers and call takers, and corrections officers.

SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

HOUSE 759

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in emergency management 2508 services, providing for emergency response payment. (Representatives DUSH, JOZWIAK, GREINER and others) - Veterans Affairs & **Emergency Preparedness, October 23, 2019**

OVER

This bill authorizes Volunteer Fire Departments to bill for real and reasonable costs.

HOUSE 1347

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in casualty insurance, further providing for billing. (Representatives MASSER, WHEELAND, IRVIN and others) - Veterans Affairs & Emergency Preparedness, October 23, 2019

OVER

This bill requires insurance carriers to reimburse ambulance companies directly that are not in the insurance carrier's network.

THIRD CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILLS

HOUSE 1037

An Act amending the act of November 10, 1999 (P.L.491, No.45), known as the Pennsylvania Construction Code Act, in preliminary provisions, further providing for definitions and for application; and, in exemptions, applicability and penalties, further providing for penalties. (Representatives LAWRENCE, CAUSER, BERNSTINE and others) - Appropriations, November 18, 2019 Fiscal-Note Attached

OVER

This bill amends the PA Construction Code Act to exempt historic agricultural buildings, when used for private events and meeting certain safety provisions, from the provisions of the code.

HOUSE

An Act providing for limited civil liability for agritourism activity providers, for notice of limited civil liability and for acknowledgment 3056 of limited civil liability. (Representatives GLEIM, GREINER, CAUSER and others) - Appropriations, December 18, 2019 Fiscal-Note **Attached**

OVER

This bill creates limited liability protection for agritourism activity providers.

OVER

This bill amends Title 40 and Title 42 to provide consumer protections for annuity benefit plans.

(Representatives SNYDER, MULLERY, GOODMAN and others) - Appropriations, **December 18, 2019 Fiscal-Note Attached**



This bill amends the Prisons and Parole Code to permit a corrections officer employed by the DOC to provide a written statement to, or testify before, the Pennsylvania Board of Probation and Parole regarding whether an inmate should be paroled.

OVER

This bill provides for the definitions of "injury," "personal injury" and "injury arising in the course of his employment," providing for diseases with long latency periods between occupational exposure and manifestation of the disease.
