SECOND CONSIDERATION CHILDREN AND YOUTH BILL

HOUSE 1633

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, further providing for employees having contact with children; adoptive and foster parents. (Representative BOBACK) – Rules, April 21, 2020

OVER

This bill amends the Child Protective Services Law to provide for additional background check requirements and to restrict provisional employment arrangements.

OVER

This bill amends the Vital Statistics Law to eliminate the fee for a death certificate for coroners in the performance of their official duties for unclaimed bodies.

HOUSE **564**

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, further providing for prompt payment of claims. (Representatives SAYLOR, RYAN, BARRAR and others) - Rules, April 16, 2020

OVER

This bill provides for prompt payment of claims.

SECOND CONSIDERATION INSURANCE BILLS

HOUSE 1862 2795

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, providing for protections for consumers receiving surprise balance bills for health care services from out-of-network providers. (Representatives PICKETT, DeLUCA, BROWN and others) – Insurance, January 22, 2020

OVER

This bill provides for protections for consumers receiving surprise balance bills from health care services from out-of-network providers.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 111 1630

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON, ISAACSON and others) - Judiciary, April 14, 2020

OVER

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

1555 3006

Amending Titles 42 (Judiciary and Judicial Procedure) and 61 (Prisons and Parole) of the Pennsylvania Consolidated States, in sentencing, further providing for order of probation and for modification or revocation of order of probation; in other criminal provisions, further providing for definitions and for supervisory relationship to offenders; and, in Pennsylvania Board of Probation and Parole, further providing for supervisory relationship to offenders. (Representatives DELOZIER, HARRIS, JONES and others) - Judiciary, April 6, 2020

OVER

This bill amends Title 42 to limit probationary terms, set forth a procedure for the courts to apply when addressing probation violations, restricting the sanctions for probation violators, providing various means by which a person on probation can reduce the length of that probation, and applying these changes retroactively.

OVER

This bill amends two provisions in Title 42 to require mandatory minimum sentences for felons convicted of illegally possessing a firearm and to expand the definition of the term "crime of violence" to include the offense of a felon in possession of a firearm.

HOUSE 2040 2867

An Act providing for the PA Second Chance Jobs website and for powers and duties of the Department of Labor and Industry. (Representatives HARRIS, LEWIS, DELLOSO and others) – Judiciary, April 6, 2020

OVER

This bill creates the PA Second Chance Jobs website to provide a free and voluntary website where employers may advertise employment opportunities for former offenders.

HOUSE 2123 3149

An Act designating the Faxon Interchange of Interstate 180 at Northway Road in Loyalsock Township, Lycoming County, as the Sgt. Thomas Woodruff, Sr., and Sgt. Hamilton Woodruff Memorial Interchange. (Representatives WHEELAND, BURNS, HENNESSEY and others) - Transportation, March 16, 2020

OVER

This bill designates the Faxon Interchange of Interstate 180 in Lycoming County as the United States Army Sgt. Thomas H. Woodruff, Sr., and United States Marine Corps Sgt. Hamilton T. Woodruff Memorial Interchange.

SENATE

OVER

HOUSE 122 1012

OVER

This bill provides for home inspection reports.

OVER

This bill creates limited liability protection for agritourism activity providers.

OVER

This bill amends Title 40 and Title 42 to provide consumer protections for annuity benefit plans.

THIRD CONSIDERATION JUDICIARY BILL

HOUSE 1850 2531

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, further providing for sentences for offenses committed with firearms and for sentences for certain drug offenses committed with firearms. (Representatives STEPHENS, QUINN, BERNSTINE and others) - Appropriations, April 14, 2020 Fiscal-Note Attached 4

OVER

This bill amends two provisions in the Judicial Code to restore a 5-year mandatory minimum sentence for violent crimes committed with firearms and drug deliveries committed with firearms.

An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in liability and compensation, further providing for the definitions of "injury," "personal injury" and "injury arising in the course of his employment," providing for diseases with long latency periods between occupational exposure and manifestation of the disease and further providing for liability. (Representatives COX, DUSH, FRITZ and others) - Appropriations, February 4, 2020 Fiscal-Note Attached

OVER

This bill provides for the definitions of "injury," "personal injury" and "injury arising in the course of his employment," providing for diseases with long latency periods between occupational exposure and manifestation of the disease.

THIRD CONSIDERATION STATE GOVERNMENT BILLS

HOUSE 1106 1599

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for environmental permits and plan approvals; making related repeals; and abrogating regulations. (Representatives PUSKARIC, TURZAI, KAUFER and others) - Appropriations, April 6, 2020 Fiscal-Note Attached

OVER

This bill amends the Administrative Code to establish processes and timelines relating to applications for individual permits, general permits, general permits and general plan approvals required by an environmental law.

OVER

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for emergency COVID-19 provisions. (Representatives TURZAI, CUTLER, SAYLOR and others) – Appropriations, April 20, 2020 Fiscal-Note Attached



This bill amends the Administrative Code to add a new Article relating to Emergency COVID-19 provisions, to extend waiver of the Governor's Business Closure Order to all public and private construction activities.

OVER

This bill designates a bridge on that portion of S.R. 2034 over PA Route 611 in Abington Township, Montgomery County, as the Captain Samuel Schultz Memorial Bridge.
