OVER

This bill amends the Administrative Code in powers and duties of the Department of Revenue, repealing provisions relating to vehicle and tractor codes.

HOUSE

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in Independent Fiscal 3541 Office, further providing for definitions and for duties of office. (Representatives GLEIM, RYAN, DONATUCCI and others) - Finance, **April 27, 2020**

HOUSE

OVER

This bill provides for prompt payment of claims.

HOUSE

1862

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, providing for protections for consumers receiving surprise balance bills for health care services from out-of-network providers. (Representatives PICKETT, DeLUCA, BROWN and others) - Insurance, April 27, 2020

OVER

This bill provides for protections for consumers receiving surprise balance bills from health care services from out-of-network providers.

OVER

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

OVER

This bill amends Title 42 to limit probationary terms, set forth a procedure for the courts to apply when addressing probation violations, restricting the sanctions for probation violators, providing various means by which a person on probation can reduce the length of that probation, and applying these changes retroactively.

(Representatives STEPHENS, QUINN, BERNSTINE and others) – Judiciary, April 7, 2020

OVER

This bill amends two provisions in Title 42 to require mandatory minimum sentences for felons convicted of illegally possessing a firearm and to expand the definition of the term "crime of violence" to include the offense of a felon in possession of a firearm.

HOUSE **2040** 2867

An Act providing for the PA Second Chance Jobs website and for powers and duties of the Department of Labor and Industry. (Representatives HARRIS, LEWIS, DELLOSO and others) – Judiciary, April 6, 2020

OVER

This bill creates the PA Second Chance Jobs website to provide a free and voluntary website where employers may advertise employment opportunities for former offenders.

OVER

This bill provides for definitions, for continuing professional competency requirements and for exemption form licensure and registration.

SENATE 67

An Act authorizing the Commonwealth of Pennsylvania to join the Psychology Interjurisdictional Compact; providing for the form of the compact; imposing additional powers and duties on the Governor, the Secretary of the Commonwealth and the Compact. (Senators J. WARD, BOSCOLA, PHILLIPS-HILL and others) - Professional Licensure, March 16, 2020 12

OVER

This bill authorizes the Commonwealth of Pennsylvania to join the Psychology Interjurisdictional Compact.

OVER

This bill designates a bridge on a portion of S.R. 4021 in Potter County as the Tec 5 C. Virgil Voorhees Memorial Bridge.

An Act designating the Faxon Interchange of Interstate 180 at Northway Road in Loyalsock Township, Lycoming County, as the Sgt. Thomas Woodruff, Sr., and Sgt. Hamilton Woodruff Memorial Interchange. (Representatives WHEELAND, BURNS, HENNESSEY and others) - Transportation, March 16, 2020

OVER

This bill designates the Faxon Interchange of Interstate 180 in Lycoming County as the United States Army Sgt. Thomas H. Woodruff, Sr., and United States Marine Corps Sgt. Hamilton T. Woodruff Memorial Interchange.

SENATE

607 1384 An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in rules of the road in general, further providing for speed timing devices. (Senators SCAVELLO, MARTIN, BROWNE and others) - Transportation, March 23, 2020 11

OVER

This bill amends Title 75 to provide for speed timing devices.

HOUSE 122

An Act amending Title 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in home inspections, further providing for home inspection reports. (Representatives KORTZ, HELM, READSHAW and others) - Urban Affairs, March 25, 2020

OVER

This bill provides for home inspection reports.

SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

HOUSE

2568

An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in interpretation and definitions, further providing for definitions; and, in liability and compensation, further providing for compensation for post-traumatic stress injury. (Representatives BARRAR, SAINATO, BIZZARRO and others) - Veterans Affairs & Emergency Preparedness, April 16, 2020

OVER

This bill requires post-traumatic stress injuries to be compensable under workers compensation for first responders, including 911 center dispatchers and call takers, and corrections officers.

OVER

This bill authorizes Volunteer Fire Departments to bill for real and reasonable costs.

HOUSE 1236 3130

An Act regulating certain smoke alarms; providing for dwelling unit owner and tenant responsibilities; and prescribing penalties. (Representatives POLINCHOCK, FARRY, CIRESI and others) - Veterans Affairs & Emergency Preparedness, April 27, 2020

OVER

This bill creates the "Smoke Alarm Device Responsibility" Act by requiring approved smoke alarm devices that have nonremovable batteries with at least a 10-year life span.

HOUSE 1347

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in casualty insurance, further providing for billing. (Representatives MASSER, WHEELAND, IRVIN and others) - Veterans Affairs & Emergency Preparedness, April 16, 2020

OVER

This bill requires insurance carriers to reimburse ambulance companies directly that are not in the insurance carrier's network.

OVER

This bill amends Title 40 and Title 42 to provide consumer protections for annuity benefit plans.

HOUSE 1850 2531

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, further providing for sentences for offenses committed with firearms and for sentences for certain drug offenses committed with firearms. (Representatives STEPHENS, QUINN, BERNSTINE and others) - Appropriations, April 14, 2020 Fiscal-Note Attached 5

OVER

This bill amends two provisions in the Judicial Code to restore a 5-year mandatory minimum sentence for violent crimes committed with firearms and drug deliveries committed with firearms.
