SECOND CONSIDERATION CHILDREN AND YOUTH BILL

HOUSE 1633

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, further providing for employees having contact with children; adoptive and foster parents. (Representative BOBACK) – Rules, April 21, 2020

OVER

This bill amends the Child Protective Services Law to provide for additional background check requirements and to restrict provisional employment arrangements.

SECOND CONSIDERATION EDUCATION BILLS

HOUSE 434

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in certification of teachers, providing for a cultural competence continuing professional development course; and, in terms and courses of study, further providing for Holocaust, genocide and human rights violations instruction. (Representatives SOLOMON, GROVE, T. DAVIS and others) – Education, April 20, 2020

OVER

This bill amends the Public School Code to require the Department of Education to develop and implement a continuing professional education course on cultural awareness.

SECOND CONSIDERATION EDUCATION BILLS

HOUSE 703

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school directors, providing for publication of e-mail addresses for school directors; and, in charter schools, providing for publication of e-mail addresses for board of trustees and further providing for applicability of other provisions of this act and of other acts and regulations. (Representatives BROWN, RYAN, ZIMMERMAN and others) - Education, May 5, 2020

VOTE

This bill requires the publication of email addresses for members of local board of school directors.

HOUSE 1800

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school district financial recovery, providing for duties of receivers in certain districts. (Representatives TURZAI, ROTHMAN, REESE and others) - Education, April 30, 2020

OVER

This bill amends the Public School Code to provide for a program of tuition grants for certain school districts in receivership.

HOUSE 1881

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school security, further providing for school police officers powers and duties. (Representatives KAUFFMAN, STEPHENS, SNYDER and others) - Education, April 20, 2020

OVER

This bill amends the Public School Code to permit school police officers employed by a school district to exercise arrest powers if authorized by a court.

HOUSE 71 71

3671

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in the State System of Higher Education, further providing for establishment of the State System of Higher Education and its institutions, for board of governors, for the chancellor, for powers and duties of the board of governors, for councils of trustees, for powers and duties of councils of trustees and for power and duties of institution presidents. (Representatives SONNEY, TOPPER, SCHROEDER and others) - Education, May 5, 2020

OVER

This bill reforms PASSHE's governance structure.

SECOND CONSIDERATION **EDUCATION BILLS**

HOUSE

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in the State System of 3202 Higher Education, further providing for definitions, for establishment of the State System of Higher Education and its institutions, for purposes and general powers, for project contracts, for power and duties of institution presidents, for method of disposition and consideration by the General Assembly and for campus police powers and duties. (Representatives TOPPER, SONNEY, SCHROEDER and others) - Education, May 5, 2020

OVER

This bill reforms PASSHE's legal and financial structure.

HOUSE

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in the State System of 3203 Higher Education, further providing for purposes and general powers, for rental fees and other charges and for annual report and providing for student records. (Representatives SCHROEDER, SONNEY, TOPPER and others) - Education, May 5, 2020



This bill modernizes PASSHE's enabling statute.

SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

HOUSE 247

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, in development, further providing for well permits. (Representatives OBERLANDER, FRITZ, JAMES and others) - Environmental Resources & Energy, April 21, 2020

OVER

This bill amends Title 58 to provide for cross unit drilling.

SECOND CONSIDERATION FINANCE BILLS

HOUSE 333

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives NELSON, GROVE, GAYDOS and others) - Finance, March 25, 2020 14

OVER

This bill provides for classes of income.

SECOND CONSIDERATION FINANCE BILLS

HOUSE 1168 1346

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in sales and use tax, further providing for the definition of "building machinery and equipment." (Representatives CALTAGIRONE, FREEMAN, HILL-EVANS and others) - Rules, April 7, 2020

OVER

This bill provides for the definition of "building machinery and equipment."

SECOND CONSIDERATION HEALTH BILL

HOUSE 1912 2660

An Act amending the act of June 29, 1953 (P.L.304, No.66), known as the Vital Statistics Law of 1953, in records, further providing for records and fees for copies. (Representatives ZIMMERMAN, READSHAW, JAMES and others) - Health, April 28, 2020

OVER

This bill amends the Vital Statistics Law to eliminate the fee for a death certificate for coroners in the performance of their official duties for unclaimed bodies.

SECOND CONSIDERATION INSURANCE BILLS

HOUSE **564**

04 2284 An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, further providing for prompt payment of claims. (Representatives SAYLOR, RYAN, BARRAR and others) - Rules, April 16, 2020

OVER

This bill provides for prompt payment of claims.

HOUSE 1862

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, providing for protections for consumers receiving surprise balance bills for health care services from out-of-network providers. (Representatives PICKETT, DeLUCA, BROWN and others) – Insurance, April 27, 2020 6

OVER

This bill provides for protections for consumers receiving surprise balance bills from health care services from out-of-network providers.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 111 1630

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON, ISAACSON and others) - Judiciary, April 14, 2020

OVER

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

HOUSE 1555 3006

Amending Titles 42 (Judiciary and Judicial Procedure) and 61 (Prisons and Parole) of the Pennsylvania Consolidated States, in sentencing, further providing for order of probation and for modification or revocation of order of probation; in other criminal provisions, further providing for definitions and for supervisory relationship to offenders; and, in Pennsylvania Board of Probation and Parole, further providing for supervisory relationship to offenders. (Representatives DELOZIER, HARRIS, JONES and others) – Judiciary, April 6, 2020

OVER

This bill amends Title 42 to limit probationary terms, set forth a procedure for the courts to apply when addressing probation violations, restricting the sanctions for probation violators, providing various means by which a person on probation can reduce the length of that probation, and applying these changes retroactively.

HOUSE

1851 2573 An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, further providing for sentences for offenses committed with firearms and providing for sentences for persons not to possess, use, manufacture, control, sell or transfer firearms.. (Representatives STEPHENS, QUINN, BERNSTINE and others) – Judiciary, April 7, 2020 12

OVER

This bill amends two provisions in Title 42 to require mandatory minimum sentences for felons convicted of illegally possessing a firearm and to expand the definition of the term "crime of violence" to include the offense of a felon in possession of a firearm.

HOUSE 2040 2867

An Act providing for the PA Second Chance Jobs website and for powers and duties of the Department of Labor and Industry. (Representatives HARRIS, LEWIS, DELLOSO and others) – Judiciary, April 6, 2020

OVER

This bill creates the PA Second Chance Jobs website to provide a free and voluntary website where employers may advertise employment opportunities for former offenders.

OVER

OVER

This bill amends the Public Employee Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.

An Act providing for property owner's bill of rights statement. (Representatives QUINN, COX, SIMMONS and others) - Local 160 Government, April 29, 2020

OVER

This bill provides for property owner's bill of rights statement.

HOUSE 1074 1614

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in municipal authorities, providing for governing bodies of airport authorities located in counties of the second class. (Representatives TURZAI, HENNESSEY, RYAN and others) – Local Government, April 13, 2020

OVER

This bill provides for governing bodies of airport authorities located in counties of the second class.

HOUSE 1566

An Act amending the act of July 2, 1993 (P.L.345, No.48), entitled "An act empowering the General Counsel or his designee to issue subpoenas for certain licensing board activities; providing for hearing examiners in the Bureau of Professional and Occupational Affairs; providing additional powers to the Commissioner of Professional and Occupational Affairs; and further providing for civil penalties and license suspension," further providing for civil penalties. OVER

This bill provides for hearing examiners in the Bureau of Professional and Occupational Affairs.

1947 2727 An Act amending the act of December 20, 1985 (P.L.457, No.112), known as the Medical Practice Act of 1985, further providing for license without restriction. (Representatives KAUFER, BERNSTINE, PICKETT and others) – Professional Licensure, April 30, 2020

OVER

This bill provides for license without restriction.

HOUSE 2101

An Act amending the act of May 23, 1945 (P.L.913, No.367), known as the Engineer, Land Surveyor and Geologist Registration Law, further providing for definitions, for procedure for licensing as professional engineer, for continuing professional competency requirements and for exemption from licensure and registration. (Representatives EMRICK, GILLEN, JOZWIAK and others) - Professional Licensure, May 5, 2020

OVER

This bill provides for definitions, for continuing professional competency requirements and for exemption form licensure and registration.

OVER

OVER

This bill designates a bridge on a portion of S.R. 4021 in Potter County as the Tec 5 C. Virgil Voorhees Memorial Bridge.

HOUSE

An Act designating the Faxon Interchange of Interstate 180 at Northway Road in Loyalsock Township, Lycoming County, as the Sgt. Thomas Woodruff, Sr., and Sgt. Hamilton Woodruff Memorial Interchange. (Representatives WHEELAND, BURNS, HENNESSEY and others) - Transportation, May 4, 2020

OVER

This bill designates the Faxon Interchange of Interstate 180 in Lycoming County as the United States Army Sgt. Thomas H. Woodruff, Sr., and United States Marine Corps Sgt. Hamilton T. Woodruff Memorial Interchange.

SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE 2319

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing 3664 for return of registration plate, for person with disability plate and placard and for special plates for recipients of Purple Heart; and, in rules of the road in general, further providing for additional parking regulations. (Representatives KAUFER, PEIFER, JAMES and others) - Transportation, May 5, 2020

 \mathbf{VOTE}

This bill designates the Purple Heart Disability license plate.

SENATE

607

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in rules of the road in general, further providing for speed timing devices. (Senators SCAVELLO, MARTIN, BROWNE and others) - Transportation, May 5, 2020

OVER

This bill amends Title 75 to provide for speed timing devices.

SECOND CONSIDERATION URBAN AFFAIRS BILL

HOUSE 122

An Act amending Title 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in home inspections, further 1012 providing for home inspection reports. (Representatives KORTZ, HELM, READSHAW and others) - Urban Affairs, March 25, 2020

OVER

This bill provides for home inspection reports.

SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

HOUSE

An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in interpretation and definitions, further providing for definitions; and, in liability and compensation, further providing for compensation for post-traumatic stress injury. (Representatives BARRAR, SAINATO, BIZZARRO and others) - Veterans Affairs & Emergency Preparedness, April 16, 2020

OVER

This bill requires post-traumatic stress injuries to be compensable under workers compensation for first responders, including 911 center dispatchers and call takers, and corrections officers.

HOUSE 759

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in emergency management services, providing for emergency response payment. (Representatives DUSH, JOZWIAK, GREINER and others) - Veterans Affairs & Emergency Preparedness, April 16, 2020

OVER

This bill authorizes Volunteer Fire Departments to bill for real and reasonable costs.

HOUSE 1236

An Act regulating certain smoke alarms; providing for dwelling unit owner and tenant responsibilities; and prescribing penalties. (Representatives POLINCHOCK, FARRY, CIRESI and others) - Veterans Affairs & Emergency Preparedness, April 27, 2020 6

OVER

This bill creates the "Smoke Alarm Device Responsibility" Act by requiring approved smoke alarm devices that have nonremovable batteries with at least a 10-year life span.

HOUSE 1347

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in casualty insurance, further providing for billing. (Representatives MASSER, WHEELAND, IRVIN and others) - Veterans Affairs & Emergency Preparedness, April 16, 2020

OVER

This bill requires insurance carriers to reimburse ambulance companies directly that are not in the insurance carrier's network.

HOUSE 1037

OVER

This bill amends the PA Construction Code Act to exempt historic agricultural buildings, when used for private events and meeting certain safety provisions, from the provisions of the code.

HOUSE

1348

An Act providing for limited civil liability for agritourism activity providers, for notice of limited civil liability and for acknowledgment of limited civil liability. (Representatives GLEIM, GREINER, CAUSER and others) - Appropriations, April 7, 2020 Fiscal-Note **Attached**

OVER

This bill creates limited liability protection for agritourism activity providers.

HOUSE

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for emergency 3612 COVID-19 provisions. (Representatives MUSTELLO, KLUNK, DIAMOND and others) - Appropriations, April 30, 2020 Fiscal-Note **Attached**

OVER

This bill amends the Administrative Code to add a new Article relating to Emergency COVID-19 provisions regarding extension of waiver provisions to animal grooming services.

OVER

This bill provides for Keystone STARS Program participants.

SENATE **790**

OVER

This bill creates the "Conventional Oil and Gas Wells Act" for the regulation of conventional oil and gas wells.

HOUSE 1283

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in judgments and other liens, further providing for exemption of particular property. (Representatives MOUL, PICKETT, RYAN and others) - Appropriations, May 4, 2020, 2019 Fiscal-Note Attached

OVER

This bill amends Title 40 and Title 42 to provide consumer protections for annuity benefit plans.

THIRD CONSIDERATION JUDICIARY BILL

HOUSE 1850 2531

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, further providing for sentences for offenses committed with firearms and for sentences for certain drug offenses committed with firearms. (Representatives STEPHENS, QUINN, BERNSTINE and others) – Appropriations, April 14, 2020 Fiscal-Note Attached

OVER

This bill amends two provisions in the Judicial Code to restore a 5-year mandatory minimum sentence for violent crimes committed with firearms and drug deliveries committed with firearms.

HOUSE 1234

An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in liability and compensation, further providing for the definitions of "injury," "personal injury" and "injury arising in the course of his employment," providing for diseases with long latency periods between occupational exposure and manifestation of the disease and further providing for liability. (Representatives COX, DUSH, FRITZ and others) - Appropriations, April 29, 2020 Fiscal-Note Attached

OVER

This bill provides for the definitions of "injury," "personal injury" and "injury arising in the course of his employment," providing for diseases with long latency periods between occupational exposure and manifestation of the disease.

THIRD CONSIDERATION LIQUOR CONTROL BILL

HOUSE 1279 3058

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in licenses and regulations, liquor, alcohol and malt and brewed beverages, further providing for wine expanded permits. (Representatives MIHALEK, TURZAI, MILLARD and others) – Appropriations, April 27, 2020 Fiscal-Note Attached

OVER
