#### SECOND CONSIDERATION PREFERRED APPROPRIATION BILL

HOUSE 2467

An Act making appropriations from the Professional Licensure Augmentation Account and from restricted revenue accounts within the General Fund to the Department of State for use by the Bureau of Professional and Occupational Affairs in support of the professional licensure boards assigned thereto. (Representative SAYLOR) - Appropriations, May 12, 2020

OVER

This bill makes an appropriations from the Professional Licensure Augmentation Account and from restricted revenue accounts within the General Fund to the Department of State for use by the Bureau of Professional and Occupational Affairs in support of the professional licensure boards assigned thereto.

### SECOND CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILL

HOUSE 2477 3690

An Act amending the act of July 10, 1981 (P.L.234, No.76), known as the Donated Food Limited Liability Act, further providing for donor immunity. (Representatives ROWE, CAUSER, BERNSTINE and others) – Agriculture & Rural Affairs, May 18, 2020 2

C VOTE

This bill provides for limited liability for donating food past the labeled date code recommended by the manufacturer.

#### SECOND CONSIDERATION APPROPRIATION BILL

**HOUSE** 2510

An Act providing for regional response health collaborations to 3735 promote health in facilities by supporting COVID-19 readiness and response and improving the quality of infection prevention. (Representatives TURZAI, READSHAW, **KORTZ** and others) - Appropriations, May 14, 2020 3  $\mathbf{VOTE}$ 

This bill provides for regional response health collaborations to promote health in facilities by supporting COVID-19 readiness and response and improving the quality of infection prevention.

#### **SECOND CONSIDERATION CHILDREN AND YOUTH BILL**

**HOUSE** 1633

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, 2185 further providing for employees having contact with children; adoptive and foster parents. (Representative BOBACK) - Rules, April 21, 2020

OVER

This bill amends the Child Protective Services Law to provide for additional background check requirements and to restrict provisional employment arrangements.

#### SECOND CONSIDERATION **EDUCATION BILLS**

HOUSE **434** 

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in certification of teachers, providing for a cultural competence continuing professional development course; and, in terms and courses of study, further providing for Holocaust, genocide and human rights violations instruction. (Representatives SOLOMON, GROVE, T. DAVIS and others) - Education, April 20, 2020

OVER

This bill amends the Public School Code to require the Department of Education to develop and implement a continuing professional education course on cultural awareness.

**HOUSE** 

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school district financial 2886 recovery, providing for duties of receivers in certain districts. **REESE** (Representatives TURZAI, ROTHMAN, others) - Education, April 30, 2020

OVER

8

This bill amends the Public School Code to provide for a program of tuition grants for certain school districts in receivership.

#### SECOND CONSIDERATION **EDUCATION BILLS**

**HOUSE** 1881

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school security, further 2616 providing for school police officers powers and duties. (Representatives KAUFFMAN, STEPHENS, **SNYDER** and others) - Education, April 20, 2020 13

OVER

This bill amends the Public School Code to permit school police officers employed by a school district to exercise arrest powers if authorized by a court.

**HOUSE** 

**2171** 

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in the State System of 3671 Higher Education, further providing for establishment of the State System of Higher Education and its institutions, for board of governors, for the chancellor, for powers and duties of the board of governors, for councils of trustees, for powers and duties of councils of trustees and for power and duties of institution presidents. (Representatives SONNEY, TOPPER, SCHROEDER and others) - Education, May 5, 2020

VOTE

This bill reforms PASSHE's governance structure.

**HOUSE** 

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in the State System of 3202 Higher Education, further providing for definitions, for establishment of the State System of Higher Education and its institutions, for purposes and general powers, for project contracts, for power and duties of institution presidents, for method of disposition and consideration by the General Assembly and for campus police powers and duties. (Representatives TOPPER, SONNEY, SCHROEDER and others) - Education, May 5, 2020

This bill reforms PASSHE's legal and financial structure.

#### SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

HOUSE **247** 

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, in development, further providing for well permits. (Representatives OBERLANDER, FRITZ, JAMES and others) - Environmental Resources & Energy, April 21, 2020

OVER

This bill amends Title 58 to provide for cross unit drilling.

#### SECOND CONSIDERATION FINANCE BILLS

**HOUSE** 333

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives NELSON, GROVE, GAYDOS and others) - Finance, May 13, 2020

OVER

This bill provides for classes of income.

**HOUSE** 1168

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in sales and use tax, further providing for the definition of "building machinery and equipment." (Representatives CALTAGIRONE, FREEMAN, HILL-EVANS and others) - Rules, May 18, 2020 2

**OVER** 

This bill provides for the definition of "building machinery and equipment."

#### **SECOND CONSIDERATION HEALTH BILL**

**HOUSE 1912** 

An Act amending the act of June 29, 1953 (P.L.304, No.66), known as the Vital Statistics Law of 1953, in records, further 2660 providing for records and fees for copies. (Representatives ZIMMERMAN, READSHAW, JAMES and others) - Health, April 28, 2020

OVER

This bill amends the Vital Statistics Law to eliminate the fee for a death certificate for coroners in the performance of their official duties for unclaimed bodies.

#### **SECOND CONSIDERATION INSURANCE BILLS**

HOUSE

564

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health 2284 care accountability and protection, further providing for prompt payment of claims. (Representatives SAYLOR, RYAN, BARRAR and others) - Rules, April 16, 2020

OVER

This bill provides for prompt payment of claims.

#### SECOND CONSIDERATION INSURANCE BILLS

HOUSE 1862 2795

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, providing for protections for consumers receiving surprise balance bills for health care services from out-of-network providers. (Representatives PICKETT, DeLUCA, BROWN and others) – Insurance, April 27, 2020

**OVER** 

This bill provides for protections for consumers receiving surprise balance bills from health care services from out-of-network providers.

#### SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 111 1630

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON, ISAACSON and others) - Judiciary, April 14, 2020

OVER

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

HOUSE 1555 3006

Amending Titles 42 (Judiciary and Judicial Procedure) and 61 (Prisons and Parole) of the Pennsylvania Consolidated States, in sentencing, further providing for order of probation and for modification or revocation of order of probation; in other criminal provisions, further providing for definitions and for supervisory relationship to offenders; and, in Pennsylvania Board of Probation and Parole, further providing for supervisory relationship to offenders. (Representatives DELOZIER, HARRIS, JONES and others) - Judiciary, May 14, 2020

OVER

This bill amends Title 42 to limit probationary terms, set forth a procedure for the courts to apply when addressing probation violations, restricting the sanctions for probation violators, providing various means by which a person on probation can reduce the length of that probation, and applying these changes retroactively.

HOUSE 1827 3696

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in criminal homicide, further providing for the offense of causing or aiding suicide. (Representatives KEEFER, RYAN, BERNSTINE and others) – Judiciary, May 12, 2020 5

(C)

This bill Amends Section 2505 of Title 18 to add a sentencing enhancement for a conviction of causing or aiding in suicide when the person who commits suicide is under 18 years old or has an intellectual disability.

#### SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 1851

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, further providing for sentences for offenses committed with firearms and providing for sentences for persons not to possess, use, manufacture, control, sell or transfer firearms.. (Representatives STEPHENS, QUINN, BERNSTINE and others) – Judiciary, May 18, 2020 2

**OVER** 

This bill amends two provisions in Title 42 to require mandatory minimum sentences for felons convicted of illegally possessing a firearm and to expand the definition of the term "crime of violence" to include the offense of a felon in possession of a firearm.

HOUSE 2016

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, providing for the offense of harassment of law enforcement officer; and imposing penalties. (Representatives SCHMITT, MOUL, GREINER and others) - Judiciary, May 12, 2020 5

VOITE

This bill amends Section 2703 of Title 18 to create the offense of harassment of law enforcement officer.

HOUSE 2040 286'

An Act providing for the PA Second Chance Jobs website and for powers and duties of the Department of Labor and Industry. (Representatives HARRIS, LEWIS, DELLOSO and others) – Judiciary, May 14, 2020

OVER

This bill creates the PA Second Chance Jobs website to provide a free and voluntary website where employers may advertise employment opportunities for former offenders.

HOUSE **2056** 

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, further providing for the offense of aggravated assault. (Representatives STRUZZI, BERNSTINE, BROOKS and others) – Judiciary, May 12, 2020 5

AOLE

This bill amends Title 18 to provide that a person is guilty of aggravated assault if he causes bodily injury to an individual with a physical or intellectual disability.

SENATE 351

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, further providing for the offense of aggravated assault. (Senators J. WARD, BREWSTER, COSTA and others) – Judiciary, May 12, 2020 5

VOTE

This bill amends Title 18 to raise the potential criminal penalties for assaults on health care practitioners and technicians.

An Act amending the act of November 24, 1998 (P.L.882, No.111), known as the Crime Victims Act, in preliminary provisions, 1424 further providing for definitions; in crime victims, further providing for rights, for responsibilities of victims of crime under basic bill of rights, for responsibilities of State and local law enforcement agencies and for responsibilities of prosecutor's office; in administration, further providing for office, for powers and duties of victim advocate and for powers and duties of Office of Victims' Services; in parole advocacy, further providing for preparole notification to victim and for petitions to deny parole upon expiration of minimum sentence; in compensation, further providing for persons eligible for compensation, for filing of claims for compensation, for minimum allowable claim, for determination of claims, for emergency awards, for awards and for confidentiality of records; in services, further providing for eligibility of victims; in financial matters, further providing for costs and for costs for offender supervision programs; and, in enforcement, further providing for subrogation. OVER

This bill amends the Crime Victims Act to make omnibus changes to victims' rights and compensation.

An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, further providing for 856 definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) - Labor & Industry, April 20, 2020

OVER

This bill amends the Public Employee Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.

An Act providing for property owner's bill of rights statement. (Representatives QUINN, COX, SIMMONS and others) - Local Government, April 29, 2020

OVER

This bill provides for property owner's bill of rights statement.

**OVER** 

This bill provides for governing bodies of airport authorities located in counties of the second class.

An Act amending the act of July 2, 1993 (P.L.345, No.48), entitled "An act empowering the General Counsel or his designee to issue subpoenas for certain licensing board activities; providing for hearing examiners in the Bureau of Professional and Occupational Affairs; providing additional powers to the Commissioner of Professional and Occupational Affairs; and further providing for civil penalties and license suspension," further providing for civil penalties. (Representatives KORTZ, KINSEY, MERSKI and others) - Professional Licensure, April 30, 2020 8

**OVER** 

This bill provides for hearing examiners in the Bureau of Professional and Occupational Affairs.

HOUSE

1947 2727

An Act amending the act of December 20, 1985 (P.L.457, No.112), known as the Medical Practice Act of 1985, further providing for license without restriction. (Representatives KAUFER, BERNSTINE, PICKETT and others) – Professional Licensure, April 30, 2020

**OVER** 

This bill provides for license without restriction.

HOUSE 2101

An Act amending the act of May 23, 1945 (P.L.913, No.367), known as the Engineer, Land Surveyor and Geologist Registration Law, further providing for definitions, for procedure for licensing as professional engineer, for continuing professional competency requirements and for exemption from licensure and registration. (Representatives EMRICK, GILLEN, JOZWIAK and others) - Professional Licensure, May 5, 2020 6

OVER

This bill provides for definitions, for continuing professional competency requirements and for exemption form licensure and registration.

An Act amending Title 45 (Legal Notices) of the Pennsylvania Consolidated Statutes, in publication and effectiveness of 1625 Commonwealth documents, further providing for Joint Committee on Documents. (Senator SCARNATI) - State Government, May 19, 2020

OVER

This bill amends Title 45 to provide for Joint Committee on Documents.

#### SECOND CONSIDERATION TOURISM AND RECREATIONAL DEV. BILL

**SENATE** 863

An Act amending Title 48 (Lodging and Housing) of the Pennsylvania Consolidated Statutes, in hotels, further providing for 1660 definitions, for hotelkeepers, for notice to boarders to lock rooms, for lien, warrant, sale and right of redemption, for liability for property loss or damage, for special arrangements for safe deposit of valuables, for duty of guest, for other liability, for exemption from levy or sale, for baggage, for baggage sale requirements, for sale proceeds, providing for abandoned property and further providing for tourist camp heater safety. (Senators SCAVELLO, STEFANO, LAUGHLIN and others) - Tourism & Recreational Development, May 19, 2020

 $\mathbf{VOTE}$ 

This bill provides to add recreational campgrounds and campground owners to the code's existing provisions for hotels and hotelkeepers.

OVER

This bill designates a bridge on a portion of S.R. 4021 in Potter County as the Tec 5 C. Virgil Voorhees Memorial Bridge.

**HOUSE** 2123

An Act designating the Faxon Interchange of Interstate 180 at Northway Road in Loyalsock Township, Lycoming County, as the Sgt. Thomas Woodruff, Sr., and Sgt. Hamilton Woodruff Memorial **Interchange.** (Representatives WHEELAND, BURNS, HENNESSEY and others) - Transportation, May 4, 2020

OVER

This bill designates the Faxon Interchange of Interstate 180 in Lycoming County as the United States Army Sgt. Thomas H. Woodruff, Sr., and United States Marine Corps Sgt. Hamilton T. Woodruff Memorial Interchange.

**SENATE** 607

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in rules of the road in general, further providing for speed timing devices. (Senators SCAVELLO, MARTIN, BROWNE and others) - Transportation, May 5, 2020

OVER

This bill amends Title 75 to provide for speed timing devices.

#### SECOND CONSIDERATION URBAN AFFAIRS BILL

HOUSE 122 1012

An Act amending Title 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in home inspections, further providing for home inspection reports. (Representatives KORTZ, HELM, READSHAW and others) - Urban Affairs, May 13, 2020

**OVER** 

This bill provides for home inspection reports.

## SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

HOUSE 432 2568

An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in interpretation and definitions, further providing for definitions; and, in liability and compensation, further providing for compensation for post-traumatic stress injury. (Representatives BARRAR, SAINATO, BIZZARRO and others) - Veterans Affairs & Emergency Preparedness, April 16, 2020

**OVER** 

This bill requires post-traumatic stress injuries to be compensable under workers compensation for first responders, including 911 center dispatchers and call takers, and corrections officers.

HOUSE

250

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in emergency management services, providing for emergency response payment. (Representatives DUSH, JOZWIAK, GREINER and others) - Veterans Affairs & Emergency Preparedness, April 16, 2020

OVER

This bill authorizes Volunteer Fire Departments to bill for real and reasonable costs.

**1236**

An Act regulating certain smoke alarms; providing for dwelling unit owner and tenant responsibilities; and prescribing penalties. (Representatives POLINCHOCK, FARRY, CIRESI and others) - Veterans Affairs & Emergency Preparedness, April 27, 2020

**OVER** 

This bill creates the "Smoke Alarm Device Responsibility" Act by requiring approved smoke alarm devices that have nonremovable batteries with at least a 10-year life span.

OVER

This bill requires insurance carriers to reimburse ambulance companies directly that are not in the insurance carrier's network.

An Act amending the act of November 10, 1999 (P.L.491, No.45), known as the Pennsylvania Construction Code Act, in preliminary 1836 provisions, further providing for definitions and for application; and, in exemptions, applicability and penalties, further providing for penalties. (Representatives LAWRENCE, CAUSER, BERNSTINE and others) - Appropriations, April 28, 2020 Fiscal-Note Attached

OVER

This bill amends the PA Construction Code Act to exempt historic agricultural buildings, when used for private events and meeting certain safety provisions, from the provisions of the code.

**HOUSE** 

An Act providing for limited civil liability for agritourism activity providers, for notice of limited civil liability and for acknowledgment 3056 of limited civil liability. (Representatives GLEIM, GREINER, CAUSER and others) - Appropriations, May 18, 2020 Fiscal-Note **Attached** 

OVER

This bill creates limited liability protection for agritourism activity providers.

HOUSE

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for emergency 3612 COVID-19 provisions. (Representatives MUSTELLO, KLÜNK, DIAMOND and others) - Appropriations, April 30, 2020 Fiscal-Note **Attached** 

OVER


