#### SECOND CONSIDERATION CHILDREN AND YOUTH BILL

HOUSE 1633

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, further providing for employees having contact with children; adoptive and foster parents. (Representative BOBACK) - Rules, May 28, 2020

OVER

This bill amends the Child Protective Services Law to provide for additional background check requirements and to restrict provisional employment arrangements.

#### SECOND CONSIDERATION COMMERCE BILLS

HOUSE **2452** 3791

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, providing for small business grant program, imposing duties on the Department of Community and making **Economic Development** and an appropriation. CIRESI, SNYDER, **HOHENSTEIN** (Representatives and others) - Commerce, May 26, 2020 3

OVER

This bill creates the Small Business Grant program under DCED.

HOUSE **2491** 

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for emergency COVID-19 provisions. (Representatives M. K. KELLER, CAUSER, SCHLEGEL CULVER and others) – Commerce, May 26, 2020 3

**OVER** 

This bill creates waiver to permit auctioneers to work during the COVID-19 emergency.

#### SECOND CONSIDERATION **EDUCATION BILLS**

HOUSE 434

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in certification of 2743 teachers, providing for a cultural competence continuing professional development course; and, in terms and courses of study, further providing for Holocaust, genocide and human rights violations instruction. (Representatives SOLOMON, GROVE, T. DAVIS and others) - Education, May 27, 2020

OVER

This bill amends the Public School Code to require the Department of Education to develop and implement a continuing professional education course on cultural awareness.

**HOUSE** 1800

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school district financial 2886 recovery, providing for duties of receivers in certain districts. (Representatives TURZAI, ROTHMAN. REESE and 12 others) - Education, April 30, 2020

OVER

This bill amends the Public School Code to provide for a program of tuition grants for certain school districts in receivership.

HOUSE

1881

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school security, further 2616 providing for school police officers powers and duties. (Representatives KAUFFMAN, STEPHENS, SNYDER and others) - Education, May 27, 2020 2

OVER

This bill amends the Public School Code to permit school police officers employed by a school district to exercise arrest powers if authorized by a court.

#### **SECOND CONSIDERATION** ENVIRONMENTAL RESOURCES AND ENERGY BILLS

HOUSE **247** 

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, in development, further providing for well permits. (Representatives OBERLANDER, FRITZ, JAMES and others) - Environmental Resources & Energy, May 28, 2020

OVER

This bill amends Title 58 to provide for cross unit drilling.

## SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILLS

HOUSE 2004

An Act amending the act of July 2, 1993 (P.L.359, No.50), known as the Keystone Recreation, Park and Conservation Fund Act, further providing for definitions, for Keystone Recreation, Park and Conservation Fund, for duties, responsibilities and limitations on agencies, for allocation from fund and for waivers; and making related repeals. (Representatives ORTITAY, GROVE, RYAN and others) - Environmental Resources & Energy, May 20, 2020 4

**OVER** 

This bill requires the General Assembly to annually appropriate money in the Keystone Recreation, Park, and Conservation Fund among the grant programs instead of relying on a static funding schedule.

#### SECOND CONSIDERATION FINANCE BILLS

HOUSE 333 2917

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives NELSON, GROVE, GAYDOS and others) – Finance, May 13, 2020 8

OVER

This bill provides for classes of income.

HOUSE 1168

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in sales and use tax, further providing for the definition of "building machinery and equipment." (Representatives CALTAGIRONE, FREEMAN, HILL-EVANS and others) - Rules, May 18, 2020

OVER

This bill provides for the definition of "building machinery and equipment."

HOUSE 1647

An Act amending the act of May 25, 1945 (P.L.1050, No.394), known as the Local Tax Collection Law, further providing for effect of failure to receive tax notice. (Representatives EMRICK, BARRAR, CIRESI and others) – Finance, May 26, 2020



This bill amends the Local Tax Collection Law to allow a taxpayer to request a waiver from penalty for the late payment of a real estate tax if the notice was not received by the taxpayer during their first year of occupancy.

#### SECOND CONSIDERATION FINANCE BILLS

HOUSE 2369

An Act amending the act of June 29, 1996 (P.L.434, No.67), known as the Job Enhancement Act, in Community Development Bank Grant and Loan Program, further providing for definitions and providing for COVID-19 grant and loan programs. (Representatives GAYDOS, SOLOMON, BARRAR and others) - Finance, May 28, 2020

OVER

This bill amends the Job Enhancement Act to establish the COVID-19 Grant and Loan Program.

**2386** 

An Act providing for business interruption insurance assistance and for powers and duties of the Department of Community and Economic Development. (Representatives MEHAFFIE, KAUFER, QUINN and others) – Finance, May 28, 2020

**OVER** 

This bill establishes the COVID-19 Disaster Emergency Business Interruption Grant Program.

HOUSE

2460 3794

An Act amending the act of May 25, 1945 (P.L.1050, No.394), known as the Local Tax Collection Law, further providing for interim assessment, duplicate and warrant, for discounts, penalties and notice, and for collectors required to be in attendance. (Representatives STEPHENS, BROWN, MALAGARI and others) - Finance, May 26, 2020

**OVER** 

This bill amends the Local Tax Collection Law to provide school district real estate tax relief for assessments issued for 2020.

HOUSE

2484 3804 An Act amending Titles 15 (Corporations and Unincorporated Associations) and 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, establishing financial restrictions related to the COVID-19 emergency: in financial matters of domestic nonprofit corporations, further providing for investment of trust funds; and in principal and income, further providing for charitable trusts. (Representative WHITE) - Finance, May 28, 2020


VOTE

This bill amends Title 15 & 20 to increase spending limitations for nonprofit corporations and charitable trusts.

#### SECOND CONSIDERATION FINANCE BILLS

HOUSE **2497** 3795

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives DUNBAR, PEIFER, GREINER and others) - Finance, May 26, 2020 3



This bill amends the Tax Reform Code to exempt an amount of loan forgiveness granted under the federal Coronavirus Aid Act from taxation.

#### SECOND CONSIDERATION HEALTH BILLS

HOUSE 1912 2660

An Act amending the act of June 29, 1953 (P.L.304, No.66), known as the Vital Statistics Law of 1953, in records, further providing for records and fees for copies. (Representatives ZIMMERMAN, READSHAW, JAMES and others) - Health, April 28, 2020

**OVER** 

This bill amends the Vital Statistics Law to eliminate the fee for a death certificate for coroners in the performance of their official duties for unclaimed bodies.

SENATE 1110 1702

An Act amending the act of April 23, 1956 (1955 P.L.1510, No.500), known at the Disease Prevention and Control Law of 1955, further providing for reports and for confidentiality of reports and records; and providing for confidentiality provisions during disaster emergency. (Senators K. WARD, PHILLIPS-HILL, COLLETT and others) - Health, May 27, 2020

**OVER** 

This bill amends the Disease Prevention and Control Act.

#### SECOND CONSIDERATION HUMAN SERVICES BILLS

HOUSE 1363 3796

An Act establishing a bill of rights for individuals with intellectual disabilities or autism; and conferring powers and duties on the Department of Human Services. (Representatives MURT, DONATUCCI, STEPHENS and others) - Human Services, May 28, 2020

C

This bill establishes a bill of rights for individuals with intellectual disabilities or autism.

#### SECOND CONSIDERATION HUMAN SERVICES BILLS

HOUSE 2187

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in children and youth, providing for Statewide children's mental health ombudsman. (Representatives GALLOWAY, T. DAVIS, ULLMAN and others) – Human Services, May 28, 2020

OVER

This bill provides for a Statewide children's mental health ombudsman.

HOUSE 2331

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in mental health: departmental powers and duties, commissioner of mental health, interstate compact, reciprocal agreements, research foundation, providing for mental health care services clearinghouse; and making an editorial change. (Representatives GALLOWAY, MURT, DONATUCCI and others) - Human Services, May 28, 2020

**OVER** 

This bill provides for mental health care services clearinghouse.

## SECOND CONSIDERATION INSURANCE BILLS

HOUSE **564** 

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, further providing for prompt payment of claims. (Representatives SAYLOR, RYAN, BARRAR and others) - Rules, May 26, 2020

OVER

This bill provides for prompt payment of claims.

HOUSE 1862

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in quality health care accountability and protection, providing for protections for consumers receiving surprise balance bills for health care services from out-of-network providers. (Representatives PICKETT, DeLUCA, BROWN and others) – Insurance, April 27, 2020

**OVER** 

This bill provides for protections for consumers receiving surprise balance bills from health care services from out-of-network providers.

#### SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 111 1630

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives SCHEMEL, McCLINTON, ISAACSON and others) – Judiciary, May 20, 2020

**OVER** 

This bill is a Joint Resolution amending Article V of the PA Constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts and establishing the Appellate Court Nominating Commission.

HOUSE 1555 3006

Amending Titles 42 (Judiciary and Judicial Procedure) and 61 (Prisons and Parole) of the Pennsylvania Consolidated States, in sentencing, further providing for order of probation and for modification or revocation of order of probation; in other criminal provisions, further providing for definitions and for supervisory relationship to offenders; and, in Pennsylvania Board of Probation and Parole, further providing for supervisory relationship to offenders. (Representatives DELOZIER, HARRIS, JONES and others) – Judiciary, May 14, 2020

**OVER** 

This bill amends Title 42 to limit probationary terms, set forth a procedure for the courts to apply when addressing probation violations, restricting the sanctions for probation violators, providing various means by which a person on probation can reduce the length of that probation, and applying these changes retroactively.

HOUSE 1655

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in riot, disorderly conduct and related offenses, providing for concurrent jurisdiction to prosecute. (Representatives ISAACSON, STEPHENS, CIRESI and others) – Judiciary, May 20, 2020

OVER

This bill creates Section 5562 in Title 18 to provide that the Attorney General has concurrent jurisdiction to investigate and institute criminal proceedings under chapter 55, subchapter B.

HOUSE 1851 2573

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, further providing for sentences for offenses committed with firearms and providing for sentences for persons not to possess, use, manufacture, control, sell or transfer firearms.. (Representatives STEPHENS, QUINN, BERNSTINE and others) – Judiciary, May 18, 2020 6

OVER

This bill amends two provisions in Title 42 to require mandatory minimum sentences for felons convicted of illegally possessing a firearm and to expand the definition of the term "crime of violence" to include the offense of a felon in possession of a firearm.

#### SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 2040 2867

An Act providing for the PA Second Chance Jobs website and for powers and duties of the Department of Labor and Industry. (Representatives HARRIS, LEWIS, DELLOSO and others) – Judiciary, May 14, 2020

**OVER** 

This bill creates the PA Second Chance Jobs website to provide a free and voluntary website where employers may advertise employment opportunities for former offenders.

**SENATE 502** 

1424

An Act amending the act of November 24, 1998 (P.L.882, No.111), known as the Crime Victims Act, in preliminary provisions, further providing for definitions; in crime victims, further providing for rights, for responsibilities of victims of crime under basic bill of rights, for responsibilities of State and local law enforcement agencies and for responsibilities of prosecutor's office; in administration, further providing for office, for powers and duties of victim advocate and for powers and duties of Office of Victims' Services; in parole advocacy, further providing for preparole notification to victim and for petitions to deny parole upon expiration of minimum sentence; in compensation, further providing for persons eligible for compensation, for filing of claims for compensation, for minimum allowable claim, for determination of claims, for emergency awards, for awards and for confidentiality of records; in services, further providing for eligibility of victims; in financial matters, further providing for costs and for costs for offender supervision programs; and, in enforcement, further providing for subrogation. (Senators BARTOLOTTA, HUGHES, HAYWOOD and others) - Judiciary, May 13, 2020

**OVER** 

This bill amends the Crime Victims Act to make omnibus changes to victims' rights and compensation.

## SECOND CONSIDERATION LABOR & INDUSTRY BILL

**HOUSE 785** 

An Act amending the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, further providing for definitions; in employee rights, providing for payments to employee organizations; and making related repeals. (Representatives KLUNK, RYAN, MOUL and others) – Labor & Industry, May 27, 2020 2

OVER

This bill amends the Public Employee Relations Act to require specific disclosure of employee rights; repeals unenforceable laws related to fair share fees.

## SECOND CONSIDERATION LOCAL GOVERNMENT BILLS

HOUSE **188** 

An Act providing for property owner's bill of rights statement.

(Representatives QUINN, COX, SIMMONS and others) - Local Government, April 29, 2020

**OVER** 

This bill provides for property owner's bill of rights statement.

HOUSE 1074 1614

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in municipal authorities, providing for governing bodies of airport authorities located in counties of the second class. (Representatives TURZAI, HENNESSEY, RYAN and others) - Local Government, May 19, 2020 5

OVER

This bill provides for governing bodies of airport authorities located in counties of the second class.

#### SECOND CONSIDERATION PROFESSIONAL LICENSURE BILLS

HOUSE 1566 1980

An Act amending the act of July 2, 1993 (P.L.345, No.48), entitled "An act empowering the General Counsel or his designee to issue subpoenas for certain licensing board activities; providing for hearing examiners in the Bureau of Professional and Occupational Affairs; providing additional powers to the Commissioner of Professional and Occupational Affairs; and further providing for civil penalties and license suspension," further providing for civil penalties. (Representatives KORTZ, KINSEY, MERSKI and others) - Professional Licensure, April 30, 2020 12

OVER

This bill provides for hearing examiners in the Bureau of Professional and Occupational Affairs.

HOUSE 1947

2727

An Act amending the act of December 20, 1985 (P.L.457, No.112), known as the Medical Practice Act of 1985, further providing for license without restriction. (Representatives KAUFER, BERNSTINE, PICKETT and others) – Professional Licensure, April 30, 2020

AOLE

This bill provides for license without restriction.

#### SECOND CONSIDERATION PROFESSIONAL LICENSURE BILLS

HOUSE 2101 3257

An Act amending the act of May 23, 1945 (P.L.913, No.367), known as the Engineer, Land Surveyor and Geologist Registration Law, further providing for definitions, for procedure for licensing as professional engineer, for continuing professional competency requirements and for exemption from licensure and registration. (Representatives EMRICK, GILLEN, JOZWIAK and others) - Professional Licensure, May 5, 2020



This bill provides for definitions, for continuing professional competency requirements and for exemption form licensure and registration.

#### SECOND CONSIDERATION STATE GOVERNMENT BILLS

**HOUSE 995** 

An Act amending Title 71 (State Government) of the Pennsylvania Consolidated Statutes, providing for regulatory review and for regulatory reduction pilot program; and making an editorial change. (Representatives LEWIS, KENYATTA, GROVE and others) - State Government, May 19, 2020 5

OVER

This bill amends Title 71 to provide for regulatory review and for regulatory pilot program.

**HOUSE** 

1874 3534 An Act amending the act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act, further providing for definitions and for classification of documents. (Representatives GROVE, JONES, MILLARD and others) – State Government, May 19, 2020

**OVER** 

This bill provides for review of regulatory actions.

HOUSE 2039 2866

An Act amending the act of December 20, 2015 (P.L.497, No.90), known as the Taxpayer-Funded Advertising Transparency Act, further providing for definitions and for advertising notification; and making a related repeal. (Representatives ORTITAY, OWLETT, RYAN and others) - State Government, April 27, 2020 15

OVER

This bill amends the Taxpayer-Funded Advertising Transparency Act, which requires certain notifications in media advertising.

#### SECOND CONSIDERATION STATE GOVERNMENT BILLS

HOUSE 2431

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, providing for local taxation on real property, for reopening of 2019-2020 school district budgets and for charter school tuition rate for the 2020-2021 school year. (Representatives GLEIM, CUTLER, LEWIS and others) – State Government, May 5, 2020

**OVER** 

This bill provides for local taxation on real property and for reopening of 2019-2020 school district budgets.

**2465** 

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in the Governor and disaster emergencies, further providing for general authority of Governor. (Representatives B. MILLER, ECKER, ROTHMAN and others) – State Government, May 12, 2020

**OVER** 

This bill amends Title 35 to add provisions relating to posting requirements during a disaster declaration.

**SENATE 412** 

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, repealing provisions relating to disqualifications for service as election officer. (Senators STEFANO, FOLMER, SCHWANK and others) - State Government, May 19, 2020 5

OVER

This bill proposes an amendment to the Constitution of the Commonwealth of Pennsylvania, repealing provisions relating to disqualifications for service as election officer.

**SENATE 703** 

1625

An Act amending Title 45 (Legal Notices) of the Pennsylvania Consolidated Statutes, in publication and effectiveness of Commonwealth documents, further providing for Joint Committee on Documents. (Senator SCARNATI) - State Government, May 19, 2020

OVER

This bill amends Title 45 to provide for Joint Committee on Documents.

#### SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE 1754 234

An Act designating a bridge on that portion of State Route 4021 over the Honeoye Creek, Sharon Township, Potter County, as the Tec 5 C. Virgil Voorhees Memorial Bridge. (Representatives CAUSER, BURNS, CALTAGIRONE and others) - Transportation, April 27, 2020

**OVER** 

This bill designates a bridge on a portion of S.R. 4021 in Potter County as the Tec 5 C. Virgil Voorhees Memorial Bridge.

HOUSE 2123 3149

An Act designating the Faxon Interchange of Interstate 180 at Northway Road in Loyalsock Township, Lycoming County, as the Sgt. Thomas Woodruff, Sr., and Sgt. Hamilton Woodruff Memorial Interchange. (Representatives WHEELAND, BURNS, HENNESSEY and others) - Transportation, May 4, 2020

OVER

This bill designates the Faxon Interchange of Interstate 180 in Lycoming County as the United States Army Sgt. Thomas H. Woodruff, Sr., and United States Marine Corps Sgt. Hamilton T. Woodruff Memorial Interchange.

SENATE

**607** 1384 An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in rules of the road in general, further providing for speed timing devices. (Senators SCAVELLO, MARTIN, BROWNE and others) - Transportation, May 5, 2020 10

OVER

This bill amends Title 75 to provide for speed timing devices.

#### SECOND CONSIDERATION URBAN AFFAIRS BILL

HOUSE 122 1012

An Act amending Title 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in home inspections, further providing for home inspection reports. (Representatives KORTZ, HELM, READSHAW and others) - Urban Affairs, May 13, 2020

OVER

This bill provides for home inspection reports.

## SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. RILLS

VETERANS AFFAIRS & EMERGENCY PREP. BILLS **HOUSE** An Act amending the act of June 2, 1915 (P.L.736, No.338), **432** OVER known as the Workers' Compensation Act, in interpretation and 2568 definitions, further providing for definitions; and, in liability and compensation, further providing for compensation for post-traumatic stress injury. (Representatives BARRAR, SAINATO, BIZZARRO and others) - Veterans Affairs & Emergency Preparedness, May 26, 2020 This bill requires post-traumatic stress injuries to be compensable under workers compensation for first responders, including 911 center dispatchers and call takers, and corrections officers. HOUSE An Act amending Title 35 (Health and Safety) of the OVER Pennsylvania Consolidated Statutes, in emergency management services, providing for emergency response payment. (Representatives DUSH, JOZWIAK, GREINER and others) - Veterans Affairs & **Emergency Preparedness, May 26, 2020** This bill authorizes Volunteer Fire Departments to bill for real and reasonable costs. **HOUSE** An Act regulating certain smoke alarms; providing for dwelling 1236 OVER unit owner and tenant responsibilities; and prescribing penalties. (Representatives POLINCHOCK, FARRY. **CIRESI** others) - Veterans Affairs & Emergency Preparedness, April 27, 2020 This bill creates the "Smoke Alarm Device Responsibility" Act by requiring approved smoke alarm devices that have nonremovable batteries with at least a 10-year life span.

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in casualty insurance, further providing for billing. (Representatives MASSER, WHEELAND, IRVIN and others) - Veterans Affairs & Emergency Preparedness, May 26, 2020

This bill requires insurance carriers to reimburse ambulance companies directly that are not in the insurance carrier's network.

#### THIRD CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILLS

**HOUSE** 1037

An Act amending the act of November 10, 1999 (P.L.491, No.45), known as the Pennsylvania Construction Code Act, in preliminary 1836 provisions, further providing for definitions and for application; and, in exemptions, applicability and penalties, further providing for penalties. (Representatives LAWRENCE, CAUSER, BERNSTINE and others) - Appropriations, April 28, 2020 Fiscal-Note **Attached** 

OVER

This bill amends the PA Construction Code Act to exempt historic agricultural buildings, when used for private events and meeting certain safety provisions, from the provisions of the code.

HOUSE

1348

An Act providing for limited civil liability for agritourism activity providers, for notice of limited civil liability and for acknowledgment of limited civil liability. (Representatives GLEIM, GREINER, CAUSER and others) - Appropriations, May 18, 2020 Fiscal-Note **Attached** 

OVER

This bill creates limited liability protection for agritourism activity providers.

**HOUSE** 

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for emergency 3612 COVID-19 provisions. (Representatives MUSTELLO, KLUNK, DIAMOND and others) - Appropriations, April 30, 2020 Fiscal-Note **Attached** 

OVER

This bill amends the Administrative Code to add a new Article relating to Emergency COVID-19 provisions regarding extension of waiver provisions to animal grooming services.


