SECOND CONSIDERATION **FINANCE BILLS**

HOUSE 230

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in Independent Fiscal 385 Office, further providing for revenue estimates. (Representatives RYAN, KAUFFMAN, STAATS and others) - Finance, February 26, 2021

This bill amends the Administrative Code to require the IFO to prepare, upon request, a revenue estimate for a proposed bill or an amendment expected to carry a fiscal impact that exceeds \$25 million.

HOUSE

273

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in realty transfer tax, correcting a scrivener's error relating to credits against tax. (Representatives PEIFER, FRITZ, GREINER and others) - Finance, February 26, 2021

This bill amends the Tax Reform Code to correct a scrivener's error.

HOUSE

359

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, **providing for exemption from taxation.** (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) - Finance, February 26, 2021

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

SECOND CONSIDERATION FINANCE BILLS

HOUSE 385

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives DUNBAR, ROTHMAN, BROOKS and others) - Finance, February 26,

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

SECOND CONSIDERATION **JUDICIARY BILLS**

HOUSE 103

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, providing for the 73 offense of harassment of law enforcement officer; and imposing penalties. (Representatives SCHMITT, BOBACK, MIZGORSKI and others) - Judiciary, February 26, 2021

This bill amends Title 18 to provide for the offense of harassment of law enforcement officer.

HOUSE 146

An Act amending Title 61 (Prisons and Parole) of the Pennsylvania Consolidated Statutes, in Pennsylvania Board of 112 Probation and Parole, further providing for parole power. (Representatives BERNSTINE, SAINATO, KAUFFMAN others) - Judiciary, February 26, 2021 2

This bill amends Title 61 to provide for parole power.

HOUSE 156

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in depositions and 121 witnesses, further providing for admissibility of certain statements. (Representatives OWLETT. KAUFFMAN. STEPHENS others) - Judiciary, February 26, 2021 2

This bill amends Title 42 to provide for admissibility of certain statements.

HOUSE 163

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in other offenses, further providing for the offense of invasion of privacy. (Representatives STAATS, LABS, SCHLEGEL CULVER and others) - Judiciary, **February 26, 2021**

This bill amends Title 18 to provide for the offense of invasion of privacy.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE **184**

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in criminal homicide, further providing for the offense of causing or aiding suicide. (Representatives KEEFER, ECKER, METCALFE and others) – Judiciary, February 26, 2021

This bill amends Title 18 to provide for the offense of causing or aiding suicide.

HOUSE 185

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, further providing for the offense of aggravated assault. (Representatives STRUZZI, KAUFFMAN, BOBACK and others) – Judiciary, February 26, 2021

This bill amends Title 18 to provide for the offense of aggravated assault.

HOUSE 26

An Act designating a bridge, identified as Bridge Key 43976, on that portion of State Route 1010 over Chatham Run, Pine Creek Township, Clinton County, as the Tech. Corporal Lee R. Phillips Memorial Bridge. (Representatives BOROWICZ, HENNESSEY, CAUSER and others) - Transportation, February 26, 2021

HOUSE 125

An Act designating a bridge, identified as Bridge Key 1951, carrying State Route 4017 on Wetzel Road, Shaler Township, Allegheny County, as the Commander William J. Schofield, III, Memorial Bridge. (Representatives MIZGORSKI, HENNESSEY, KNOWLES and others) - Transportation, February 26, 2021 2

This bill designates a bridge carrying State Route 4017 on Wetzel Road, Shaler Township, Allegheny County, as the Commander William J. Schofield, III, Memorial Bridge.

HOUSE **140**

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in rules of the road in general, further providing for additional parking regulations. (Representatives MALONEY, LONGIETTI, SANCHEZ and others) - Transportation, February 26, 2021

This bill amends Title 75 to establish Protected Pedestrian Plazas and Pedalcycle Lanes.

HOUSE **148**

An Act designating a bridge, identified as Bridge Key 25488, carrying State Route 1011 over the Mix Creek, Eldred Township, McKean County, as the Sgt. Neil K. Dorrion Memorial Bridge. (Representatives CAUSER, ARMANINI, BURNS and others) - Transportation, February 26, 2021

This bill designates a bridge carrying State Route 1011 over the Mix Creek, Eldred Township, McKean County, as the Sgt. Neil K. Dorrion Memorial Bridge.

An Act designating a bridge, identified as Bridge Key 8391, on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) – Transportation, February 26, 2021

This bill designates a bridge on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge.

An Act designating the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway. (Representatives SANCHEZ, BURNS, RYAN and others) - Transportation, February 26, 2021 2

This bill designates the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway.

HOUSE **152**

An Act designating a bridge, identified as Bridge Key 43267, on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) - Transportation, February 26, 2021

This bill designates a bridge on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge.

(Representatives BURNS, HENNESSEY, GUENST and others) - Transportation, February 26, 2021 2

This bill designates a bridge on that portion of U.S. Route 219 over Pennsylvania Route 53, also known as Railroad Street, in Croyle Township, Cambria County, as the Janice Keen-Livingston First Responders' Memorial Bridge.

An Act amending Title 51 (Military Affairs) of the Pennsylvania

Affairs & Emergency Preparedness, February 26, 2021 2

This bill provides for employment protections to PA residents who are members of a National Guard or Reserve unit in another state.
