SECOND CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILL

HOUSE 755

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, in food protection, further providing for rules and regulations. (Representatives DAY, BURGOS, CAUSER and others) - Agriculture & Rural Affairs, March 23, 2021

OVER

This bill requires food establishments producing bottled water to comply with federal and state requirements.

SECOND CONSIDERATION EDUCATION BILL

HOUSE 232

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school districts, further providing for how constituted. (Representatives MUSTELLO, STRUZZI, ROWE and others) – Education, March 17, 2021

OVER

This bill amends the Public School Code to permit a school district to change its name.

SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

HOUSE 754

An Act amending the act of May 1, 1984 (P.L.206, No.43), known as the Pennsylvania Safe Drinking Water Act, further providing for definitions. (Representatives DAY, BURGOS, CAUSER and others) - Environmental Resources & Energy, March 23, 2021

OVER

This bill amends the Safe Drinking Water Act to exclude facilities that bottle water for human consumption registered with the Department of Agriculture as food establishments from the definition of a "public water system".

SECOND CONSIDERATION FINANCE BILLS

HOUSE 359

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, providing for exemption from taxation. (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) - Finance, February 26, 2021

OVER

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

385

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives DUNBAR, ROTHMAN, BROOKS and others) - Finance, February 26, 2021

OVER

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

SECOND CONSIDERATION HEALTH BILLS

HOUSE

An Act relating to the administration and distribution of COVID-19 vaccinations in this Commonwealth. (Representatives LAWRENCE AND OWLETT) - Health, March 23, 2021 1

VOIE

This bill provides for administration and distribution of COVID-19 vaccinations.

SECOND CONSIDERATION HEALTH BILLS

HOUSE **649**

An Act providing for access to congregate care facilities for essential caregivers, for additional safety requirements for residents of congregate care facilities, for suspension of access for essential caregivers and for personal protective equipment for essential caregivers. (Representatives RAPP, ZIMMERMAN, COX and others) - Health, March 23, 2021

(C)

This bill creates a stand-alone act pertaining to access to long-term care nursing facilities for essential caregivers.

SECOND CONSIDERATION STATE GOVERNMENT BILL

HOUSE 71

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, providing for spending limitations on the Commonwealth. (Representatives WARNER, DAVANZO, DIAMOND and others) - State Government, March 22, 2021

OVER

This is a Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, providing for spending limitations on the Commonwealth.

HOUSE

148

An Act designating a bridge, identified as Bridge Key 25488, carrying State Route 1011 over the Mix Creek, Eldred Township, McKean County, as the Sgt. Neil K. Dorrion Memorial Bridge. (Representatives CAUSER, ARMANINI, BURNS and others) - Transportation, February 26, 2021

OVER

This bill designates a bridge carrying State Route 1011 over the Mix Creek, Eldred Township, McKean County, as the Sgt. Neil K. Dorrion Memorial Bridge.

HOUSE

149

An Act designating a bridge, identified as Bridge Key 39504, carrying Pennsylvania Route 3004 over the Allegheny River, Roulette Township, Potter County, as the SSG Gerrith Kibbe Memorial Bridge. (Representatives CAUSER, BURNS, CONKLIN and others) - Transportation, February 26, 2021

OVER

This bill designates a bridge carrying Pennsylvania Route 3004 over the Allegheny River, Roulette Township, Potter County, as the SSG Gerrith Kibbe Memorial Bridge.

SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE 150

An Act designating a bridge, identified as Bridge Key 8391, on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) – Transportation, February 26, 2021

OVER

This bill designates a bridge on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge.

HOUSE

151

An Act designating the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway. (Representatives SANCHEZ, BURNS, RYAN and others) - Transportation, February 26, 2021

OVER

This bill designates the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway.

HOUSE **152**

An Act designating a bridge, identified as Bridge Key 43267, on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and

others) - Transportation, February 26, 2021

OVER

This bill designates a bridge on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge.

HOUSE

334

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing for display of registration plate. (Representatives JOZWIAK, HENNESSEY, MILLARD and others) – Transportation, March 23, 2021

VOIE

This bill amends Title 75 to reinstate the issuance of a validating registration sticker that is placed on the license plate of a vehicle.

SECOND CONSIDERATION TRANSPORTATION BILLS


An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in rules of the road in general, further providing for speed timing devices. (Representatives ROTHMAN, SCHLEGEL CULVER, HICKERNELL and others) - Transportation, March 23, 2021

VOTE

This bill amends Title 75 to permit local police departments to use RADAR/LIDAR devices for speed enforcement.

SENATE 49

An Act designating the bridge, identified as Bridge Key 8659, carrying State Route 3037, also known as William Penn Avenue, over the Norfolk Southern and Lehigh Valley Rail Management rail lines in the City of Johnstown, Cambria County, as the Reverend Andrew William Tilly, Jr., Bridge. (Senator LANGERHOLC) - Transportation, March 23, 2021



This bill designates a bridge carrying State Route 3037, also known as William Penn Avenue, over the Norfolk Southern and Lehigh Valley Rail Management rail lines in the City of Johnstown, Cambria County, as the Reverend Andrew William Tilly, Jr., Bridge.

An Act designating the bridge, identified as Bridge Key 8365, carrying Pennsylvania Route 53 over Little Conemaugh River in Croyle Township, Cambria County, as the Private Fredrick Kinley Memorial Bridge. (Senator LANGERHOLC) - Transportation, March 23, 2021



This bill designates a bridge carrying Pennsylvania Route 53 over Little Conemaugh River in Croyle Township, Cambria County, as the Private Fredrick Kinley Memorial Bridge.

SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILL

HOUSE 491

An Act amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, providing for the exclusion of veterans' benefit payments from income for Commonwealth programs. (Representatives BOBACK, HAMM, HILL-EVANS and others) - Veterans Affairs & Emergency Preparedness, March 23, 2021



This bill excludes veterans benefits/pension funds as income for state benefit programs that have an income qualifications threshold.

SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILL

HOUSE 803

An Act amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, in National Guard Youth Challenge Program, further providing for definitions and for administration, establishing the Keystone State Challenge Academy Fund and further providing for report and for audit required. (Representatives O'NEAL, SAYLOR, HERSHEY and others) - Veterans Affairs & Emergency Preparedness, March 23, 2021

VOTE

This bill establishes the Keystone State Challenge Academy Special Fund for the PA National Guard Youth Challenge Program.

THIRD CONSIDERATION JUDICIARY BILL

SENATE

87

An Act amending Titles 18 (Crimes and Offenses), 23 (Domestic Relations) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in minors, further providing for the offense of sexual abuse of children; in child protective services, providing for task force on child pornography; and, in sentencing, further providing for sentencing for offenses involving sexual abuse of children. (Senators BAKER, ARNOLD, VOGEL and others) - Appropriations, March 22, 2021 Fiscal-Note Attached

OVER

This bill amends Titles 18 and Title 42 to provide for enhanced sentencing of defendants convicted of child pornography if the child victim is under 10 years of age or prepubescent and further amends Title 23 to create the Task Force on Child Pornography.
