This bill amends the Safe Drinking Water Act to exclude facilities that bottle water for human consumption registered with the Department of Agriculture as food establishments from the definition of a "public water system".

OVER

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

357 An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the **Tax Reform Code of 1971**, in personal income tax, further **providing for classes of income.** (Representatives DUNBAR, ROTHMAN, BROOKS and others) - **Finance, February 26, 2021** **8**

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.
