SECOND CONSIDERATION EDUCATION BILL

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school districts, further providing for how constituted. (Representatives MUSTELLO, STRUZZI, ROWE and others) – Education, March 17, 2021

OVER

This bill amends the Public School Code to permit a school district to change its name.

SECOND CONSIDERATION FINANCE BILLS

HOUSE 48

An Act amending Title 72 (Taxation and Fiscal Affairs) of the Pennsylvania Consolidated Statutes, providing for financial transparency. (Representatives GROVE, JONES, RYAN and others) - Finance, April 7, 2021

C)

This bill provides to codify the Treasurer's Transparency Portal.

HOUSE **359**

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, providing for exemption from taxation. (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) - Finance, February 26, 2021

OVER

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

SECOND CONSIDERATION FINANCE BILLS

HOUSE 385

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives DUNBAR, ROTHMAN, BROOKS and others) - Finance, February 26, 2021

OVER

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

HOUSE 423

An Act repealing the act of July 12, 1935 (P.L.970, No.314), entitled "An act imposing a graduated income tax for school purposes on residents of Pennsylvania including fiduciaries and on income of nonresidents derived from property or business in Pennsylvania; defining taxable income and requiring filing of returns thereof; providing for the assessment, collection and lien of said tax and for the disposition of proceeds thereof; providing for administration and enforcement of the act by the Department of Revenue; conferring powers and imposing duties on certain persons, partnerships, associations, corporations, school districts, State officers, employes and departments; imposing penalties; and appropriating the revenues derived from said tax." (Representatives ROWE, BERNSTINE, JAMES and others) - Finance, April 7, 2021

C)

This bill repeals the defunct individual Net Income Tact of of 1935.

HOUSE 430

An Act amending the act of May 25, 1945 (P.L.1050, No.394), known as the Local Tax Collection Law, further providing for effect of failure to receive tax notice. (Representatives EMRICK, GREINER, MILLARD and others) – Finance, April 7, 2021

OVER

This bill eliminates the Property Tax Penalty if property tax bill is not received during the first year of ownership.

SECOND CONSIDERATION LOCAL GOVERNMENT BILL

HOUSE **664**

An Act amending Titles 53 (Municipalities Generally) and 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in preemptions, providing for businesses operated by minors; and, in general provisions relating to planned communities, providing for businesses operated by minors. (Representatives HERSHEY, FEE, GILLEN and others) - Local Government, April 7, 2021

C)

This bill allows minors to operate a lemonade stand, or other small business, without receiving a business license from their municipality of HOA.

SECOND CONSIDERATION STATE GOVERNMENT BILL

HOUSE 71

47 A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, providing for spending limitations on the Commonwealth. (Representatives WARNER, DAVANZO, DIAMOND and others) - State Government, March 22, 2021 6

OVER

This is a Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, providing for spending limitations on the Commonwealth.

SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE 37

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in licensing of drivers, further providing for learners' permits and for examination of applicant for driver's license; in rules of the road in general, further providing for prohibiting text-based communications, providing for prohibiting use of interactive wireless communications devices and imposing penalties; and, in operation of vehicles miscellaneous provisions, further providing for the offense of homicide by vehicle and for the offense of aggravated assault by vehicle. (Representatives R. BROWN, MALAGARI, BOBACK and others) - Transportation, April 5, 2021

OVER

This bill bans the use of handheld cellphones while driving.

SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE 150

An Act designating a bridge, identified as Bridge Key 8391, on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) – Transportation, February 26, 2021

OVER

This bill designates a bridge on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge.

HOUSE

151

An Act designating the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills

Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway. (Representatives SANCHEZ, BURNS, RYAN and others) - Transportation, February 26, 2021 11

OVER

This bill designates the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway.

HOUSE **152**

An Act designating a bridge, identified as Bridge Key 43267, on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) - Transportation, February 26, 2021

OVER

This bill designates a bridge on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge.

HOUSE

832

An Act designating a bridge, identified as Bridge Key 37135, located on Pennsylvania Route 92 over the Susquehanna River, Falls Township, Wyoming County, as the Falls Veterans Memorial Bridge. (Representatives BOBACK, CAUSER, BURNS and others) - Transportation, April 5, 2021

OVER

This bill designates a bridge located on Pennsylvania Route 92 over the Susquehanna River, Falls Township, Wyoming County, as the Falls Veterans Memorial Bridge.

SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE **877**

An Act designating a bridge, identified as Bridge Key 45998, carrying State Route 2027 in North Union Township, Fayette County, as the SSG Willis J. Crayton Memorial Bridge. (Representatives WARNER, SONNEY, ROTHMAN and others) - Transportation, April 5, 2021

OVER

This bill designates a bridge carrying State Route 2027 in North Union Township, Fayette County, as the SSG Willis J. Crayton Memorial Bridge.

HOUSE 929

An Act designating a roundabout at Pennsylvania Route 34, Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout. (Representatives STAMBAUGH, BURNS, CONKLIN and others) - Transportation, April 5, 2021 3

OVER

This bill designates a roundabout at Pennsylvania Route 34, Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout.

SENATE

96

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing for contributions to Veterans' Trust Fund. (Senators ROBINSON, MARTIN, BARTOLOTTA and others) - Transportation, April 5, 2021


OVER

This bill increases contribution amounts to the Veterans Trust Fund.

THIRD CONSIDERATION JUDICIARY BILLS

HOUSE **184**

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in criminal homicide, further providing for the offense of causing or aiding suicide. (Representatives KEEFER, RYAN, ECKER and others) – Appropriations, April 07, 2021 Fiscal-Note Attached



This bill provides for the offense of causing or aiding suicide.

THIRD CONSIDERATION JUDICIARY BILLS

SENATE 87

An Act amending Titles 18 (Crimes and Offenses), 23 (Domestic Relations) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in minors, further providing for the offense of sexual abuse of children; in child protective services, providing for task force on child pornography; and, in sentencing, further providing for sentencing for offenses involving sexual abuse of children. (Senators BAKER, ARNOLD, VOGEL and others) - Appropriations, March 22, 2021 Fiscal-Note Attached

OVER

This bill amends Titles 18 and Title 42 to provide for enhanced sentencing of defendants convicted of child pornography if the child victim is under 10 years of age or prepubescent and further amends Title 23 to create the Task Force on Child Pornography.

THIRD CONSIDERATION STATE GOVERNMENT BILL

746

An Act limiting assignment of State-owned vehicles. (Representatives ROAE, ROWE, THOMAS and others) – Appropriations, April 05, 2021 Fiscal-Note Attached 3

OVER

This bill establishes limitations on State-Owned vehicles used by Members of the General Assembly.

THIRD CONSIDERATION TRANSPORTATION BILL

HOUSE **607**

An Act amending the act of June 25, 1931 (P.L.1352, No.332), referred to as the Delaware River Joint Toll Bridge Compact, providing for veto power by the Governor over certain actions; further providing for audits; and providing the Governor of each state with power to ratify or veto certain actions taken by commissioners. (Representatives EMRICK, CIRESI, FREEMAN and others) - Appropriations, April 07, 2021 Fiscal-Note Attached 1

OVER

This bill provides for veto power by the Governor over certain actions; further providing for audits; and providing the Governor of each state with power to ratify or veto certain actions taken by commissioners.

HOUSE 19

A Resolution honoring the life and legacy of Dr. Martin Luther King, Jr., and recognizing the week of January 18 through 24, 2021, as "Martin Luther King, Jr., Week of Remembrance" in Pennsylvania. (Representatives GAINEY, HENNESSEY, HILL-EVANS and others) – State Government, January 28, 2021
