SECOND CONSIDERATION EDUCATION BILL

HOUSE 232 844 An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school districts, further providing for how constituted. (Representatives MUSTELLO, STRUZZI, ROWE and others) – Education, March 17, 2021 8

This bill amends the Public School Code to permit a school district to change its name.

SECOND CONSIDERATION FINANCE BILLS

HOUSE 359 331

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, providing for exemption from taxation. (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) – Finance, February 26, 2021 12

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

SECOND CONSIDERATION **FINANCE BILLS**



An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further 357 providing for classes of income. (Representatives DUNBAR, ROTHMAN, BROOKS and others) - Finance, February 26, 12 2021

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

HOUSE An Act amending the act of May 25, 1945 (P.L.1050, No.394), 430 known as the Local Tax Collection Law, further providing for effect 407 of failure to receive tax notice. (Representatives EMRICK, GREINER, MILLARD and others) - Finance, April 7, 2021

This bill eliminates the Property Tax Penalty if property tax bill is not received during the first year of ownership.

SECOND CONSIDERATION **HUMAN SERVICES BILLS**

HOUSE An Act amending the act of April 9, 1929 (P.L.177, No.175), 220 known as The Administrative Code of 1929, in powers and duties 187 of the Department of Drug and Alcohol Programs, further providing for powers and duties. (Representatives RADER, HOHENSTEIN, MILLARD and others) - Human Services, April 19, 2021 1

This bill clarifies language for admission to drug and alcohol treatment facilities.

HOUSE An Act amending the act of April 9, 1929 (P.L.177, No.175), 741 known as The Administrative Code of 1929, in powers and duties 1153 of the Department of Drug and Alcohol Programs, providing for notification of emergency contact. (Representatives HEFFLEY, HILL-EVANS, T. DAVIS and others) - Human Services, April 19, 2021 1

This bill amends the Administrative Code to provide for duties of the Department of Drug and Alcohol Programs with respect to individuals who leave a recovery house against advice of the staff.

This bill amends the Administrative Code to provide for duties of the Department of Drug and Alcohol Programs with the respect to persons who leave an inpatient treatment facility against medical advice.

An Act designating a bridge, identified as Bridge Key 43267, on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) - Transportation, February 26, 2021 12

This bill designates a bridge on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge.

Troutman Memorial Roundabout. (Representatives STAMBAUGH, BURNS, CONKLIN and others) - Transportation, April 5, 2021 4

This bill designates a roundabout at Pennsylvania Route 34, Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout.

HOUSE 1101 1132 An Act designating a portion of Pennsylvania Route 981 from the intersection with Pennsylvania Route 819 to the intersection with State Route 2021 in Mount Pleasant Township, Westmoreland County, as the Honorable Mike Reese Memorial Highway. (Representatives WARNER, E. NELSON, DAVANZO and others) - Transportation, April 19, 2021 1

This bill establishes the Honorable Mike Reese Memorial Highway.

HOUSE 581 1004 An Act authorizing local taxing authorities to provide for tax exemptions for improvements to deteriorated areas and dwellings to incentivize the creation and improvement of affordable housing units. (Representatives SOLOMON, SANCHEZ, STURLA and others) - Urban Affairs, April 19, 2021 1

This bill creates the Affordable Housing Unit Tax Exemption Act to allow local governments the option of abating property taxes to encourage the development of affordable housing.



THIRD CONSIDERATION JUDICIARY BILL



An Act amending Titles 18 (Crimes and Offenses), 23 (Domestic Relations) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in minors, further providing for the offense of sexual abuse of children; in child protective services, providing for task force on child pornography; and, in sentencing, further providing for sentencing for offenses involving sexual abuse of children. (Senators BAKER, ARNOLD, VOGEL and others) - Appropriations, March 22, 2021 Fiscal-Note Attached 7

This bill amends Titles 18 and Title 42 to provide for enhanced sentencing of defendants convicted of child pornography if the child victim is under 10 years of age or prepubescent and further amends Title 23 to create the Task Force on Child Pornography.


