#### SECOND CONSIDERATION EDUCATION BILL

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school districts, further providing for how constituted. (Representatives MUSTELLO, STRUZZI, ROWE and others) – Education, March 17, 2021

OVER

This bill amends the Public School Code to permit a school district to change its name.

### SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILLS

HOUSE 72

An Act amending the act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act, further providing for definitions, for proposed regulations and procedures for review and for final-form regulations and final-omitted regulations and procedures for review; providing for regulations deemed withdrawn; further providing for procedures for subsequent review of disapproved final-form or final-omitted regulations by the commission; and providing for concurrent resolution required for economically significant regulations. (Representatives KEEFER, MILLARD, ROTHMAN and others) – Environmental Resources & Energy, May 3, 2021

C VOTE

This bill amends the Regulatory Review Act to require economically significant regulations receive approval from the General Assembly before going into effect.

#### **SECOND CONSIDERATION** ENVIRONMENTAL RESOURCES AND ENERGY BILLS

**HOUSE 139** 

An Act providing for the administration of permits by State agencies, for a tracking system for permit applications, for the 104 establishment of permit programs and for annual reports. (Representatives ROTHMAN, SCHMITT, **PICKETT** others) - Environmental Resources & Energy, May 3, 2021 1

 $\mathbf{VOTE}$ 

This bill reforms the administration of permits in the Commonwealth.

**HOUSE 288** 

An Act providing for regulatory compliance. (Representatives O'NEAL, DAVANZO, OWLETT and others) - Environmental Resources & Energy, May 3, 2021

VOTE

This bill establishes Regulatory Compliance Officers within State agencies.

#### **SECOND CONSIDERATION FINANCE BILLS**

**HOUSE** 359

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, **providing for exemption from taxation.** (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) - Finance, February 26, 2021

OVER

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

**HOUSE** 385

An Act amending the act of March 4, 1971 (P.L.6, No.2), known 357 as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives DUNBAR, ROTHMAN, BROOKS and others) - Finance, February 26,

OVER

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

**HOUSE** 

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in computer data center equipment 1310 incentive program, further providing for definitions and for review of application, providing for applicability and for sales and use tax exemption program; imposing duties on the Department of Revenue; and making editorial changes. (Representatives OBERLANDER, MUSTELLO, KAUFER and others) - Finance, May 3, 2021

This bill provides for Data Center Sales and Use Tax Exemption.

#### SECOND CONSIDERATION **HUMAN SERVICES BILL**

HOUSE 1012

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, further 1051 providing for medical assistance payments for institutional care. (Representatives O'NEAL, DELOZIER, FARRY and others) - Human Services, April 21, 2021

OVER

This bill amends the Human Services Code to provide for additional payment allocations for eligible Medical Assistance ventilatory or tracheostomy patients.

#### **SECOND CONSIDERATION** LABOR & INDUSTRY BILL

**HOUSE** 129

An Act amending the act of December 5, 1936 (2nd Sp.Sess., 1937 P.L.2897, No.1), known as the Unemployment Compensation 1311 Law, in determination of compensation, appeals, reviews and procedure, further providing for rules of procedure and for place of hearing. (Representatives COX, GLEIM, JOZWIAK and others) - Labor & Industry, May 3, 2021



This bill amends the Unemployment Compensation Law to require that appeal hearings be held by telephone unless good cause exists to hold an in-person hearing.

#### **SECOND CONSIDERATION** STATE GOVERNMENT BILLS

**HOUSE** 71

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, providing for spending limitations on the Commonwealth. (Representatives WARNER. DAVANZO, DIAMOND others) - State Government, March 22, 2021 10

OVER

This is a Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, providing for spending limitations on the Commonwealth.

HOUSE

An Act amending the act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act, further providing for 1308 definitions and for existing regulations; and establishing the Independent Office of the Repealer and providing for its power and duties. (Representatives KLUNK, DUNBAR, FEE and others) - State Government, May 3, 2021

OVER

This bill provides for definitions and for existing regulations and establishes the *Independent Fiscal Office Of the Repealer and providing for its power and duties.* 

### SECOND CONSIDERATION STATE GOVERNMENT BILLS

**950** 

An Act amending the act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act, further providing for procedures for subsequent review of disapproved final-form or final-omitted regulations. (Representatives METCALFE, ARMANINI, CAUSER and others) – State Government, May 3, 2021

This bill provides for procedures for subsequent review of disapproved final-form of final-omitted regulations.

#### SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE

1019

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in licensing of drivers, further providing for learners' permits and for examination of applicant for driver's license; in rules of the road in general, further providing for prohibiting text-based communications, providing for prohibiting use of interactive wireless communications devices and imposing penalties; and, in operation of vehicles miscellaneous provisions, further providing for the offense of homicide by vehicle and for the offense of aggravated assault by vehicle. (Representatives R. BROWN, MALAGARI, BOBACK and others) - Transportation, April 5, 2021

**OVER** 

This bill bans the use of handheld cellphones while driving.

HOUSE

**150** 

An Act designating a bridge, identified as Bridge Key 8391, on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) – Transportation, February 26, 2021

OVER

This bill designates a bridge on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge.

TRANSPORTATION BILLS	
An Act designating the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway. (Representatives SANCHEZ, BURNS, RYAN and others) - Transportation, February 26, 2021 15	OVER
This bill designates the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway.	
An Act designating a bridge, identified as Bridge Key 43267, on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) - Transportation, February 26, 2021	OVER
This bill designates a bridge on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge.	
An Act amending the act of June 1, 1945 (P.L.1242, No.428), known as the State Highway Law, in construction, improvement, maintenance and repair of State highways, providing for native vegetation along highways. (Representatives B. MILLER, SANCHEZ, STAMBAUGH and others) – Transportation, April 19, 2021	OVER
This bill requires planting of native vegetation along state highways.	
HOUSE 765 An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in powers of department and local authorities, further providing for specific powers of department and local authorities. (Representatives B. MILLER, HAMM, JAMES and others) - Transportation, April 19, 2021 4	OVER
This bill removes indemnification requirements on municipalities.	
HOUSE 877  An Act designating a bridge, identified as Bridge Key 45998, carrying State Route 2027 in North Union Township, Fayette County, as the SSG Willis J. Crayton Memorial Bridge. (Representatives WARNER, SONNEY, ROTHMAN and others) - Transportation, April 5, 2021  7	OVER

This bill designates a bridge carrying State Route 2027 in North Union Township, Fayette County, as the SSG Willis J. Crayton Memorial Bridge.

#### SECOND CONSIDERATION TRANSPORTATION BILLS

**HOUSE 929** 

An Act designating a roundabout at Pennsylvania Route 34, Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout. (Representatives STAMBAUGH, BURNS, CONKLIN and others) - Transportation, April 5, 2021 7

**OVER** 

This bill designates a roundabout at Pennsylvania Route 34, Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout.

HOUSE

An Act designating a portion of Pennsylvania Route 981 from the intersection with Pennsylvania Route 819 to the intersection with State Route 2021 in Mount Pleasant Township, Westmoreland County, as the Honorable Mike Reese Memorial Highway. (Representatives WARNER, E. NELSON, DAVANZO and others) - Transportation, April 19, 2021



This bill establishes the Honorable Mike Reese Memorial Highway.

**SENATE** 

**70** 

An Act designating a bridge, identified as Bridge Key 8556, carrying SR 1008 (Eckenrode Mill Road) over Chest Creek, located in East Carroll Township, Cambria County, as the Kenneth John Ivory Memorial Bridge. (Senator LANGERHOLC) - Transportation, April 19, 2021

OVER

This bill designates a bridge in Cambria County as the Kenneth John Ivory Memorial Bridge.

**SENATE** 

96

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing for contributions to Veterans' Trust Fund. (Senators ROBINSON, MARTIN, BARTOLOTTA and others) – Transportation, April 5, 2021

OVER

This bill increases contribution amounts to the Veterans Trust Fund.

**SENATE 120** 

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in size, weight and load, further providing for conditions of permits and security for damages. (Senator TOMLINSON) - Transportation, April 19, 2021

**OVER** 

This bill establishes requirements for the permitted movement of dozer blades.

### THIRD CONSIDERATION JUDICIARY BILL

SENATE 87

An Act amending Titles 18 (Crimes and Offenses), 23 (Domestic Relations) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in minors, further providing for the offense of sexual abuse of children; in child protective services, providing for task force on child pornography; and, in sentencing, further providing for sentencing for offenses involving sexual abuse of children. (Senators BAKER, ARNOLD, VOGEL and others) - Appropriations, March 22, 2021 Fiscal-Note Attached

**OVER** 

This bill amends Titles 18 and Title 42 to provide for enhanced sentencing of defendants convicted of child pornography if the child victim is under 10 years of age or prepubescent and further amends Title 23 to create the Task Force on Child Pornography.

### THIRD CONSIDERATION STATE GOVERNMENT BILL

**HOUSE 746** 

An Act limiting assignment of State-owned vehicles. ROAE, ROWE, THOMAS and others) - Appropriations, April 05, 2021 Fiscal-Note Attached 7

OVER

This bill establishes limitations on State-Owned vehicles used by Members of the General Assembly.
