### SECOND CONSIDERATION EDUCATION BILLS

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school districts, further providing for how constituted. (Representatives MUSTELLO, STRUZZI, ROWE and others) - Education, March 17, 2021 13

OVER

This bill amends the Public School Code to permit a school district to change its name.

HOUSE 358

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in terms and courses of study, further providing for agreements with institutions of higher education; and, in opportunities for educational excellence, further providing for definitions, for responsibilities of school entities and for concurrent enrollment agreements. (Representatives MARSHALL, PICKETT, BERNSTINE and others) – Education, May 5, 2021 1

VOTE

This bill permits charter schools and area career and technical schools to enter into dual enrollment agreements with institutions of higher education.

HOUSE **602** 

930

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, providing for the Career and Technical Education Investment Incentive Program. (Representatives OWLETT, O'NEAL, ECKER and others) - Education, May 5, 2021

VOIE

This bill creates the Career and Technical Education Investment Incentive Program.

### SECOND CONSIDERATION EDUCATION BILLS

HOUSE 1013

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, further providing for Keystone Exams and graduation requirements. (Representatives GLEIM, ECKER, STAATS and others) - Education, May 5, 2021

C VOTE

This bill requires CTE Certifications on High School Student Transcript.

HOUSE 1041

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in pupils and attendance, further providing for home education program. (Representatives TOPPER, R. BROWN, COX and others) - Education, May 5, 2021



This bill requires a school district to permit a home school student to participate in co-curriculum activities and area career and technical education programs.

### SECOND CONSIDERATION FINANCE BILLS

**359** 

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, providing for exemption from taxation. (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) – Finance, May 4, 2021 2

OVER

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

**385** 

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives DUNBAR, ROTHMAN, BROOKS and others) – Finance, May 4, 2021

OVER

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

### SECOND CONSIDERATION FINANCE BILLS

**HOUSE** 952

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in computer data center equipment 1310 incentive program, further providing for definitions and for review of application, providing for applicability and for sales and use tax exemption program; imposing duties on the Department of Revenue; and making editorial changes. (Representatives OBERLANDER, MUSTELLO, KAUFER and others) - Finance, May 3, 2021



This bill provides for Data Center Sales and Use Tax Exemption.

An Act regarding the past, present and future response of this Commonwealth to the COVID-19 pandemic. (Representative 1342 OWLETT) - State Government, May 5, 2021

This bill provides for past, present and future response of this Commonwealth to the COVID-19 pandemic.

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in licensing of drivers, further providing for learners' permits and for examination of applicant for driver's license; in rules of the road in general, further providing for prohibiting text-based communications, providing for prohibiting use of interactive wireless communications devices and imposing penalties; and, in operation of vehicles miscellaneous provisions, further providing for the offense of homicide by vehicle and for the offense of aggravated assault by vehicle. (Representatives R. BROWN, MALAGARI, BOBACK and others) - Transportation, April 5, 2021

**OVER** 

This bill bans the use of handheld cellphones while driving.

An Act designating a bridge, identified as Bridge Key 8391, on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) - Transportation, May 4, 2021

OVER

This bill designates a bridge on that portion of Pennsylvania Route 53 over Laurel Run, also known as Lost Creek, in Dean Township, Cambria County, as the Seaman 2nd Class Louis J. Benzie WWII Memorial Bridge.

HOUSE

**151** 

An Act designating the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway. (Representatives SANCHEZ, BURNS, RYAN and others) - Transportation, May 4, 2021

OVER

This bill designates the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway.

HOUSE **152**

An Act designating a bridge, identified as Bridge Key 43267, on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) - Transportation, May 4, 2021

OVER

This bill designates a bridge on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge.

(Representatives WARNER, SONNEY, **ROTHMAN** others) - Transportation, April 5, 2021 This bill designates a bridge carrying State Route 2027 in North Union Township, Fayette County, as the SSG Willis J. Crayton Memorial Bridge. HOUSE An Act designating a roundabout at Pennsylvania Route 34, 929 OVER Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout. (Representatives STAMBAUGH, BURNS, CONKLIN and others) - Transportation, April 5, 2021 This bill designates a roundabout at Pennsylvania Route 34, Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout. **SENATE** An Act designating a bridge, identified as Bridge Key 8556, 70 OVER carrying SR 1008 (Eckenrode Mill Road) over Chest Creek, located in East Carroll Township, Cambria County, as the Kenneth John Ivory Memorial Bridge. (Senator LANGERHOLC) - Transportation, **April 19, 2021** This bill designates a bridge in Cambria County as the Kenneth John Ivory Memorial Bridge. **SENATE**

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing for contributions to Veterans' Trust Fund. (Senators ROBINSON, MARTIN, BARTOLOTTA and others) - Transportation, April 5, 2021

This bill increases contribution amounts to the Veterans Trust Fund.

### THIRD CONSIDERATION JUDICIARY BILL

An Act amending Titles 18 (Crimes and Offenses), 23 (Domestic Relations) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in minors, further providing for the offense of sexual abuse of children; in child protective services, providing for task force on child pornography; and, in sentencing, further providing for sentencing for offenses involving sexual abuse of children. (Senators BAKER, ARNOLD, VOGEL and others) - Appropriations, March 22, 2021 Fiscal-Note Attached

**OVER** 

This bill amends Titles 18 and Title 42 to provide for enhanced sentencing of defendants convicted of child pornography if the child victim is under 10 years of age or prepubescent and further amends Title 23 to create the Task Force on Child Pornography.
