An Act making appropriations from a restricted revenue account within the General Fund and from Federal augmentation funds to the Pennsylvania Public Utility Commission for the fiscal year July 1, 2021, to June 30, 2022. (Representative SAYLOR) - Appropriations, June 07, 2021 Fiscal-Note Attached

This bill makes appropriations from a restricted revenue account within the General Fund and from Federal augmentation funds to the Pennsylvania Public Utility Commission.

HOUSE 1516 1611

An Act making appropriations from the restricted revenue accounts within the State Gaming Fund and from the restricted revenue accounts within the Fantasy Contest Fund and Video Gaming Fund to the Attorney General, the Department of Revenue, the Pennsylvania State Police and the Pennsylvania Gaming Control Board for the fiscal year beginning July 1, 2021, to June 30, 2022, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2021; and making additional appropriations from the restricted revenue accounts within the State Gaming Fund to the Pennsylvania State Police for the fiscal year July 1, 2020, to June 30, 2021, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2020. (Representative SAYLOR) – Appropriations, June 07, 2021 Fiscal-Note Attached

VOTE



This bill makes appropriations from the the State Gaming Fund to the Attorney General, Department of Revenue, the Pennsylvania State Police and the Pennsylvania Gaming Control Board.

### SECOND CONSIDERATION **EDUCATION BILL**

**HOUSE** 232

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school districts, further providing for how constituted. (Representatives MUSTELLO, STRUZZI, ROWE and others) - Education, May 26, 2021

OVER

This bill amends the Public School Code to permit a school district to change its name.

### SECOND CONSIDERATION **FINANCE BILLS**

HOUSE 359

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, providing for exemption from taxation. (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) - Finance, May 4, 2021

OVER

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

HOUSE 385

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives DUNBAR, ROTHMAN, BROOKS and others) - Finance, May 4, 2021

OVER

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

### **SECOND CONSIDERATION** HEALTH BILLS

**HOUSE** 

An Act providing for the final disposition of fetal remains; and 86 imposing penalties. (Representatives RYAN, HAMM, RAPP and others) - Health, June 7, 2021

VOTE

This bill creates a free-standing act known as the Unborn Child Dignity Act.

**HOUSE** 

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in abortion, further providing 1563 for definitions, for medical consultation and judgment and for reporting. (Representatives KLUNK, RAPP, BERNSTINE and others) - Health, June 7, 2021

This bill amends the Abortion Control Act to prohibit abortion based on a diagnosis of Down Syndrome.

### SECOND CONSIDERATION **HUMAN SERVICES BILLS**

HOUSE 409

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in mental health: departmental 382 known as the rullian Services code, in mediate powers and duties, commissioner of mental health, interstate compact, reciprocal agreements and research foundation, providing for mental health care services clearinghouse; and making an editorial change. (Representatives GALLOWAY, N. NELSON, LEE and others) - Human Services, June 7, 2021

OVER

This bill amends the Human Services Code to provide for an online mental health services clearinghouse.

**SENATE** 108

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, further 73 providing for medical assistance payments for institutional care. (Senators BARTOLOTTA, LAUGHLIN, LANGERHOLC and others) - Human Services, June 7, 2021 1



This bill amends the Human Services Code to provide for additional allocations for eligible Medical Assistance ventilator and tracheostomy patients.

### **SECOND CONSIDERATION JUDICIARY BILLS**

HOUSE

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous 1536 articles, repealing provisions relating to firearms not to be carried without a license, providing for license not required, repealing provisions relating to carrying firearms on public streets or public property in Philadelphia, providing for sportsman's firearm permit, further providing for licenses and repealing provisions relating to proof of license and exception. (Representatives BERNSTINE, MALONEY, GREGORY and others) - Judiciary, June 7, 2021



This bill amends Chapter 61 of Title 18 to provide for "constitutional carry" of a firearm.

**HOUSE** 940

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in cruelty to animals, further providing for police animals. (Representatives RIGBY, E. NELSON, KNOWLES and others) - Judiciary, June 7, 2021



This bill amends Section 5548 of Title 18 to apply it to individuals who recklessly injure or kill a police animal.

### SECOND CONSIDERATION JUDICIARY BILLS

**HOUSE 979** 

An Act amending Titles 18 (Crimes and Offenses) and 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous articles, further providing for limitation on the regulation of firearms and ammunition; and, in preemptions, providing for regulation of firearms and ammunition. (Representatives DOWLING, METCALFE, GREINER and

VOTE



This bill amends Title 18 and Title 53 to provide remedies for the unlawful municipal regulation of firearms and ammunition preempted by state law.

HOUSE 1095

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, further providing for life imprisonment for homicide. (Representatives KAUFFMAN, MILLARD, RYAN and others) – Judiciary, June 7, 2021

VOTE



This bill amends Section 9715 of Title 42 regarding third degree murder of an unborn child to provide for life imprisonment.

### SECOND CONSIDERATION STATE GOVERNMENT BILL

HOUSE 71

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, providing for spending limitations on the Commonwealth. (Representatives WARNER, DAVANZO, DIAMOND and others) - State Government, June 7, 2021

This is a Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, providing for spending limitations on the Commonwealth.

### SECOND CONSIDERATION TRANSPORTATION BILLS

HOUSE 37

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in licensing of drivers, further providing for learners' permits and for examination of applicant for driver's license; in rules of the road in general, further providing for prohibiting text-based communications, providing for prohibiting use of interactive wireless communications devices and imposing penalties;

This bill designates the portion of State Route 2038, also known as Fitzwatertown Road, between Jenkintown Road and North Hills Avenue in Upper Dublin Township, Montgomery County, as the CPL Vincent J. Wargo, Jr., U.S.M.C. Memorial Highway.

HOUSE 152

An Act designating a bridge, identified as Bridge Key 43267, on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) - Transportation, May 4, 2021

OVER

This bill designates a bridge on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge.

**763** 

An Act amending the act of June 1, 1945 (P.L.1242, No.428), known as the State Highway Law, in construction, improvement, maintenance and repair of State highways, providing for native vegetation along highways. (Representatives B. MILLER, SANCHEZ, STAMBAUGH and others) – Transportation, April 19, 2021



This bill designates a bridge carrying State Route 2027 in North Union Township, Fayette County, as the SSG Willis J. Crayton Memorial Bridge.

**HOUSE** 929

An Act designating a roundabout at Pennsylvania Route 34, Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout. (Representatives STAMBAUGH, BURNS, CONKLIN and others) - Transportation, April 2021


OVER

This bill designates a roundabout at Pennsylvania Route 34, Spring Road, Pennsylvania Route 850, Valley Road, and Pisgah State Road in Carroll Township, Perry County, as the Shane E. Troutman Memorial Roundabout.

HOUSE

1091

An Act designating the entire portion of US Route 20 in Pennsylvania, beginning at the Pennsylvania-Ohio State Line and 1125 ending at the Pennsylvania-New York State Line, as the **Pennsylvania Medal of Honor Highway.** (Representatives WENTLING, ROAE, BIZZARRO and others) - Transportation, June 7, 2021



This bill designates the entire portion of US Route 20 in Pennsylvania, beginning at the Pennsylvania-Ohio State Line and ending at the Pennsylvania-New York State Line, as the Pennsylvania Medal of Honor Highway.

**SENATE** 

70

An Act designating a bridge, identified as Bridge Key 8556, carrying SR 1008 (Eckenrode Mill Road) over Chest Creek, located 228 in East Carroll Township, Cambria County, as the Kenneth John Ivory Memorial Bridge. (Senator LANGERHOLC) - Transportation, **April 19, 2021** 

OVER

This bill designates a bridge in Cambria County as the Kenneth John Ivory Memorial Bridge.

### SECOND CONSIDERATION TRANSPORTATION BILLS

**SENATE** 96

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing for contributions to Veterans' Trust Fund. (Senators ROBINSON, MARTIN, BARTOLOTTA and others) - Transportation, April 5, 2021

OVER

This bill increases contribution amounts to the Veterans Trust Fund.

**SENATE 120** 

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in size, weight and load, further providing 91 for conditions of permits and security for damages. (Senator TOMLINSON) - Transportation, April 19, 2021

OVER

This bill establishes requirements for the permitted movement of dozer blades.

This bill amends Titles 18 and Title 42 to provide for enhanced sentencing of defendants convicted of child pornography if the child victim is under 10 years of age or prepubescent and further amends Title 23 to create the Task Force on Child Pornography.
