SECOND CONSIDERATION AGRICULTURE AND RURAL AFFAIRS BILL

HOUSE 2315 2693

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in additional special funds and restricted accounts, further providing for distributions from Pennsylvania Race Horse Development Fund. (Representatives CAUSER, PASHINSKI, MOUL and others) - Agriculture & Rural Affairs, February 09, 2022

C)

This bill extends a sunset date for funding the costs associated with horse racing medication testing.

SECOND CONSIDERATION COMMERCE BILL

HOUSE 424

An Act amending the act of July 9, 1970 (P.L.484, No.164), entitled "An act relating to indemnification agreements between architects, engineers or surveyors and owners, contractors, subcontractors or suppliers," further providing for title of act; and providing for indemnification agreements relative to construction contracts, including agreements for architectural, engineering or land surveying services. (Representatives STEPHENS, DRISCOLL, ZABEL and others) - Rules, December 14, 2021

OVER

This bill amends the act of July 9, 1970 providing for indemnification agreements relative to construction contracts.

SECOND CONSIDERATION EDUCATION BILLS

HOUSE 1254

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in terms and courses of study, providing for in-person instruction or tuition grant program required. (Representatives LEWIS DELROSSO, ROTHMAN, WHITE and others) - Education, December 13, 2021

OVER

This bill amends the Public School Code to require a school district to create a tuition grant program for resident students.

HOUSE 1330 2643

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, providing for supplemental online course initiative; and establishing the Online Course Clearinghouse Restricted Account. (Representatives ORTITAY, HILL-EVANS, GAYDOS and others) - Education, February 7, 2022

OVER

This bill amends the public school code for the establishment of an online clearinghouse of online courses for students enrolled in grades 6 through 12.

SECOND CONSIDERATION ENVIRONMENTAL RESOURCES AND ENERGY BILL

HOUSE 637

An Act authorizing the Department of Environmental Protection to conduct a public comment process on and submit to the General Assembly a measure or action intended to abate, control or limit carbon dioxide emissions by imposing a revenue-generating tax or fee on carbon dioxide emissions. (Representatives STRUZZI, OBERLANDER, SNYDER and others) - Rules, February, 9, 2022

C

This bill authorizes the Department of Environmental Protection to conduct a public comment process on and submit to the General Assembly a measure or action intended to abate, control or limit carbon dioxide emissions by imposing a revenue-generating tax or fee on carbon dioxide emissions.

SECOND CONSIDERATION FINANCE BILLS

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, providing for exemption from taxation. (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) - Finance, January 26, 2022

OVER

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

HOUSE **385**

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives DUNBAR, ROTHMAN, BROOKS and others) – Finance, January 26, 2022 4

OVER

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

HOUSE

1151 1207

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in powers and duties of the Department of Revenue, repealing provisions relating to vehicle and tractor codes. (Representatives O'NEAL, OWLETT, RYAN and others) – Finance, February 8, 2022

OVER

This bill provides for powers and duties of the Department of Revenue, repealing provisions relating to vehicle and tractor codes.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 38

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, organizing the Judiciary into representative districts and further providing for residency requirements. (Representatives DIAMOND, KAUFFMAN, BERNSTINE and others) – Judiciary, January 12, 2022 7

OVER

This bill is a Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, organizing the Judiciary into representative districts and further providing for residency requirements.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE **659**

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous articles, repealing provisions relating to firearms not to be carried without a license, providing for license not required, repealing provisions relating to carrying firearms on public streets or public property in Philadelphia, providing for sportsman's firearm permit, further providing for licenses and repealing provisions relating to proof of license and exception. (Representatives BERNSTINE, MALONEY, GREGORY and others) - Judiciary, November 17,

OVER

This bill amends Chapter 61 of Title 18 to provide for "constitutional carry" of a firearm.

HOUSE 1587

2021

An Act amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in assault, providing for arrests of previously convicted persons possessing firearms in a subsequent offense; and, in sentencing, providing for sentences for previously convicted persons possessing firearms in a subsequent offense. (Representatives A. BROWN, KAUFFMAN, STEPHENS and others) - Rules, February 9, 2022

OVER

14

This bill provides for arrests of previously convicted persons possessing firearms in a subsequent offense.

SECOND CONSIDERATION LIQUOR CONTROL BILL

HOUSE

1828

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for renewal of licenses and temporary provisions for licensees in armed service and for rights of municipalities preserved. (Representatives JONES, MOUL, ZIMMERMAN and others) - Rules, January 25, 2022

OVER

This bill provide for a 75 decibel limit for noise for licensees in Class 2A-8 counties.

SECOND CONSIDERATION PROFESSIONAL LICENSURE BILL

HOUSE 1862

An Act amending the act of December 20, 1985 (P.L.457, No.112), known as the Medical Practice Act of 1985, further 2108 providing for institutional license; and abrogating a related regulation. (Representatives GILLESPIE, JAMES, HILL-EVANS and others) - Professional Licensure, January 26, 2022

OVER

This bill amends the Medical Practice Act to preserve a COVID-19 regulatory waiver that allows physicians with an institutional license in a teaching hospital to serve patients at more than just two facilities in a given health system.

(Representatives CUTLER, RYAN, ROWE and others) - State Government, December 13, 2021

OVER

This bill establishes the Bureau of Election Audits.

HOUSE 1596

A Joint Resolution proposing separate and distinct and integrated amendments to the Constitution of the Commonwealth of Pennsylvania, further providing for qualifications of electors, for method of elections and secrecy in voting and for election and registration laws and providing for election audits and for the election and qualifications of the Secretary of the Commonwealth. (Representatives WHEELAND, STAATS, R. MACKENZIE and others) - State Government, January 4, 2022 10

OVER

This is a Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania providing for qualifications of electors.

An Act designating a bridge, identified as Bridge Key 43267, on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge. (Representatives BURNS, GUENST, KINSEY and others) - Transportation, January 26, 2022

OVER

This bill designates a bridge on that portion of State Route 3041, also known as Dishong Mountain Road, over U.S. Route 22 in Jackson Township, Cambria County, as the Technical Sergeant Mike Capelli Memorial Bridge.

HOUSE 371

An Act designating the portion of Pennsylvania Route 837, also known as Duquesne Boulevard, between Center Street in the City of Duquesne, Allegheny County, and Hoffman Boulevard in West Mifflin Borough, Allegheny County, as the Clifton P. Pitts Memorial Highway. (Representatives A. DAVIS, LEE, PISCIOTTANO and others) - Transportation, January 11, 2022

OVER

This bill designates the portion of Pennsylvania Route 837, also known as Duquesne Boulevard, between Center Street in the City of Duquesne, Allegheny County, and Hoffman Boulevard in West Mifflin Borough, Allegheny County, as the Clifton P. Pitts Memorial Highway.

An Act designating a bridge, identified as Bridge Key 8517, carrying Pennsylvania Route 403 over the Stonycreek River in 1825 Ferndale Borough, Cambria County, as the Private First Class Lee David Meadows Memorial Bridge. (Representatives RIGBY, E. NELSON, SMITH and others) - Transportation, January 12, 2022



Hasay Memorial Highway. (Representatives BOBACK, TOOHIL, HENNESSEY and others) - Transportation, February 9, 2022



This bill designates a portion of U.S. Route 11 to the intersection with Oak Street in Shickshinny Borough, Luzerne County, as the Honorable George C. Hasay Memorial Highway.

HOUSE 2073 2395

An Act designating a bridge, identified as Bridge Key 5786, carrying State Route 3013, known as Dunnings Highway, over South Poplar Run, in Greenfield Township, Blair County, as the Bryan T. "Chipper" Chamberlain Memorial Bridge. (Representatives GREGORY, KINSEY, MILLARD and others) - Transportation, February 9, 2022

OVER

This bill designates a bridge carrying State Route 3013, known as Dunnings Highway, over South Poplar Run, in Greenfield Township, Blair County, as the Bryan T. "Chipper" Chamberlain Memorial Bridge.

HOUSE

2085 2526 An Act amending the act of June 1, 1945 (P.L.1242, No.428), known as the State Highway Law, providing for commemorative designations; and making editorial changes. (Representatives LAWRENCE, BERNSTINE, R. BROWN and others) – Transportation, February 8, 2022

OVER

This bill establishes an application process for the approval of transportation infrastructure commemorative designations.

OVER

This bill amends Title 42 to make sentencing guidelines presumptive for certain offenses involving firearms.

THIRD CONSIDERATION LABOR & INDUSTRY BILL

HOUSE 922

An Act amending the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, in liability and compensation, further providing for compensable injuries, subrogation and proration. (Representatives DAVANZO, DUNBAR, KAUFFMAN and others) - Appropriations, January 4, 2022 Fiscal-Note Attached

OVER

This bill amends the Workers' Compensation Act to provide employers or their insurance the right to treat a third-party settlement related to a workers' compensation claim as a credit for future medical costs.

HOUSE 527

2594

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in public improvements, utilities and services, providing for public notice, public meeting and consent requirements. (Representatives COX, BROOKS, CIRESI and others) – Appropriations, January 24, 2022 Fiscal-Note Attached

OVER

This bill provides for public notice, public meeting and consent requirements.

SENATE

478

An Act amending the act of October 27, 1979 (P.L.241, No.78), entitled "An act authorizing political subdivisions, municipality authorities and transportation authorities to enter into contracts for the purchase of goods and the sale of real and personal property where no bids are received," further providing for title of the act; adding a short title; and providing for contracts for services. (Senators DUSH, HUTCHINSON, J. WARD and others) - Appropriations, February 07, 2022 Fiscal-Note Attached

OVER

This bill amends Act 78 of 1979 to authorize political subdivisions and authorities to enter into contracts for services when two consecutive advertisements fail to induce bids.

SENATE

An Act amending the act of July 10, 1987 (P.L.246, No.47), known as the Municipalities Financial Recovery Act, in municipal financial distress, further providing for designation and for performance of coordinator; and, in receivership in municipalities, further providing for receiver. (Senators HUTCHINSON, J. WARD, DUSH and others) – Appropriations, February 07, 2022 Fiscal-Note Attached

OVER

This bill provides for the responsibilities of coordinators and receivers appointed to assist financially distressed municipalities by requiring compliance with ethics statutes.
