(Representatives FIEDLER, HANBIDGE, HILL-EVANS and others) - **Health, April 25, 2023** **1**

**290** An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in casualty insurance, further providing for coverage for mammographic examinations and diagnostic breast imaging and providing for coverage for BRCA-related genetic counseling and genetic testing. (Senators K. WARD, ROBINSON, PENNYCUICK and others) - **Insurance, April 25, 2023** **1**

*This bill amends the Insurance Company Law to require health insurance coverage of breast cancer genetic counseling and testing without cost-sharing. Also eliminates cost-sharing for breast MRIs for women with increased breast cancer risk factors.*
