An Act providing for reporting requirements for qualifying crypto-asset mining operations and for an impact study; and imposing duties on the Department of Environmental Protection. (Representatives VITALI, WAXMAN, MADDEN and others) - Environmental Resources & Energy, December 12, 2023 1



This bill establishes reporting requirements for certain cryptocurrency mining operations and a two-year moratorium on air permits for behind-the-grid energy generation used for cryptocurrency mining.

403 An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in disposition of abandoned and unclaimed property, further providing for claim for property paid or delivered. (Senators DiSANTO, AUMENT, PHILLIPS-HILL and others) - Finance, December 12, 2023



This bill provides statutory authority for the Treasury Department to establish the Pennsylvania Money Match Program.

An Act providing for access to treatment for sexual assault survivors and for duties of the Department of Health. (Senators 361 VOGEL, STREET, HAYWOOD and others) - Health, December 12,2023 1



This bill requires the Department of Health to publish a list of hospitals that provide SANE services.

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in public safety, providing for miscellaneous provisions. (Senators MASTRIANO, BROOKS, AND BARTOLOTTA) - Health, December 12, 2023 1



This bill requires Fentanyl and Xylazine testing be added to urine drug screens in hospitals.

An Act amending Titles 42 (Judiciary and Judicial Procedure) and 68 (Real and Personal Property) of the Pennsylvania Consolidated Statutes, in personnel of the system, further providing for appointment of personnel and establishing eviction agent advisory boards in cities of the first class and eviction agent education and training programs in cities of the first class; providing for eviction procedure in cities of the first class; making a repeal; and making an editorial change. (Representatives KRAJEWSKI, CEPHAS, KHAN and others) - Housing & Community Development, November 14, 2023

This bill provides common sense eviction reform.

SECOND CONSIDERATION **HUMAN SERVICES BILLS**

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in fraud and abuse control, 852 further providing for definitions, for restrictions on provider charges and payments and for venue and limitations on actions. (Representatives CABELL AND GROVE) - Rules, October 3, 2023

(Representatives PASHINSKI, SANCHEZ, HILL-EVANS and others) - Human Services, **December 10, 2023**

This bill amends Title 67 of the Pennsylvania Consolidated Statutes to establish the Legal Services for Kinship Care Families Grant Program and the Legal Services for Kinship Care Families Grant Program Account.

SENATE An Act amending the act of April 9, 1929 (P.L.177, No.175), 941 known as The Administrative Code of 1929, in powers and duties 1148 of the Department of Drug and Alcohol Programs, further providing for powers and duties and providing for regulatory flexibility during opioid epidemic. (Senators BROOKS, YAW, TARTAGLIONE and others) - Human Services, December 12, 2023

This bill amends the Administrative Code in the powers and duties of the Department of Drug and Alcohol Program to provide for staffing flexibilities during an opioid epidemic.

SECOND CONSIDERATION JUDICIARY BILLS

An Act amending Titles 42 (Judiciary and Judicial Procedure) and 61 (Prisons and Parole) of the Pennsylvania Consolidated 2080 Statutes, in sentencing, repealing provisions relating to transfer of inmates in need of medical treatment; in Pennsylvania Board of Probation and Parole, providing for parole for reasons of age or illness and for medical parole due to public or disaster emergency related to health or contagious disease outbreak; and abrogating regulations. (Representatives KINSEY, BURGOS, CURRY and others) - Judiciary, November 15, 2023 4


This bill amends Title 42 to create a medical parole process to allow incarcerated individuals with serious medical conditions including terminal illness to apply for release.

SECOND CONSIDERATION JUDICIARY BILLS



This bill amends the Landlord Tenant Act to allow victims of domestic violence to change locks or terminate a lease.

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, further providing for endangerment of public safety official. (Representatives ISAACSON AND BELLMON) – Judiciary, December 12, 2023 1

This bill adds federal judicial officers to the endangerment of public official statute.

An Act amending Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, in intestate succession, 2144 further providing for forfeiture; in wills, further providing for modification by circumstances; in slayers, further providing for definition of terms, providing for elder abuser not to acquire property, further providing for descent, distribution, dower, curtesy, and statutory rights as survivor, for legacies, for tenancies by the entirety, for joint tenants, joint owners and joint obligees, for reversions and vested remainders, for interests dependent on survivorship or continuance of life, for contingent remainders and executory or other future interests, for powers of appointment, for proceeds of insurance, for bona fide payment by insurance company or obligor, for bona fide purchasers, for record of conviction as evidence and for preadjudication rule and providing for intent to transfer notwithstanding elder abuse; and making an editorial change. (Representatives HANBIDGE, SCHEMEL, MADDEN and others) - Judiciary, December 12, 2023 1

This bill expands the Slayer Act to include elder abuse.

SECOND CONSIDERATION JUDICIARY BILLS

SENATE An Act amending Titles 18 (Crimes and Offenses) and 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in 1264 human trafficking, further providing for definitions, for the offense of trafficking in individuals and for the offense of patronizing a victim of sexual servitude; in minors, further providing for unlawful contact with minor; and, in domestic and sexual violence victim address confidentiality, further providing for definitions and for persons eligible to apply. (Senators DUSH, COLLETT, PHILLIPS-HILL and others) - Judiciary, December 12, 2023 1

VOTE

This bill treats individuals who patronize a victim of sexual servitude as a trafficker if the victim is under 18 and the individual knew or recklessly disregards that the individual is being subject to sexual servitude and ensures victims of human trafficking have access to service.

SENATE An Act amending Title 74 (Transportation) of the Pennsylvania 140 **Consolidated Statutes, in metropolitan transportation authorities,** 684 providing for special prosecutor for mass transit. (Senators LANGERHOLC, FARRY, VOGEL and others) - Judiciary, December 12, 2023 1

This bill requires the Attorney General appoint a special prosecutor to investigate and prosecute crimes that occur within a public transportation authority (SEPTA).

SENATE An Act amending Title 42 (Judiciary and Judicial Procedure) 361 of the Pennsylvania Consolidated Statutes, in organization and 1203 jurisdiction of courts of common pleas, further providing for courts of common pleas. (Senators J. WARD, COMITTA, CULVER and others) - Judiciary, December 12, 2023

This bill amends Title 42 to add Common Pleas Court judges to several judicial districts.

SENATE An Act amending Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, in incapacitated persons, 843 further providing for petition and hearing and independent evaluation, for determination of incapacity and appointment of guardian and for review hearing. (Senators BAKER, HAYWOOD, KEARNEY and others) - Judiciary, December 12, 2023 1

This bill provides for strengthening Pennsylvania's guardianship laws.

SENATE An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in theft and related offenses, **1266** further providing for the offense of organized retail theft. (Senators ARGALL, STEFANO, BARTOLOTTA and others) - Judiciary, December 12, 2023 1

This bill increases penalties for individuals convicted of organized retail theft and creates the Office of Deputy Attorney General for Organized Retail Crime Theft within the OAG to be staffed by five prosecuting attorneys.

An Act amending the act of July 9, 1987 (P.L.220, No.39), known as the Social Workers, Marriage and Family Therapists and **1838** Professional Counselors Act, further providing for definitions, for license required, for State Board of Social Workers, Marriage and Family Therapists and Professional Counselors, for powers and functions of board, for qualifications for license, for procedures for licensing, for reciprocity and for reinstatement of license; providing for restrictions on use of title "Licensed Associate Marriage and Family Therapist"; and further providing for penalties, for license renewal and records and fees and for unlawful practice. (Representatives CERRATO, HANBIDGE, SCHLOSSBERG and others) - Professional Licensure, December 12, 2023 1

This bill creates an associate license for marriage and family therapists.

HOUSE An Act amending Title 63 (Professions and Occupations (State 1882 Licensed)) of the Pennsylvania Consolidated Statutes, in powers 2363 and duties, further providing for civil penalties. (Representatives BURNS, VENKAT, HADDOCK and others) - Professional Licensure, **December 12, 2023**



This bill provides conveyance of New Freedom Theater.

HOUSE 1538 1782 An Act amending the act of November 22, 1978 (P.L.1166, No.274), referred to as the Pennsylvania Commission on Crime and Delinquency Law, establishing the Public Safety Resident Communications Program. (Representatives SOLOMON, MADDEN, SANCHEZ and others) - State Government, December 12, 2023 1

This bill creates a Public Safety Resident Communications Program with our police.



This bill prohibits state contracts, grants, and tax credits with companies who do business with Russia and Belarus.
